A bill to amend 1954 PA 116, entitled

"Michigan election law,"

by amending sections 252, 254, 267, and 269 (MCL 168.252, 168.254, 168.267, and 168.269), section 254 as amended by 1999 PA 218 and section 269 as amended by 1990 PA 7.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 252. (1) No-A person shall NOT be eliqible to the office
- 2 of county road commissioner who shall not have been UNLESS THE
- 3 PERSON IS a citizen of the United States and a qualified and
- 4 registered elector of the county in which election is sought for at
- 5 least 1 year next preceding BEFORE his OR HER election. , nor shall
- 6 he be a member of the county board of supervisors IN ADDITION, A
- PERSON SHALL NOT BE ELIGIBLE TO THE OFFICE OF COUNTY ROAD
- COMMISSIONER IF HE OR SHE IS A MEMBER OF THE COUNTY BOARD OF
- 9 COMMISSIONERS.

- 1 (2) IN ADDITION TO THE REQUIREMENTS OF SUBSECTION (1), A
- 2 PERSON SEEKING TO REPRESENT A SINGLE-MEMBER DISTRICT IN THE OFFICE

- 5 Sec. 254. (1) Telescept as otherwise provided in this section,

- 10 divided among them. The deposits of all other defeated candidates,

- 12 disqualified, shall be forfeited and the candidates shall be
- 13 notified of the forfeitures. Deposits forfeited under this section
- 14 shall be paid into and credited to the general fund of the county.
- 15 Sec. 267. The office of county road commissioner in any county
- 16 in this state shall become vacant upon the happening of any of the
- 17 following events:
- 18 (A) Death of the incumbent. ; his
- 19 (B) HIS OR HER resignation. ; his
- 20 (C) HIS OR HER removal from office for cause. ; his
- 21 (D) HIS OR HER ceasing to be a resident of the county where
- 22 his OR HER office is located. ; his
- 23 (E) IF REPRESENTING A SINGLE-MEMBER DISTRICT, MOVING HIS OR
- 24 HER RESIDENCE OUTSIDE OF THE SINGLE-MEMBER DISTRICT.
- 25 (F) HIS OR HER conviction of an infamous crime —or an offense
- 26 involving the violation of his OR HER oath of office. ; the
- 27 (G) THE decision of a competent tribunal declaring his OR HER

- 2 (H) HIS OR HER refusal or neglect to take and subscribe to the
- 3 constitutional oath of office and deposit the same in the manner
- 4 and within the time prescribed by law. ; or his
- 5 (I) HIS OR HER refusal or neglect to give bond in the amount
- 6 and manner and within the time prescribed by law.
- 7 Sec. 269. If a vacancy occurs in the office of county road
- 8 commissioner, a qualified person shall be appointed to fill the
- 9 vacancy by the county board of commissioners. IF A VACANCY OCCURS
- 10 IN A SINGLE-MEMBER COUNTY ROAD COMMISSION DISTRICT, A QUALIFIED
- 11 PERSON FROM THAT SINGLE-MEMBER DISTRICT SHALL BE APPOINTED TO FILL
- 12 THE VACANCY BY THE COUNTY BOARD OF COMMISSIONERS. The person so
- 13 appointed shall take the oath of office, give bond in the manner
- 14 required by law, and hold office for the remainder of the unexpired
- 15 term and until a successor is elected and qualified. However, in a
- 16 county in which county road commissioners are elected, if the next
- 17 general November election is to be held more than 182 days after
- 18 the vacancy occurs, and it is not the general November election at
- 19 which a successor in office would be elected if there were no
- 20 vacancy, the person appointed shall hold office only until a
- 21 successor is elected at the next general November election in the
- 22 manner provided by law and qualifies for office. The successor
- 23 shall hold the office for the remainder of the unexpired term.
