SUBSTITUTE FOR HOUSE BILL NO. 4088

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 803e (MCL 257.803e), as amended by 2003 PA 30.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 803e. (1) A person who has been a prisoner of war or a
- 2 person whose spouse has been a prisoner of war may make application
- 3 to the secretary of state for a special registration plate which
- 4 THAT shall be inscribed with special identification numbers
- 5 preceded by the letters "EX-POW" and shall have the words "ex-
- 6 prisoner of war" inscribed beneath the registration number.
- 7 (2) A person who was a member of the armed services during
- 8 World War I may make application to the secretary of state for a
- 9 special registration plate, which THAT shall be inscribed with
- 10 special identification numbers preceded by the letters "WWI" and

- 1 shall have the words "World War I veteran" inscribed beneath the
- 2 registration number.
- 3 (3) A person who was a member of the armed services during
- 4 1941, stationed at a United States military or naval establishment
- 5 at Pearl Harbor in the Hawaiian islands, and who survived the
- 6 attack by Japan on Pearl Harbor on December 7, 1941 may make
- 7 application to the secretary of state for a special registration
- 8 plate, which THAT shall be inscribed with special identification
- 9 numbers and shall have the words "Pearl Harbor survivor" inscribed
- 10 beneath the registration number.
- 11 (4) A person who is a recipient of the purple heart medal may
- 12 make application to the secretary of state for a special
- 13 registration plate which THAT shall be inscribed with special
- 14 identification numbers and shall have the words "combat wounded
- 15 veteran" inscribed beneath the registration number. In addition,
- 16 the special registration plate described under this subsection
- 17 shall be inscribed with a vignette of the official purple heart
- 18 medal.
- 19 (5) Application for a special registration plate shall be on a
- 20 form prescribed by the secretary of state, and shall be accompanied
- 21 by any proof of the applicant having been a prisoner of war, World
- 22 War I veteran, Pearl Harbor survivor, or recipient of the purple
- 23 heart medal that the secretary of state may require. APPLICATION
- 24 FOR A "GOLD STAR FAMILY" SPECIAL REGISTRATION PLATE DESCRIBED IN
- 25 SUBSECTION (9) SHALL BE ON A FORM PRESCRIBED BY THE SECRETARY OF
- 26 STATE AND SHALL BE ACCOMPANIED BY ANY PROOF OF THE APPLICANT HAVING
- 27 BEEN A GOLD STAR FAMILY MEMBER THAT THE SECRETARY OF STATE MAY

- 1 REQUIRE. The application for a special registration plate shall
- 2 also be accompanied with payment of a \$5.00 service fee.
- 3 (6) Upon proper application and payment of the \$5.00 service
- 4 fee, the secretary of state shall issue 1 or more special
- 5 registration plates for each applicant for use on a passenger
- 6 vehicle. A person who is disabled who makes application for a
- 7 special registration plate under this section and who makes payment
- 8 of the \$5.00 service fee shall be issued a tab for persons with
- 9 disabilities as provided in section 803f for his or her special
- 10 registration plate. The secretary of state shall require the same
- 11 proof that the applicant is a disabled person as is required for
- 12 issuance of a permanent windshield placard under section 675. One
- 13 person in any household is entitled to 1 special registration plate
- 14 issued under subsection (1) that is exempt from payment of the tax
- 15 provided in section 801. The person who is issued an additional
- 16 special registration plate under subsection (1) shall be assessed
- 17 the applicable tax provided for in section 801. A person issued 1
- 18 or more special registration plates under subsection (2), (3), ox
- 19 (4), OR (9) shall be assessed the applicable tax provided in
- 20 section 801.
- 21 (7) The use of a special registration plate on a vehicle other
- 22 than the vehicle for which the plate is issued, or by a person who
- 23 does not qualify under this section, is a misdemeanor.
- 24 (8) The special registration plate issued under this section
- 25 expires on the birthday of the vehicle owner in a year in which new
- 26 plates are issued by the secretary of state. Application for
- 27 renewal of the special registration plate shall be accompanied by a

- \$5.00 service fee. The applicant is not required to furnish the 1
- proof provided in subsection (5). 2
- (9) A GOLD STAR FAMILY MEMBER MAY MAKE APPLICATION TO THE 3
- SECRETARY OF STATE FOR A SPECIAL REGISTRATION PLATE THAT SHALL BE
- INSCRIBED WITH SPECIAL IDENTIFICATION NUMBERS PRECEDED BY A GOLD 5
- STAR AND SHALL HAVE THE WORDS "GOLD STAR FAMILY" INSCRIBED BENEATH
- THE REGISTRATION NUMBER. 7
- (10) AS USED IN THIS SECTION, "GOLD STAR FAMILY MEMBER" MEANS 8
- A PERSON WHO HAS HAD AN IMMEDIATE FAMILY MEMBER DIE WHILE SERVING 9
- IN THE UNITED STATES ARMED FORCES OR IN FORCES INCORPORATED AS PART 10
- 11 OF THE UNITED STATES ARMED FORCES IF THE IMMEDIATE FAMILY MEMBER
- 12 MEETS ANY OF THE ELIGIBILITY CRITERIA SPECIFIED IN 10 USC 1126
- (A) (1) TO (3) FOR A GOLD STAR LAPEL BUTTON. 13
