SUBSTITUTE FOR HOUSE BILL NO. 4227

A bill to prohibit certain covenants attaching to nonresidential real property; to prohibit the imposition of certain fees upon transfer of that real property; and to provide for remedies.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. As used in this act:
- 2 (a) "Transfer fee" means a fee or charge payable upon the
- 3 subsequent sale, gift, conveyance, assignment, inheritance, or
- 4 other transfer of an ownership interest in nonresidential real
- 5 property located in this state, or payable for the right to make or
- 6 accept such a transfer, regardless of whether the fee or charge is
- 7 a fixed amount or is determined as a percentage of the value of the

- 1 property, the purchase price, or other consideration given for the
- 2 transfer. Transfer fee does not include any of the following:
- 3 (i) Any consideration payable by the grantee to the grantor for
- 4 the interest in real property being transferred, including any
- 5 subsequent additional consideration for the property payable by the
- 6 grantee based upon any subsequent appreciation, development, or
- 7 sale of the property, provided such additional consideration is
- 8 payable on a 1-time basis only and the obligation to make such
- 9 payment does not bind successors in title to the property. For the
- 10 purposes of this subdivision, an interest in real property may
- 11 include a separate mineral estate and its appurtenant surface
- 12 access rights.
- (ii) Any commission payable to a licensed real estate broker
- 14 for the transfer of real property pursuant to an agreement between
- 15 the broker and the grantor or the grantee, including any subsequent
- 16 additional commission for that transfer payable by the grantor or
- 17 the grantee based upon any subsequent appreciation, development, or
- 18 sale of the property.
- 19 (iii) Any interest, charges, fees, or other amounts payable by a
- 20 borrower to a lender pursuant to a loan secured by a mortgage
- 21 against real property, including, but not limited to, any fee
- 22 payable to the lender for consenting to an assumption of the loan
- 23 or a transfer of the real property subject to the mortgage, any
- 24 fees or charges payable to the lender for estoppel letters or
- 25 certificates, and any shared appreciation interest or profit
- 26 participation or other consideration payable to the lender in
- 27 connection with the loan.

- 1 (iv) Any rent, reimbursement, charge, fee, or other amount
- 2 payable by a lessee to a lessor under a lease, including, but not
- 3 limited to, any fee payable to the lessor for consenting to an
- 4 assignment, subletting, encumbrance, or transfer of the lease.
- 5 (v) Any consideration payable to the holder of an option to
- 6 purchase an interest in real property or the holder of a right of
- 7 first refusal or first offer to purchase an interest in real
- 8 property for waiving, releasing, or not exercising the option or
- 9 right upon the transfer of the property to another person.
- 10 (vi) Any tax, fee, charge, assessment, fine, or other amount
- 11 payable to or imposed by a governmental authority.
- 12 (vii) Any fee, charge, assessment, fine, or other amount
- 13 payable to a homeowners', condominium, cooperative, mobile home, or
- 14 property owners' association pursuant to a declaration or covenant
- 15 or law applicable to such association, including, but not limited
- 16 to, fees or charges payable for estoppel letters or certificates
- 17 issued by the association or its authorized agent.
- 18 (viii) Any fee, charge, assessment, dues, contribution, or other
- 19 amount imposed by a declaration or covenant encumbering a
- 20 community, and payable to a nonprofit or charitable organization
- 21 for the purpose of supporting cultural, educational, charitable,
- 22 recreational, environmental, conservation, or other similar
- 23 activities benefiting the community that is subject to the
- 24 declaration or covenant.
- 25 (ix) Any fee, charge, assessment, dues, contribution, or other
- 26 amount pertaining to the purchase or transfer of a club membership
- 27 relating to real property owned by the member, including, but not

- 1 limited to, any amount determined by reference to the value,
- 2 purchase price, or other consideration given for the transfer of
- 3 the real property.
- 4 (b) "Transfer fee covenant" means a declaration or covenant
- 5 that requires or purports to require the payment of a transfer fee
- 6 to the declarant or other person specified in the declaration or
- 7 covenant or to that person's successors or assigns.
- 8 Sec. 2. A transfer fee covenant that is executed on or after
- 9 the effective date of this section, whether or not recorded, does
- 10 not run with the title to real property and is not binding on or
- 11 enforceable against any subsequent owner, purchaser, or mortgagee
- 12 of any interest in the real property as an equitable servitude or
- 13 otherwise.
- 14 Sec. 3. Any lien purporting to secure the payment of a
- 15 transfer fee under a transfer fee covenant that is executed on or
- 16 after the effective date of this section is void.
- 17 Sec. 4. (1) Any person aggrieved by the imposition of a
- 18 transfer fee, whether the original or subsequent transferee or
- 19 purchaser, may bring an action to clear the title and void the
- 20 transfer fee and for other equitable relief.
- 21 (2) In a successful action brought under subsection (1), the
- 22 court may award actual reasonable attorney fees and other costs of
- 23 bringing the action.
