THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 40103. (1) "Game" means any of the following animals but
- 2 does not include privately owned cervidae species located on a
- 3 registered cervidae livestock facility as that term is defined in
- 4 THAT IS REGISTERED UNDER the privately owned cervidae producers
- 5 marketing act, 2000 PA 190, MCL 287.951 TO 287.969, OR SPORTING
- 6 SWINE LOCATED ON A SPORTING SWINE LIVESTOCK OPERATION THAT IS

- 24 (7) "Protected" or "protected animal" means an animal or kind
- 25 of animal that is designated by the department as an animal that
- 26 shall not be taken.
- 27 (8) "Residence" means a permanent building serving as a

- 1 temporary or permanent home. Residence may include a cottage,
- 2 cabin, or mobile home, but does not include a structure designed
- 3 primarily for taking game, a tree blind, a tent, a recreational or
- 4 other vehicle, or a camper.
- 5 Sec. 41102. (1) The department, in accordance with this part,
- 6 may regulate the taking or killing of all fish, game and fur-
- 7 bearing animals, and game birds protected by the laws of this
- 8 state, and may suspend or abridge the open season provided by law
- 9 for the taking or killing of such fish, animals, or game birds in
- 10 any designated waters or area of this state, if in the opinion of
- 11 the department it is necessary to assist in the increased or better
- 12 protection of the fish, game or fur-bearing animals, or game birds,
- 13 or any particular kinds or species of fish, game or fur-bearing
- 14 animals, or game birds, which may in the opinion of the department
- 15 be threatened from any cause or causes with depletion or
- 16 extermination in the waters or area. The department may promulgate
- 17 rules and orders necessary to implement this part after a thorough
- 18 investigation has been made by the department.
- 19 (2) This section does not apply to privately EITHER OF THE

- 21 (A) PRIVATELY owned cervidae species located on a registered
- 22 cervidae livestock facility or involved in a registered cervidae
- 23 livestock operation REGISTERED under the privately owned cervidae
- 24 producers marketing act, 2000 PA 190, MCL 287.951 TO 287.969.
- 25 (B) SPORTING SWINE LOCATED ON A SPORTING SWINE LIVESTOCK
- 26 OPERATION REGISTERED UNDER THE SPORTING SWINE MARKETING ACT.
- 27 Sec. 41301. (1) As used in this part:

- 1 (a) "Genetically engineered" refers to an organism whose
- 2 genome, chromosomal or extrachromosomal, is modified permanently
- 3 and heritably, using recombinant nucleic acid techniques, or the
- 4 progeny of such an organism.
- 5 (b) "Introduce", with reference to an organism, means to
- 6 knowingly and willfully stock, place, plant, release, or allow the
- 7 release of the organism in this state at any specific location
- 8 where the organism is not already naturalized.
- 9 (c) "Prohibited species", subject to section 41302, means any
- 10 of the following:
- 11 (i) Any of the following prohibited aquatic plant species,
- 12 including a hybrid or genetically engineered variant of the species
- or a fragment, including a seed or other propagule, of the species
- 14 or of a hybrid or genetically engineered variant:
- 15 (A) African oxygen weed (Lagarosiphon major).
- 16 (B) Brazilian elodea (Egeria densa).
- 17 (C) Cylindro (Cylindrospermopsis raciborskii).
- (D) European frogbit (Hydrocharis morsus-ranae).
- 19 (E) Fanwort (Cabomba caroliniana).
- (F) Giant hogweed (Heracleum mantegazzianum).
- 21 (G) Giant salvinia (Salvinia molesta, auriculata, biloba, or
- 22 herzogii).
- 23 (H) Hydrilla (Hydrilla verticillata).
- 24 (I) Japanese knotweed (Fallopia japonica).
- 25 (J) Parrot's feather (Myriophyllum aquaticum).
- 26 (K) Starry stonewort (Nitellopsis obtusa).
- 27 (L) Water chestnut (Trapa natans).

- 6 (iii) The following prohibited crustacean species, including a
- 7 hybrid or genetically engineered variant of the species or an egg
- 8 of the species or of a hybrid or genetically engineered variant:
- 9 rusty crayfish (Orconectes rusticus).
- 10 (iv) Any of the following prohibited fish species, including a
- 11 hybrid or genetically engineered variant of the species or an egg
- 12 of the species or of a hybrid or genetically engineered variant:
- (A) Bighead carp (Hypophthalmichthys nobilis).
- 14 (B) Bitterling (Rhodeus sericeus).
- (C) Black carp (Mylopharyngodon piceus).
- 16 (D) Eurasian ruffe (Gymnocephalus cernuus).
- 17 (E) Grass carp (Ctenopharyngodon idellus).
- 18 (F) Ide (Leuciscus idus).
- 19 (G) Japanese weatherfish (Misgurnus anguillicaudatus).
- 20 (H) Round goby (Neogobius melanostomus).
- 21 (I) Rudd (Scardinius erythrophthalamus).
- 22 (J) Silver carp (Hypophthalmichthys molitrix).
- 23 (K) A fish of the snakehead family (family Channidae).
- 24 (L) Tench (Tinca tinca).
- 25 (M) Tubenose goby (Proterorhinus marmoratus).
- (v) Any of the following prohibited insect species, including
- 27 a hybrid or genetically engineered variant of the species or an egg

- 1 of the species or of a hybrid or genetically engineered variant:
- 2 (A) Asian longhorned beetle (Anoplophora glabripennis).
- 3 (B) Emerald ash borer (Agrilus planipennis).
- 4 (vi) The following prohibited mammal species, including a
- 5 hybrid or genetically engineered variant: nutria
- 6 (A) FERAL SWINE AS DEFINED IN SECTION 3 OF ANIMAL INDUSTRY
- 7 ACT, 1988 PA 466, MCL 287.703.
- 8 (B) NUTRIA (Myocastor coypus).
- 9 (vii) Any of the following prohibited mollusk species,
- 10 including a hybrid or genetically engineered variant of the species
- 11 or an egg of the species or of a hybrid or genetically engineered
- 12 variant:
- (A) Brown garden snail (Helix aspersa).
- 14 (B) Carthusian snail (Monacha cartusiana).
- 15 (C) Giant African snail (Achatina fulica).
- 16 (D) Girdled snail (Hygromia cinctella).
- 17 (E) Heath snail (Xerolenta obvia).
- 18 (F) Wrinkled dune snail (Candidula intersecta).
- 19 (d) "Recombinant nucleic acid techniques" means laboratory
- 20 techniques through which genetic material is isolated and
- 21 manipulated in vitro and then inserted into an organism.
- (e) "Restricted species", subject to section 41302, means any
- 23 of the following:
- 24 (i) Any of the following restricted aquatic plant species,
- 25 including a hybrid or genetically engineered variant of the species
- 26 or a fragment, including a seed or other propagule, of the species
- 27 or of a hybrid or genetically engineered variant:

- 1 (A) Curly leaf pondweed (Potamogeton crispus).
- 2 (B) Eurasian watermilfoil (Myriophyllum spicatum).
- 3 (C) Flowering rush (Butomus umbellatus).
- 4 (D) Phragmites or common reed (Phragmites australis).
- 5 (E) Purple loosestrife (Lythrum salicaria), except that
- 6 cultivars of purple loosestrife developed and recognized to be
- 7 sterile and approved by the director of the department of
- 8 agriculture AND RURAL DEVELOPMENT under section 16a of the insect
- 9 pest and plant disease act, 1931 PA 189, MCL 286.216a, are not a
- 10 restricted species.
- 11 (ii) Any of the following restricted mollusk species, including
- 12 a hybrid or genetically engineered variant of the species or an egg
- 13 of the species or of a hybrid or genetically engineered variant:
- 14 (A) Quagga mussel (Dreissena bugensis).
- 15 (B) Zebra mussel (Dreissena polymorpha).
- 16 (2) For the purposes of this part:
- 17 (a) A person is not considered to possess a live organism
- 18 simply because the organism is present on land or in waters owned
- 19 by that person unless the person has knowingly introduced that live
- 20 organism on that land or in those waters.
- 21 (b) A person is not considered to possess a live organism if
- 22 the organism was obtained from the environment and the person only
- 23 possesses the organism at the specific location at which it was
- 24 obtained from the environment.
- 25 (c) A person is not considered to possess a live organism if
- 26 the possession is for the purpose of promptly destroying the
- 27 organism.

- 1 Sec. 41302. (1) The commission of EXCEPT AS PROVIDED IN
- 2 SUBSECTION (4), THE natural resources COMMISSION may, by order, add
- 3 to or delete from the list of prohibited species or restricted
- 4 species under section 41301 any species other than an insect or
- 5 plant species. Before issuing an order under this subsection, the
- 6 commission of natural resources COMMISSION shall consult with the
- 7 department of agriculture AND RURAL DEVELOPMENT. After the
- 8 consultation, and at least 30 days before the commission of natural
- 9 resources COMMISSION issues the order, the department of natural
- 10 resources shall post a copy of the proposed order on the department
- 11 of natural resources' website and shall submit a copy of the
- 12 proposed order to all of the following:
- 13 (a) The legislature.
- 14 (b) The standing committees of the senate and house of
- 15 representatives with primary responsibility for any of the
- 16 following:
- 17 (i) Agricultural issues.
- 18 (ii) Environmental issues.
- 19 (iii) Natural resources issues.
- 20 (2) The commission of agriculture AND RURAL DEVELOPMENT may,
- 21 by order, add to or delete from the list of prohibited species or
- 22 restricted species under section 41301 any insect or plant species.
- 23 Before issuing an order under this subsection, the commission of
- 24 agriculture AND RURAL DEVELOPMENT shall consult with the department
- 25 of natural resources. After the consultation, and at least 30 days
- 26 before the commission of agriculture AND RURAL DEVELOPMENT issues
- 27 the order, the department of agriculture AND RURAL DEVELOPMENT

- 1 shall post a copy of the proposed order on the department of
- 2 agriculture's AGRICULTURE AND RURAL DEVELOPMENT'S website and shall
- 3 submit a copy of the proposed order to all of the following:

- 15 agriculture AND RURAL DEVELOPMENT, respectively, determines the

- 17 (a) For a prohibited species, all of the following
- 18 requirements are met:
- 19 (i) The organism is not native to this state.
- 20 (ii) The organism is not naturalized in this state or, if
- 21 naturalized, is not widely distributed in this state.
- 22 (iii) One or more of the following apply:
- 23 (A) The organism has the potential to harm human health or to
- 24 severely harm natural, agricultural, or silvicultural resources.
- 25 (B) Effective management or control techniques for the
- 26 organism are not available.
- 27 (b) For a restricted species, all of the following

- 1 requirements are met:
- 2 (i) The organism is not native to this state.
- 3 (ii) The organism is naturalized and widely distributed in this
- 4 state.
- 5 (iii) One or more of the following apply:
- 6 (A) The organism has the potential to harm human health or to
- 7 harm natural, agricultural, or silvicultural resources.
- 8 (B) Effective management or control techniques for the
- 9 organism are available.
- 10 (4) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, THE
- 11 NATURAL RESOURCES COMMISSION SHALL NOT LIST AS A PROHIBITED OR
- 12 RESTRICTED SPECIES SPORTING SWINE REGULATED UNDER THE SPORTING
- 13 SWINE MARKETING ACT. THE DEPARTMENT OF NATURAL RESOURCES SHALL NOT
- 14 ENFORCE ANY ORDER UNDER THIS PART THAT IS INCONSISTENT WITH THIS
- 15 SUBSECTION.
