## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. (1) A cooperative library shall include INCLUDES those 2 areas consisting of 1 of the following:
- 3 (a) Two or more counties with a total population of at least4 100,000.
  - (b) One county plus portions of other counties with a population of at least 100,000.
- 7 (c) One county or portion of the county with a population of 8 at least 400,000.
  - (d) Portions of 2 or more counties with a population of at

- 1 least 350,000.
- 2 (e) Combinations of counties or portions of counties serving a
- 3 population of at least 50,000, if the region served has a
- 4 population of 35 or fewer persons per square mile.
- 5 (2) (f) The area covered by a cooperative library shall
- 6 recognize the geosocioeconomic conditions within that area and
- 7 regions established for governmental purposes throughout the state.
- 8 A local board placed in a cooperative library shall have the option
- 9 to MAY petition the department to be placed in a different
- 10 cooperative library or to join with other local boards to form a
- 11 cooperative library under this act. A local board serving an area
- 12 adjoining more than 1 cooperative library shall have the option to
- 13 MAY determine the cooperative library in which it participates.
- 14 (3) (g) The system board of an existing library system serving
- over 750,000 600,000 population may petition the department for
- 16 designation as a cooperative board, and the department shall
- 17 designate that system board, as already constituted, as the
- 18 cooperative board. If a cooperative board is a county library
- 19 board, the cooperative plan shall provide for expanding the
- 20 cooperative board to represent proportionately the population
- 21 served in any other county or counties within the area of the
- 22 cooperative library. This expanded cooperative board shall have
- 23 authority over those matters affecting the operation of the
- 24 cooperative library except for the property, personnel, and
- 25 governmental relationships of the county whose board was designated
- 26 as the cooperative board, which matters shall continue to be the
- 27 responsibility of that county library board. The department shall

- 1 include in the cooperative library serving over 750,000 600,000
- 2 population the communities presently served by the existing system
- 3 and all other communities not in another cooperative library within
- 4 counties represented by members on the expanded cooperative board
- 5 other than the designated system board members.
