

SENATE SUBSTITUTE FOR
HOUSE BILL NO. 4394

A bill to amend 1936 (Ex Sess) PA 1, entitled
"Michigan employment security act,"
(MCL 421.1 to 421.75) by adding section 27c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC 27C. NOTWITHSTANDING ANY OTHER PROVISION OF THIS ACT, FOR
2 BENEFIT YEARS BEGINNING ON OR AFTER OCTOBER 1, 2000 AND BEFORE
3 JANUARY 1, 2014, IF A BASE PERIOD CONTRIBUTING EMPLOYER NOTIFIES
4 THE AGENCY THAT IT PAID GROSS WAGES TO A CLAIMANT IN A WEEK AT
5 LEAST EQUAL TO THE EMPLOYER'S BENEFIT CHARGE FOR THAT CLAIMANT FOR
6 THE WEEK, THEN THE AGENCY SHALL ISSUE A MONETARY REDETERMINATION
7 NONCHARGING THE ACCOUNT OF THAT EMPLOYER FOR THAT WEEK AND FOR THE
8 REMAINING WEEKS OF THE BENEFIT YEAR FOR BENEFITS PAYABLE TO THAT
9 CLAIMANT THAT WOULD OTHERWISE BE CHARGED TO THE EMPLOYER'S ACCOUNT.

1 FOR BENEFIT YEARS BEGINNING ON OR AFTER JANUARY 1, 2014, BENEFITS
2 PAYABLE TO AN INDIVIDUAL FOR A WEEK AND FOR EACH REMAINING PAYABLE
3 WEEK IN THE BENEFIT YEAR SHALL BE CHARGED TO THE NONCHARGEABLE
4 BENEFITS ACCOUNT IF EITHER OF THE FOLLOWING OCCURS:

5 (A) THE INDIVIDUAL REPORTS GROSS EARNINGS IN THE WEEK WITH A
6 CONTRIBUTING BASE PERIOD EMPLOYER AT LEAST EQUAL TO THE EMPLOYER'S
7 BENEFIT CHARGES FOR THAT INDIVIDUAL FOR THE WEEK.

8 (B) A CONTRIBUTING BASE PERIOD EMPLOYER TIMELY PROTESTS A
9 DETERMINATION CHARGING BENEFITS TO ITS ACCOUNT FOR A WEEK IN WHICH
10 THE EMPLOYER PAID GROSS WAGES TO THE INDIVIDUAL AT LEAST EQUAL TO
11 THE EMPLOYER'S CHARGES FOR BENEFITS PAID TO THAT INDIVIDUAL FOR
12 THAT WEEK.
