

**SUBSTITUTE FOR
HOUSE BILL NO. 5819**

A bill to amend 1982 PA 162, entitled
"Nonprofit corporation act,"
by amending section 1060 (MCL 450.3060), as amended by 2007 PA 87.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1060. (1) The fees a person shall pay to the
2 administrator for the purposes described in this section are as
3 follows:

4 (a) Examining, filing, and copying of articles of a domestic
5 corporation, \$10.00.

6 (b) Examining and filing articles or certificate of
7 incorporation, and other papers connected with the application of a
8 foreign corporation for admission to conduct affairs in this state,
9 \$10.00.

- 1 (c) Examining, filing, and copying an amendment to the
2 articles of a domestic corporation, \$10.00.
- 3 (d) Examining and filing an amendment to the articles of a
4 foreign corporation, \$10.00.
- 5 (e) Examining, filing, and copying a certificate of merger or
6 consolidation under chapter 7, \$50.00.
- 7 (f) Examining and filing a certificate of merger or
8 consolidation of a foreign corporation, under section 1021, \$10.00.
- 9 (g) Examining, filing, and copying a certificate of
10 dissolution, \$10.00.
- 11 (h) Examining and filing an application for withdrawal and
12 issuance of a certificate of withdrawal of a foreign corporation,
13 \$10.00.
- 14 (i) Examining, filing, and copying an application for
15 reservation of corporate name, \$10.00.
- 16 (j) Examining, filing, and copying a certificate of assumed
17 name or certificate of termination of assumed name, \$10.00.
- 18 (k) Examining, filing, and copying a statement of change of
19 registered office or resident agent, \$5.00.
- 20 (l) Examining, filing, and copying restated articles of
21 domestic corporation, \$10.00.
- 22 (m) Examining, filing, and copying a certificate of
23 abandonment, \$10.00.
- 24 (n) Examining, filing, and copying a certificate of
25 correction, \$10.00.
- 26 (o) Examining, filing, and copying a certificate of revocation
27 of dissolution proceedings, \$10.00.

1 (p) Examining, filing, and copying a certificate of renewal of
2 corporate existence, \$10.00.

3 (q) Filing and examination of a special report required by
4 law, \$2.00.

5 (r) Examining and filing a certificate of election, \$10.00.

6 (s) Filing a report required under section 911, \$10.00 if paid
7 before October 1, 2003 or after September 30, ~~2012~~—~~2015~~. After
8 September 30, 2003 and before October 1, ~~2012~~,—~~2015~~, the fee is
9 \$20.00.

10 (2) A corporation shall pay the applicable fee described in
11 this section to the administrator at the time of filing or when the
12 service is rendered by the administrator. The fees described in
13 this section are in addition to any franchise fees prescribed in
14 this act.

15 (3) A person shall pay a minimum charge of \$1.00 for each
16 certificate and 50 cents per folio to the administrator for
17 certifying a part of a file or record pertaining to a corporation
18 if a fee for that service is not described in subsection (1). The
19 administrator may furnish copies of documents, reports, and papers
20 required or permitted by law to be filed with the administrator,
21 and shall charge for those copies the fee established in a schedule
22 of fees adopted by the administrator with the approval of the state
23 administrative board.

24 (4) The administrator shall not refund all or any part of a
25 fee described in this section. The administrator shall deposit all
26 fees received and collected under this section in the state
27 treasury to the credit of the administrator, who may only use the

1 money credited pursuant to legislative appropriation and only in
2 carrying out those duties of the department required by law.

[(5) THE ADMINISTRATOR SHALL WAIVE ANY FEE OTHERWISE REQUIRED
UNDER THIS SECTION IF A MAJORITY OF THE MEMBERS OR DIRECTORS
OF THE CORPORATION RESPONSIBLE FOR PAYING THE FEE ARE, AND THE
CORPORATION PROVIDES PROOF SATISFACTORY TO THE ADMINISTRATOR THAT A
MAJORITY OF THE MEMBERS OR DIRECTORS ARE, HONORABLY DISCHARGED
VETERANS OF THE ARMED FORCES OF THE UNITED STATES.]
