22	GENERAL SECTIONS
23	Sec. 201. In accordance with the provisions of section 30 of
24	article IX of the state constitution of 1963 total state spending

25 from state resources in this appropriation act for the fiscal year

- 8 to 18.1594.

9 DEPARTMENT OF NATURAL RESOURCES

10 Sec. 301. The department of natural resources shall enter into 11 agreements with local units of government for the purpose of 12 administering the grants identified in part 1. Among other 13 provisions, the agreements shall require that grant recipients 14 agree to dedicate to public outdoor recreation uses in perpetuity 15 the land acquired or developed; to replace lands converted or lost 16 to other than public outdoor recreation use; and, for parcels 17 acquired that are over 5 acres in size, to provide the state with a 18 nonparticipating 1/6 minimum royalty interest in any acquired 19 minerals that are retained by the grant recipient. The agreements 20 shall also provide that the full payments of grants can be made 21 only after proof of acquisition, or proof of completion of the 22 development project, is submitted by the grant recipient and all 23 costs are verified by the department of natural resources. This requirement may be waived by the department of natural resources. 24 25 Sec. 302. Any unobligated balance in a Michigan natural 26 resources trust fund appropriation made under part 1 shall not

- 1 revert to the Michigan natural resources trust fund at the close of
- 2 the fiscal year, but shall continue until the purpose for which it
- 3 was appropriated is completed for a period not to exceed 3 fiscal
- 4 years. The unexpended balance of any Michigan natural resources
- 5 trust fund appropriation made in part 1 remaining after the purpose
- 6 for which it was appropriated is completed shall revert to the
- 7 Michigan natural resources trust fund and be made available for
- 8 appropriation.
