(NPLEX) ADMINISTERED BY THE NATIONAL ASSOCIATION OF DRUG DIVERSION
INVESTIGATORS (NADDI). << A RETAILER SHALL NOT BE REQUIRED TO PAY A FEE
FOR USING THE NPLEX SYSTEM.
