## **SENATE BILL No. 396**

May 24, 2011, Introduced by Senators RICHARDVILLE and NOFS and referred to the Committee on Education.

A bill to amend 1857 PA 72, entitled

"An act amendatory to the several acts in relation to the Wesleyan Seminary at Albion, and the Albion Female Collegiate Institute," by amending section 2 (MCL 390.702) and by adding sections 1a, 7, 7a, 7b, and 7c; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1A. AS USED IN THIS ACT:
  - (A) "BOARD OF TRUSTEES" MEANS THE BOARD OF TRUSTEES OF ALBION COLLEGE CREATED IN SECTION 1.
    - (B) "COLLEGE" MEANS ALBION COLLEGE, CREATED IN SECTION 1.
    - (C) "NONTRUSTEE VOLUNTEER" MEANS AN INDIVIDUAL, OTHER THAN A VOLUNTEER TRUSTEE, PERFORMING SERVICES FOR THE COLLEGE WHO DOES NOT RECEIVE COMPENSATION OR ANY OTHER TYPE OF CONSIDERATION FOR THE SERVICES OTHER THAN REIMBURSEMENT FOR EXPENSES ACTUALLY INCURRED.
      - (D) "TRUSTEE" MEANS A MEMBER OF THE BOARD OF TRUSTEES.

- 1 (E) "VOLUNTEER TRUSTEE" MEANS A TRUSTEE WHO DOES NOT RECEIVE
- 2 ANYTHING OF MORE THAN NOMINAL VALUE FROM THE COLLEGE FOR SERVING AS
- 3 A TRUSTEE OTHER THAN REASONABLE PER DIEM COMPENSATION AND

- 21 alternation, the West Michigan Annual Conference to designate the
- 22 first trustee.
- 23 (B) NOT MORE THAN 6 TRUSTEES, THE NUMBER TO BE DETERMINED BY
- 24 THE BOARD OF TRUSTEES, APPOINTED BY THE UNITED METHODIST CHURCH.
- 25 (C) NOT MORE THAN 2 TRUSTEES WHO ARE RECENT GRADUATES OF THE
- 26 COLLEGE, THE NUMBER TO BE DETERMINED BY THE BOARD OF TRUSTEES,
- 27 APPOINTED BY THE PRESIDENT OF THE COLLEGE. TRUSTEES APPOINTED UNDER

- 1 THIS SUBDIVISION SHALL SERVE STAGGERED 2-YEAR TERMS.
- 2 (D) (h) Six NOT MORE THAN 6 trustees, designated THE NUMBER TO

- 4 college alumni association.
- 5 (E) (i) Twenty NOT MORE THAN 20 trustees, designated THE

- 16 TRUSTEE APPOINTED UNDER SUBSECTION (1) (C) IS 2 YEARS, EXCEPT THAT
- 17 THE BOARD OF TRUSTEES MAY APPOINT AN INDIVIDUAL FOR A 1-YEAR TERM
- 18 SO THAT THE TERMS OF OFFICE OF BOARD MEMBERS APPOINTED UNDER
- 19 SUBSECTION (1) (C) ARE STAGGERED.
- 20 (3) THE BOARD OF TRUSTEES MAY PROVIDE IN BYLAWS ADOPTED UNDER
- 21 SECTION 3 A LIMITATION ON THE NUMBER OF CONSECUTIVE TERMS AN
- 22 INDIVIDUAL MAY SERVE AS A TRUSTEE.
- 23 (4) A TRUSTEE APPOINTED UNDER SUBSECTION (1)(B), (C), (D), OR

- 1 FOR MONETARY DAMAGES FOR A BREACH OF THE TRUSTEE'S OR OFFICER'S
- 2 FIDUCIARY DUTY. THIS PROVISION DOES NOT ELIMINATE OR LIMIT THE
- 3 LIABILITY OF A TRUSTEE OR OFFICER FOR ANY OF THE FOLLOWING:
- 4 (A) A BREACH OF THE TRUSTEE'S OR OFFICER'S DUTY OF LOYALTY TO

- 12 (E) AN ACT OR OMISSION OCCURRING BEFORE THE EFFECTIVE DATE OF
- 13 THIS AMENDMENT.
- 14 (F) AN ACT OR OMISSION THAT IS GROSSLY NEGLIGENT.
- 15 SEC. 7A. DURING THE TIME THAT THE COLLEGE IS TAX EXEMPT UNDER
- 16 SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, 26 USC 501, THE
- 17 COLLEGE ASSUMES ALL LIABILITY TO ANY PERSON OTHER THAN THE COLLEGE
- 18 FOR ALL ACTS OR OMISSIONS OF A VOLUNTEER TRUSTEE INCURRED IN THE
- 19 GOOD FAITH PERFORMANCE OF THE VOLUNTEER TRUSTEE'S DUTIES.
- 20 SEC. 7B. THE COLLEGE ASSUMES THE LIABILITY FOR ALL ACTS OR
- 21 OMISSIONS OF A PERSON WHO IS A VOLUNTEER TRUSTEE OR NONTRUSTEE
- 22 VOLUNTEER OCCURRING ON OR AFTER THE EFFECTIVE DATE OF THE
- 23 AMENDATORY ACT THAT ADDED THIS SECTION IF ALL OF THE FOLLOWING ARE
- 24 MET:
- 25 (A) THE PERSON WAS ACTING OR REASONABLY BELIEVED HE OR SHE WAS
- 26 ACTING WITHIN THE SCOPE OF HIS OR HER AUTHORITY.
- 27 (B) THE VOLUNTEER WAS ACTING IN GOOD FAITH.

- 1 (C) THE VOLUNTEER'S CONDUCT DID NOT AMOUNT TO GROSS NEGLIGENCE
- 2 OR WILLFUL AND WANTON MISCONDUCT.
- 3 (D) THE VOLUNTEER'S CONDUCT WAS NOT AN INTENTIONAL TORT.
- 4 (E) THE VOLUNTEER'S CONDUCT WAS NOT A TORT ARISING OUT OF THE
- 5 OWNERSHIP, MAINTENANCE, OR USE OF A MOTOR VEHICLE FOR WHICH TORT
- 6 LIABILITY MAY BE IMPOSED UNDER SECTION 3135 OF THE INSURANCE CODE
- 7 OF 1956, 1956 PA 218, MCL 500.3135.
- 8 SEC. 7C. A CLAIM FOR MONETARY DAMAGES FOR AN ACT OR OMISSION
- 9 OF A VOLUNTEER TRUSTEE OR A NONTRUSTEE VOLUNTEER SHALL NOT BE
- 10 BROUGHT OR MAINTAINED AGAINST THAT VOLUNTEER TRUSTEE OR NONTRUSTEE
- 11 VOLUNTEER. THE CLAIM SHALL BE BROUGHT AND MAINTAINED AGAINST THE
- 12 COLLEGE.
- 13 Enacting section 1. Sections 4 and 8 of 1857 PA 72, MCL
- 14 390.704 and 390.708, are repealed.
