SUBSTITUTE FOR SENATE BILL NO. 178

A bill to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 2012; to provide for the expenditures of those appropriations; to provide anticipated appropriations for the fiscal year ending September 30, 2013; and to prescribe the powers and duties of certain state departments, institutions, agencies, employees, and officers.

22 GENERAL SECTIONS

Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state resources under this act for fiscal year 2011-2012 is \$1,263,952,000.00 and

- 1 state spending from state resources to be paid to local units of
- 2 government for fiscal year 2011-2012 is \$0.
- 3 Sec. 202. The appropriations authorized under this act are
- 4 subject to the management and budget act, 1984 PA 431, MCL 18.1101
- **5** to 18.1594.
- 6 Sec. 203. As used in this act, "research university" means a
- 7 public university classified as a "research university (high or
- 8 very high research activity) " under the classification of
- 9 institutions of higher education conducted by the Carnegie
- 10 foundation.
- 11 Sec. 208. Unless otherwise specified, public universities
- 12 receiving appropriations in part 1 shall use the Internet to
- 13 fulfill the reporting requirements of this act. This requirement
- 14 may include transmission of reports via electronic mail to the
- 15 recipients identified for each reporting requirement, or it may
- 16 include placement of reports on an Internet or Intranet site.
- 17 Sec. 209. Funds appropriated in part 1 shall not be used for
- 18 the purchase of foreign goods or services, or both, if
- 19 competitively priced and of comparable quality American goods and
- 20 services, or both, are available. Preference shall be given to
- 21 goods or services, or both, manufactured or provided by Michigan
- 22 businesses if they are competitively priced and of comparable
- 23 value. In addition, preference shall be given to goods or services,
- 24 or both, that are manufactured or provided by Michigan businesses
- 25 owned and operated by veterans if they are competitively priced and
- 26 of comparable quality.
- 27 Sec. 210. It is the intent of the legislature that the funds

- 2 shall not be used to enter into a lease or to purchase a vehicle
- 3 assembled or manufactured outside of the United States, and that
- 4 preference be given to vehicles assembled or manufactured in
- 5 Michigan.
- 6 Sec. 211. The principal executive officer of each public
- 7 university receiving appropriations in part 1 shall take all
- 8 reasonable steps to ensure that businesses in deprived and
- 9 depressed communities compete for and perform contracts to provide
- 10 services, supplies, or both. Each principal executive officer shall
- 11 strongly encourage firms with which the university contracts to
- 12 subcontract with businesses in depressed and deprived communities
- 13 for services, supplies, or both.
- 14 Sec. 212. (1) The funds appropriated in part 1 to public
- 15 universities shall be paid out of the state treasury and
- 16 distributed by the state treasurer to the respective institutions
- 17 in 11 equal monthly installments on the sixteenth of each month, or
- 18 the next succeeding business day, beginning with October 16, 2011.
- 19 Except for Wayne State University, each institution shall accrue
- 20 its July and August 2012 payments to its institutional fiscal year
- 21 ending June 30, 2012.
- 22 (2) All public universities shall submit higher education
- 23 institutional data inventory (HEIDI) data and associated financial
- 24 and program information requested by and in a manner prescribed by
- 25 the state budget director. For public universities with fiscal
- years ending June 30, 2011, these data shall be submitted to the
- 27 state budget director by October 15, 2011. Public universities with

- 1 a fiscal year ending September 30, 2011 shall submit preliminary
- 2 HEIDI data by November 15, 2011 and final data by December 15,
- 3 2011. If a public university fails to submit HEIDI data and
- 4 associated financial aid program information in accordance with
- 5 this reporting schedule, the state treasurer shall withhold the
- 6 monthly installments under subsection (1) to the public university
- 7 until those data are submitted.
- 8 Sec. 213. Funds received by the state from the federal
- 9 government or private sources for the use of a college or
- 10 university are appropriated for the purposes for which they are
- 11 provided. The acceptance and use of federal or private funds do not
- 12 place an obligation upon the legislature to continue the purposes
- 13 for which the funds are made available.
- 14 Sec. 215. A public university that receives funds under this
- 15 act shall furnish all program and financial information that is
- 16 required by and in a manner prescribed by the state budget director
- 17 or the house or senate appropriations committee.
- 18 Sec. 216. A public university receiving funds in part 1 shall
- 19 cooperate with all measures taken by the state to establish a
- 20 statewide P-20 education longitudinal data system to comply with
- 21 the state fiscal stabilization fund provisions of the American
- 22 recovery and reinvestment act of 2009, Public Law 111-5.
- 23 Sec. 218. In an effort to better improve transparency and to
- 24 further identify effective educational practices, it is the intent
- 25 of the legislature that a public university receiving an
- 26 appropriation in part 1 shall develop, post, and maintain a user-
- 27 friendly and publicly accessible Internet site, with all

- 1 expenditures made by the university within a fiscal year. The
- 2 posting must include the purpose for which the expenditure is made.
- 3 A public university shall not provide financial information on its
- 4 website under this section if doing so would violate a federal or
- 5 state law, rule, regulation, or guideline that establishes privacy
- 6 or security standards applicable to that section.

GRANTS AND FINANCIAL AID

- 8 Sec. 301. (1) Payments of the amounts included in part 1 for
- 9 the state competitive scholarship program shall be distributed
- 10 pursuant to 1964 PA 208, MCL 390.971 to 390.981.
- 11 (2) Pursuant to section 6 of 1964 PA 208, MCL 390.976, the
- 12 department of treasury shall determine an actual maximum state
- 13 competitive scholarship award per student, which shall be no less
- 14 than \$1,300.00, that ensures that the aggregate payments for the
- 15 state competitive scholarship program do not exceed the
- 16 appropriation contained in part 1 for the state competitive
- 17 scholarship program. If the department determines that insufficient
- 18 funds are available to establish a maximum award amount equal to at
- 19 least \$1,300.00, the department shall immediately report to the
- 20 house and senate appropriations subcommittees on higher education,
- 21 the house and senate fiscal agencies, and the state budget director
- 22 regarding the estimated amount of additional funds necessary to
- establish a \$1,300.00 maximum award amount.
- 24 (3) The department of treasury shall implement a proportional
- 25 competitive scholarship maximum award level for recipients enrolled
- 26 less than full-time in a given semester or term.

- 1 (4) If a student who receives an award under this section has
- 2 his or her tuition and fees paid under the Michigan educational
- 3 trust program, pursuant to the Michigan education trust act, 1986
- 4 PA 316, MCL 390.1421 to 390.1442, and still has financial need, the
- 5 funds awarded under this section may be used for educational
- 6 expenses other than tuition and fees.
- 7 (5) If the department of treasury increases the maximum award
- 8 per eligible student from that provided in the previous fiscal
- 9 year, it shall not have the effect of reducing the number of
- 10 eliqible students receiving awards in relation to the total number
- 11 of eligible applicants. Any increase in the maximum grant shall be
- 12 proportional for all eligible students receiving awards.
- 13 (6) Veterans administration benefits shall not be considered
- 14 in determining eligibility for the award of scholarships under 1964
- 15 PA 208, MCL 390.971 to 390.981.
- 16 Sec. 302. (1) The amounts appropriated in part 1 for the state
- 17 tuition grant program shall be distributed pursuant to 1966 PA 313,
- **18** MCL 390.991 to 390.997a.
- 19 (2) Tuition grant awards shall be made to all eligible
- 20 Michigan residents enrolled in undergraduate degree programs who
- 21 apply before July 1, 2011 and who are qualified.
- 22 (3) Pursuant to section 5 of 1966 PA 313, MCL 390.995, and
- 23 subject to subsection (7), the department of treasury shall
- 24 determine an actual maximum tuition grant award per student, which
- 25 shall be no less than \$2,100.00, that ensures that the aggregate
- 26 payments for the tuition grant program do not exceed the
- 27 appropriation contained in part 1 for the state tuition grant

- 1 program. If the department determines that insufficient funds are
- 2 available to establish a maximum award amount equal to at least
- 3 \$2,100.00, the department shall immediately report to the house and
- 4 senate appropriations subcommittees on higher education, the house
- 5 and senate fiscal agencies, and the state budget director regarding
- 6 the estimated amount of additional funds necessary to establish a
- 7 \$2,100.00 maximum award amount. By December 15, 2011, and again by
- 8 February 1, 2012, the department shall analyze the status of award
- 9 commitments, shall make any necessary adjustments, and shall
- 10 confirm that those award commitments will not exceed the
- 11 appropriation contained in part 1 for the tuition grant program.
- 12 The determination and actions shall be reported to the state budget
- 13 director and the house and senate fiscal agencies no later than
- 14 February 15, 2012. If award adjustments are necessary, the students
- 15 shall be notified of the adjustment by the third Monday in
- 16 February.
- 17 (4) Any unexpended and unencumbered funds remaining on
- 18 September 30, 2012 from the amounts appropriated in part 1 for the
- 19 tuition grant program shall not lapse on September 30, 2012, but
- 20 shall continue to be available for expenditure for tuition grants
- 21 provided in the 2012-2013 fiscal year under a work project account.
- 22 The use of these unexpended fiscal year 2011-2012 funds shall
- 23 terminate at the end of the 2012-2013 fiscal year.
- 24 (5) The department of treasury shall continue a proportional
- 25 tuition grant maximum award level for recipients enrolled less than
- 26 full-time in a given semester or term.
- 27 (6) If the department of treasury increases the maximum award

- 1 per eligible student from that provided in the previous fiscal
- 2 year, it shall not have the effect of reducing the number of
- 3 eligible students receiving awards in relation to the total number
- 4 of eligible applicants. Any increase in the maximum grant shall be
- 5 proportional for all eligible students receiving awards for fiscal
- 6 year 2011-2012.
- 7 (7) The department of treasury shall not award more than
- 8 \$3,000,000.00 in tuition grants to eligible students enrolled in
- 9 the same independent nonprofit college or university in this state.
- 10 Any decrease in the maximum grant shall be proportional for all
- 11 eligible students enrolled in that college or university, as
- 12 determined by the department.
- Sec. 307. The auditor general may audit selected enrollments,
- 14 degrees, and awards at selected independent colleges and
- 15 universities receiving awards administered by the department of
- 16 treasury. The audits shall be based upon definitions and
- 17 requirements established by the department of treasury, the state
- 18 budget director, and the senate and house fiscal agencies. The
- 19 auditor general shall accept the Free Application for Federal
- 20 Student Aid (FAFSA) form as the standard of residency
- 21 documentation. The auditor general shall submit a report of
- 22 findings to the senate and house appropriations committees and
- 23 state budget director by May 1, 2012.
- 24 Sec. 308. The sums appropriated in part 1 for the student
- 25 financial aid programs shall be paid out of the state treasury and
- 26 shall be distributed to the respective institutions under a
- 27 quarterly payment system as follows:

- 1 (a) For the state competitive scholarship, tuition incentive,
- 2 and tuition grant programs, 40% shall be paid at the beginning of
- 3 the state's first fiscal quarter, 40% at the beginning of the
- 4 state's second fiscal quarter, 10% at the beginning of the state's
- 5 third fiscal quarter, and 10% at the beginning of the state's
- 6 fourth fiscal quarter.
- 7 (b) For the Robert C. Byrd honors scholarship program, 50%
- 8 shall be paid at the beginning of the state's first fiscal quarter
- 9 and 50% at the beginning of the state's second fiscal quarter.
- 10 Sec. 309. The department of treasury shall determine the needs
- 11 analysis criteria for students to qualify for the state competitive
- 12 scholarship program and tuition grant program. To be consistent
- 13 with federal requirements, student wages may be taken into
- 14 consideration when determining the amount of the award.
- 15 Sec. 310. (1) The funds appropriated in part 1 for the tuition
- 16 incentive program shall be distributed as provided in this section
- 17 and pursuant to the administrative procedures for the tuition
- 18 incentive program of the department of treasury.
- 19 (2) As used in this section:
- 20 (a) "Phase I" means the first part of the tuition incentive
- 21 assistance program defined as the academic period of 80 semester or
- 22 120 term credits, or less, leading to an associate degree or
- 23 certificate.
- 24 (b) "Phase II" means the second part of the tuition incentive
- 25 assistance program which provides assistance in the third and
- 26 fourth year of 4-year degree programs.
- (c) "Department" means the department of treasury.

- 1 (3) A person shall meet the following basic criteria and
- 2 financial thresholds to be eligible for tuition incentive benefits:
- 3 (a) To be eligible for phase I, a person shall meet all of the
- 4 following criteria:
- 5 (i) Apply for certification to the department before graduating
- 6 from high school or completing the general education development
- 7 (GED) certificate.
- 8 (ii) Be less than 20 years of age at the time of high school
- 9 graduation or GED completion.
- 10 (iii) Be a United States citizen and a resident of Michigan
- 11 according to institutional criteria.
- 12 (iv) Be at least a half-time student, earning less than 80
- 13 semester or 120 term credits at a participating educational
- 14 institution within 4 years of high school graduation or GED
- 15 certificate completion.
- 16 (v) Request information on filing a FAFSA.
- 17 (b) To be eligible for phase II, a person shall meet either of
- 18 the following criteria in addition to the criteria in subdivision
- **19** (a):
- 20 (i) Complete at least 56 transferable semester or 84
- 21 transferable term credits.
- 22 (ii) Obtain an associate degree or certificate at a
- 23 participating institution.
- (c) To be eligible for phase I or phase II, a person must not
- 25 be incarcerated and must be financially eligible as determined by
- 26 the department. A person is financially eligible for the tuition
- 27 incentive program if that person was Medicaid eligible for 24

- 1 months within the 36 months before application. Certification of
- 2 eligibility may begin in the sixth grade.
- **3** (4) For phase I, the department shall provide payment on
- 4 behalf of a person eligible under subsection (3). The department
- 5 shall reject billings that are excessive or outside the guidelines
- 6 for the type of educational institution.
- 7 (5) For phase I, all of the following apply:
- 8 (a) Payments for associate degree or certificate programs
- 9 shall not be made for more than 80 semester or 120 term credits for
- 10 any individual student at any participating institution.
- 11 (b) For persons enrolled at a Michigan community college, the
- 12 department shall pay the current in-district tuition and mandatory
- 13 fees. For persons residing in an area that is not included in any
- 14 community college district, the out-of-district tuition rate may be
- 15 authorized.
- 16 (c) For persons enrolled at a Michigan public university, the
- 17 department shall pay lower division resident tuition and mandatory
- 18 fees for the current year.
- 19 (d) For persons enrolled at a Michigan independent, nonprofit
- 20 degree-granting college or university, or a Michigan federal
- 21 tribally controlled community college, or Focus: HOPE, the
- 22 department shall pay mandatory fees for the current year and a per-
- 23 credit payment that does not exceed the average community college
- 24 in-district per-credit tuition rate as reported on August 1, for
- 25 the immediately preceding academic year.
- 26 (6) A person participating in phase II may be eligible for
- 27 additional funds not to exceed \$500.00 per semester or \$400.00 per

1 term up to a maximum of \$2,000.00 subject to the following

- 2 conditions:
- 3 (a) Credits are earned in a 4-year program at a Michigan

- 4 degree-granting 4-year college or university.
- 5 (b) The tuition reimbursement is for coursework completed
- 6 within 30 months of completion of the phase I requirements.
- 7 (7) The department shall work closely with participating
- 8 institutions to develop an application and eligibility
- 9 determination process that will provide the highest level of
- 10 participation and ensure that all requirements of the program are
- **11** met.
- 12 (8) Applications for the tuition incentive program may be
- 13 approved at any time after the student begins the sixth grade. If a
- 14 determination of financial eligibility is made, that determination
- 15 is valid as long as the student meets all other program
- 16 requirements and conditions.
- 17 (9) Each institution shall ensure that all known available
- 18 restricted grants for tuition and fees are used prior to billing
- 19 the tuition incentive program for any portion of a student's
- 20 tuition and fees.
- 21 (10) The department shall ensure that the tuition incentive
- 22 program is well publicized and that eligible Medicaid clients are
- 23 provided information on the program. The department shall provide
- 24 the necessary funding and staff to fully operate the program.
- 25 Sec. 311. To enable the legislature and the state budget
- 26 director to evaluate the appropriation needs of higher education,
- 27 each independent college and university shall make available to the

- 1 legislature or state budget director, upon request, data regarding
- 2 grants for the preceding, current, and ensuing fiscal years.
- 3 Sec. 315. By February 15 of each year, the department of
- 4 treasury shall submit a report to the state budget director, the
- 5 house and senate appropriations subcommittees on higher education,
- 6 and the house and senate fiscal agencies for the preceding fiscal
- 7 year on all student financial aid programs for which funds are
- 8 appropriated in part 1. For each student financial aid program, the
- 9 report shall include, but is not limited to, the total number of
- 10 awards paid in the preceding fiscal year, the total dollar amount
- 11 of those awards, and the number of students receiving awards and
- 12 the total amount of those awards at each eligible postsecondary
- 13 institution. To the extent information is available, the report
- 14 shall also include information on the average exam performance,
- 15 household income, and other demographic characteristics of students
- 16 receiving awards under each program and historical information on
- 17 the number of awards and total award amounts for each program.

18 UNIVERSITY OPERATIONS

- 19 Sec. 402. The University of Michigan biological station at
- 20 Douglas Lake in Cheboygan County is regarded as a unique resource
- 21 and is designated as a special research reserve. It is the intent
- 22 of the legislature to protect and preserve the unique long-term
- 23 research value and capabilities of the biological station area and
- 24 Douglas Lake. The legislature further intends that no state
- 25 programs or policies be developed that would have a deleterious
- 26 impact on the research value of Douglas Lake.

- 1 Sec. 426. (1) It is the intent of the legislature that each
- 2 public university shall develop policies for minimizing the cost of

- 3 textbooks and course materials used at the university while
- 4 maintaining quality of education and academic freedom. These
- 5 policies should require all of the following:
- 6 (a) That faculty members submit lists of required textbooks
- 7 and course materials for university review.
- 8 (b) That faculty members consider the least costly practices
- 9 in assigning textbooks and course materials, such as adopting the
- 10 least expensive edition of a textbook available when educational
- 11 content is comparable to a more costly edition.
- 12 (c) That the university review any potential financial
- 13 conflict of interest that may occur if a faculty member requires
- 14 the purchase of any textbooks or course materials he or she has
- 15 written.
- 16 (2) By February 1, 2012, each public university shall submit a
- 17 report to the house and senate appropriations subcommittees on
- 18 higher education and the house and senate fiscal agencies on the
- 19 policies developed pursuant to this section.
- Sec. 433. (1) Included in the appropriation in part 1 for
- 21 agricultural experiment and cooperative extension activities is
- \$5,628,100.00 for project GREEEN. Project GREEEN is intended to
- 23 address critical regulatory, food safety, economic, and
- 24 environmental problems faced by this state's plant-based
- 25 agriculture, forestry, and processing industries. "GREEEN" is an
- 26 acronym for generating research and extension to meet environmental
- 27 and economic needs.

- 1 (2) The department of agriculture and rural development and
- 2 Michigan State University, in consultation with agricultural
- 3 commodity groups and other interested parties, shall develop
- 4 project GREEEN and its program priorities.
- 5 (3) By September 30, 2012, Michigan State University shall
- 6 submit a report to the house and senate appropriations
- 7 subcommittees on agriculture and on higher education, the house and
- 8 senate standing committees on agriculture, the house and senate
- 9 fiscal agencies, and the state budget director for the preceding
- 10 school fiscal year regarding expenditures and programmatic outcomes
- 11 of the agricultural experiment station and cooperative extension
- 12 service. The report shall include, but is not limited to:
- 13 (a) Total funds expended by the agricultural experiment
- 14 station and cooperative extension service identified by state,
- 15 local, private, federal, and university fund sources.
- 16 (b) The dollar amount of each project GREEEN project and a
- 17 review of each project's performance and accomplishments.
- 18 (c) The dollar amount of each bioeconomy research and
- 19 development project and a review of each project's performance and
- 20 accomplishments.
- 21 (d) The dollar amount and description of all other individual
- 22 programs and services provided by the agricultural experiment
- 23 station and cooperative extension service and a review of each
- 24 project's performance and accomplishments.
- 25 (e) The number of businesses created or that had increased
- 26 employment and the number of patents generated as a result of work
- 27 conducted by the agricultural experiment station and cooperative

- 1 extension service.
- 2 Sec. 433a. (1) Annually, in partnership with stakeholders of
- 3 the agricultural experiment station and cooperative extension
- 4 service, Michigan State University shall develop a set of research
- 5 and extension priorities. As a part of this effort, Michigan State
- 6 University and the department of agriculture and rural development,
- 7 in partnership with the agriculture industry, shall convene a
- 8 summit to set priorities for research and extension regarding
- 9 production agriculture.
- 10 (2) Not later than September 30, 2012, Michigan State
- 11 University shall submit a report to the house and senate
- 12 appropriations subcommittees on agriculture and on higher
- 13 education, the house and senate standing committees on agriculture,
- 14 the house and senate fiscal agencies, and the state budget director
- 15 for the preceding school fiscal year detailing, but not limited to:
- 16 (a) Total funds expended by the agricultural experiment
- 17 station and by the cooperative extension service identified by
- 18 state, local, private, federal, and university fund sources.
- 19 (b) A review of major programs within both the agricultural
- 20 experiment station and the cooperative extension service with
- 21 specific reference to accomplishments and impacts.
- Sec. 434. Included in the appropriation in part 1 for Michigan
- 23 State University is \$80,000.00 for the Michigan future farmers of
- 24 America association. This \$80,000.00 appropriation shall not
- 25 supplant any existing support that Michigan State University
- 26 provides to the Michigan future farmers of America association.
- Sec. 436. (1) It is the intent of the legislature that, if any

1 public university increases its resident undergraduate tuition and

- 2 required fees from academic year 2010-2011 to academic year 2011-
- 3 2012, then that university shall increase its fiscal year 2010-2011
- 4 general fund expenditures for student financial aid by at least the
- 5 same percentage as the percentage change in resident undergraduate
- 6 tuition and required fees. It is the intent of the legislature that
- 7 public universities place an emphasis on increasing the number of
- 8 institutional financial aid awards that are based on demonstrated
- 9 financial need.
- 10 (2) Each public university shall report the following
- 11 information to the house and senate appropriations subcommittees on
- 12 higher education, the house and senate fiscal agencies, and the
- 13 state budget director by November 1, 2011:
- 14 (a) Actual academic year 2010-2011 and academic year 2011-2012
- 15 average tuition and required fee charges for a full-time resident
- 16 undergraduate student.
- 17 (b) Actual fiscal year 2010-2011 and budgeted fiscal year
- 18 2011-2012 total general fund tuition and fee revenue.
- 19 (c) Actual fiscal year 2010-2011 and budgeted fiscal year
- 20 2011-2012 total general fund revenue.
- 21 (d) Actual fiscal year 2010-2011 and budgeted fiscal year
- 22 2011-2012 general fund expenditures for student financial aid.
- 23 (e) Actual fiscal year 2010-2011 and budgeted fiscal year
- 24 2011-2012 total general fund expenditures.
- 25 (f) Actual fiscal year 2010-2011 and projected fiscal year
- 26 2011-2012 total fiscal year equated student enrollment.
- 27 (3) The state budget director shall, in consultation with the

- 1 house and senate fiscal agencies, develop a uniform reporting
- 2 mechanism based on standard definitions for public universities to
- 3 comply with the reporting requirements of subsection (2).
- 4 Sec. 440. All public universities shall submit the amount of
- 5 tuition and fees actually charged to a full-time resident
- 6 undergraduate student for academic year 2011-2012 as part of their
- 7 higher education institutional data inventory (HEIDI) data by
- 8 August 31, 2011. A public university shall report any revisions for
- 9 any semester of the reported academic year 2011-2012 tuition and
- 10 fee charges to HEIDI within 15 days of being adopted.
- 11 Sec. 451. For the fiscal year ending September 30, 2012, it is
- 12 the intent of the legislature that funds be allocated for unfunded
- 13 North American Indian tuition waiver costs incurred by public
- 14 universities under 1976 PA 174, MCL 390.1251 to 390.1253, from the
- 15 general fund/general purpose.
- 16 Sec. 460. From the amount appropriated in part 1 to Central
- 17 Michigan University for operations, \$29,700.00 shall be paid to
- 18 Saginaw Chippewa Tribal College for the costs of waiving tuition
- 19 for North American Indians under 1976 PA 174, MCL 390.1251 to
- **20** 390.1253.
- 21 Sec. 461. From the amount appropriated in part 1 to Lake
- 22 Superior State University for operations, \$100,000.00 shall be paid
- 23 to Bay Mills Community College for the costs of waiving tuition for
- 24 North American Indians under 1976 PA 174, MCL 390.1251 to 390.1253.
- 25 Sec. 466. Public universities shall coordinate their purchases
- 26 of goods and services whenever possible. This may include, but is
- 27 not limited to, group purchases for vehicles, utilities, supplies,

- 1 electronic equipment, maintenance equipment, books, and contractual
- 2 services. To the extent possible, the public universities shall use
- 3 both the "Michigan delivering extended agreements locally" (MiDEAL)
- 4 purchasing services of the state department of technology,
- 5 management, and budget that makes state contracts available to
- 6 local units of government, colleges, and universities and the
- 7 purchasing services available through the state's membership in the
- 8 Midwestern Higher Education Compact (MHEC). Not later than January
- 9 1 of each year, the presidents council, state universities of
- 10 Michigan shall submit to the members of the house and senate
- 11 appropriations subcommittees on higher education, the house and
- 12 senate fiscal agencies, and the state budget director a report on
- 13 group or pooled purchases and the savings achieved by the public
- 14 universities in the previous fiscal year.
- 15 Sec. 469. By November 14, 2011, each public university
- 16 receiving an appropriation in part 1 shall report the number of
- 17 undergraduate students who graduated in academic year 2010-2011 and
- 18 received a Pell grant at any time during their enrollment at that
- 19 university to the members of the house and senate appropriations
- 20 subcommittees on higher education, the house and senate fiscal
- 21 agencies, and the state budget director.
- Sec. 472. It is the intent of the legislature that each public
- 23 university shall submit a report to the house and senate
- 24 appropriations committees, the house and senate fiscal agencies,
- 25 and the state budget director by October 15, 2011, on the
- 26 university's efforts to accommodate the sincerely held religious
- 27 beliefs of students enrolled in accredited counseling degree

- 1 programs at the university.
- 2 Sec. 473. It is the intent of the legislature that each public
- 3 university that has received a donation of human embryos that is
- 4 subject to section 27 of article I of the state constitution of
- 5 1963, or that is conducting ongoing research using human embryonic
- 6 stem cells derived from donated human embryos pursuant to section
- 7 27 of article I of the state constitution of 1963, shall submit a
- 8 report to the director of the department of community health by
- 9 December 1, 2011 that includes all of the following:
- 10 (a) The number of human embryos and the number of human embryo
- 11 stem cell lines received by the university during fiscal year 2010-
- **12** 2011.
- 13 (b) The number of human embryos utilized for research purposes
- 14 during fiscal year 2010-2011.
- 15 (c) The number of human embryo stem cell lines created from
- 16 the embryos received during fiscal year 2010-2011.
- 17 (d) The number of donated human embryos being held in storage
- 18 by the university as of September 30, 2011.
- 19 (e) The number of research projects using human embryonic stem
- 20 cells derived from donated embryos being conducted by the
- 21 university.
- Sec. 480. (1) It is the intent of the legislature that each
- 23 public university receiving an appropriation in part 1 do all of
- 24 the following:
- 25 (a) Meet the provisions of section 5003 of the post-911
- 26 veterans educational assistance act of 2008, title V of Public Law
- 27 110-252, 38 USC 3301 to 3324, including voluntary participation in

- 1 the yellow ribbon GI education enhancement program established in
- 2 that act in 38 USC 3317. By October 1 of each year, each public
- 3 university shall report to the house and senate appropriations
- 4 subcommittees on higher education, the house and senate fiscal
- 5 agencies, and the presidents council, state universities of
- 6 Michigan on whether or not it has chosen to participate in the
- 7 yellow ribbon GI education enhancement program. If at any time
- 8 during the fiscal year a university participating in the yellow
- 9 ribbon program chooses to leave the yellow ribbon program, it shall
- 10 notify the house and senate appropriations subcommittees on higher
- 11 education, the house and senate fiscal agencies, and the presidents
- 12 council, state universities of Michigan.
- 13 (b) Establish an on-campus veterans' liaison to provide
- 14 information and assistance to all student veterans.
- 15 (c) Provide flexible enrollment application deadlines for all
- 16 veterans.
- 17 (2) As used in this section, "veteran" means an honorably
- 18 discharged veteran entitled to educational assistance under the
- 19 provisions of section 5003 of the post-911 veterans educational
- 20 assistance act of 2008, title V of Public Law 110-252, 38 USC 3301
- **21** to 3324.
- 22 Sec. 482. Funds appropriated in part 1 shall not be used to
- 23 pay for the construction or maintenance of a self-liquidating
- 24 project. A public university shall comply with the current use and
- 25 finance requirements of the joint capital outlay subcommittee
- 26 (JCOS) for any construction, renovation, or other capital outlay
- 27 projects pursuant to JCOS policy. The appropriation in part 1 for a

- 1 public university that fails to comply with JCOS reporting
- 2 requirements shall be reduced by 1% for each violation.
- 3 Sec. 483. (1) If the combined total of the maximum amount
- 4 appropriated under this act from the state school aid fund for
- 5 fiscal year 2011-2012 and the maximum amounts appropriated under
- 6 the public acts making appropriations for K-12 state school aid and
- 7 community colleges for that fiscal year exceeds the amount
- 8 available for expenditure from the state school aid fund for that
- 9 fiscal year, payments under this act are subject to the proration
- 10 provided under this subsection and subsection (2). If proration is
- 11 necessary, state payments under this act from the state school aid

- 3 education. Preference may not be given to applicants on the basis
- 4 of race, color, ethnicity, gender, or national origin. Institutions
- 5 should encourage applications from applicants who would otherwise
- 6 not adequately be represented in the graduate student and faculty
- 7 populations. Each public university shall apply the percentage
- 8 change applicable to every public university in the calculation of
- 9 appropriations in part 1 to the amount of funds allocated to the
- 10 future faculty program.
- 11 (2) The program shall be administered by each public
- 12 university in a manner prescribed by the Michigan department of
- 13 energy, labor, and economic growth. The Michigan department of
- 14 energy, labor, and economic growth shall use a good faith effort
- 15 standard to evaluate whether a fellowship is in default.
- 16 Sec. 502. (1) Included in the appropriation for each public
- 17 university in part 1 is funding for the Martin Luther King, Jr. -
- 18 Cesar Chavez Rosa Parks college day program that is intended to
- 19 introduce academically or economically disadvantaged schoolchildren
- 20 to the potential of a college education. Preference may not be
- 21 given to participants on the basis of race, color, ethnicity,
- 22 gender, or national origin. Public universities should encourage
- 23 participation from those who would otherwise not adequately be
- 24 represented in the student population.
- 25 (2) Individual program plans of each public university shall
- 26 include a budget of equal contributions from this program, the
- 27 participating public university, the participating school district,

1 and the participating independent degree-granting college. College

- 2 day funds shall not be expended to cover indirect costs. Not more
- 3 than 20% of the university match shall be attributable to indirect
- 4 costs. Each public university shall apply the percentage change
- 5 applicable to every public university in the calculation of
- 6 appropriations in part 1 to the amount of funds allocated to the
- 7 college day program.
- 8 (3) The program described in this section shall be
- 9 administered by each public university in a manner prescribed by
- 10 the Michigan department of energy, labor, and economic growth.
- 11 Sec. 503. (1) Included in part 1 is funding for the Martin
- 12 Luther King, Jr. Cesar Chavez Rosa Parks select student support
- 13 services program for developing academically or economically
- 14 disadvantaged student retention programs for 4-year public and
- 15 independent educational institutions in this state. Preference may
- 16 not be given to participants on the basis of race, color,
- 17 ethnicity, gender, or national origin. Institutions should
- 18 encourage participation from those who would otherwise not
- 19 adequately be represented in the student population.
- 20 (2) An award made under this program to any 1 institution
- 21 shall not be greater than \$150,000.00, and the amount awarded shall
- 22 be matched on a 70% state, 30% college or university basis.
- 23 (3) The program described in this section shall be
- 24 administered by the Michigan department of energy, labor, and
- 25 economic growth.
- Sec. 504. (1) Included in part 1 is funding for the Martin
- 27 Luther King, Jr. Cesar Chavez Rosa Parks college/university

- 1 partnership program between 4-year public and independent colleges
- 2 and universities and public community colleges, which is intended
- 3 to increase the number of academically or economically
- 4 disadvantaged students who transfer from community colleges into
- 5 baccalaureate programs. Preference may not be given to participants
- 6 on the basis of race, color, ethnicity, gender, or national origin.
- 7 Institutions should encourage participation from those who would
- 8 otherwise not adequately be represented in the transfer student
- 9 population.
- 10 (2) The grants shall be made under the program described in
- 11 this section to Michigan public and independent colleges and
- 12 universities. An award to any 1 institution shall not be greater
- than \$150,000.00, and the amount awarded shall be matched on a 70%
- 14 state, 30% college or university basis.
- 15 (3) The program described in this section shall be
- 16 administered by the Michigan department of energy, labor, and
- 17 economic growth.
- 18 Sec. 505. (1) Included in the appropriation for each public
- 19 university in part 1 is funding for the Martin Luther King, Jr. -
- 20 Cesar Chavez Rosa Parks visiting professors program which is
- 21 intended to increase the number of instructors in the classroom to
- 22 provide role models for academically or economically disadvantaged
- 23 students. Preference may not be given to participants on the basis
- 24 of race, color, ethnicity, gender, or national origin. Public
- 25 universities should encourage participation from those who would
- 26 otherwise not adequately be represented in the student population.
- 27 (2) The program described in this section shall be

- 1 administered by the Michigan department of energy, labor, and
- 2 economic growth.
- 3 Sec. 506. (1) Included in the appropriation in part 1 is
- 4 funding under the Martin Luther King, Jr. Cesar Chavez Rosa
- 5 Parks initiative for the Morris Hood, Jr. educator development
- 6 program which is intended to increase the number of academically or
- 7 economically disadvantaged students who enroll in and complete K-12
- 8 teacher education programs at the baccalaureate level. Preference
- 9 may not be given to participants on the basis of race, color,
- 10 ethnicity, gender, or national origin. Institutions should
- 11 encourage participation from those who would otherwise not
- 12 adequately be represented in the teacher education student
- 13 population.
- 14 (2) The program described in this section shall be
- 15 administered by each state-approved teacher education institution
- 16 in a manner prescribed by the Michigan department of energy, labor,
- 17 and economic growth.
- 18 (3) Approved teacher education institutions may and are
- 19 encouraged to use student support services funding in coordination
- 20 with the Morris Hood, Jr. funding to achieve the goals of the
- 21 program described in this section.
- 22 Sec. 507. Each institution receiving funds under section 503,
- 23 504, or 506 shall notify the Michigan department of energy, labor,
- 24 and economic growth by April 15, 2012 as to whether it will expend
- 25 by the end of its fiscal year the funds received under section 503,
- 26 504, or 506. Notwithstanding the award limitations in sections 503
- 27 and 504, the amount of funding reported as not being expended will

3 STUDENT PERFORMANCE REPORTING

- 16 universities shall inform Michigan community colleges regarding the

- 18 prescribed by the presidents council, state universities of
- 19 Michigan in cooperation with the Michigan community college
- 20 association.
- 21 Sec. 603. Public universities shall work with the state
- 22 community colleges to encourage the transfer of students from the
- 23 community colleges to the state universities and to facilitate the
- 24 transfer of credits from the community colleges to the public
- 25 universities.

GENERAL REPORTS AND AUDITS

- 2 Sec. 701. (1) The auditor general shall review higher
- 3 education institutional data inventory (HEIDI) enrollment data
- 4 submitted by all public universities and may perform audits of
- 5 selected public universities if determined necessary. The review
- 6 and audits shall be based upon the definitions, requirements, and
- 7 uniform reporting categories established by the state budget
- 8 director and the house and senate fiscal agencies in consultation

- 23 education credit hours in a given term and the student's non-
- 24 distance education enrollment is at a campus or site located within
- 25 Michigan, student credit hours per the student's eligibility for
- in-state or out-of-state tuition rates may be reported.
- 27 (c) Student credit hours generated through credit by

- 1 examination.
- 2 (d) Student credit hours generated through inmate prison
- 3 programs regardless of teaching location.
- 4 (e) Student credit hours generated in new degree programs
- 5 after January 1, 1975, that have not been specifically authorized

- 6 for funding by the legislature, except spin-off programs converted
- 7 from existing core programs that do all of the following:
- 8 (i) Represent new options, fields, or concentrations within
- 9 existing programs.
- 10 (ii) Are consistent with the current institutional role and
- 11 mission.
- 12 (iii) Are accommodated within the continuing funding base of the
- 13 public university.
- (iv) Do not require a new degree level beyond that which the
- 15 public university is currently authorized to grant within that
- 16 discipline or field.
- 17 (v) Do not require funding from the state other than that
- 18 provided by the student credit hours generated within the program,
- 19 either before program initiation or within the first 3 years of
- 20 program operation.
- 21 (3) The auditor general shall periodically audit higher
- 22 education institutional data inventory (HEIDI) data as submitted by
- 23 the public universities for compliance with the definitions
- 24 established by the state budget director in consultation with the

- 2 conference. The January 2012 consensus revenue estimating
- 3 conference shall include estimates for fiscal year 2011-2012,
- 4 fiscal year 2012-2013, and fiscal year 2013-2014 for the following:

- 6 (b) Prison population and correction expenditures.
- 7 (c) Annual percentage growth in the school aid basic
