

HOUSE SUBSTITUTE FOR  
SENATE BILL NO. 962

A bill to make appropriations for the department of state police and certain other state purposes for the fiscal year ending September 30, 2013; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of those reports; to provide for the disposition of other income received by the various state agencies; to provide for certain emergency powers; to provide for the powers and duties of certain committees, certain state agencies, and certain employees; and to provide for the acquisition and disposition of certain real and personal property.

2 LINE-ITEM APPROPRIATIONS  
3 FOR FISCAL YEAR 2012-2013

Sec. 101. Subject to the conditions set forth in this act, the amounts listed in this part for the department of state police are appropriated for the fiscal year ending September 30, 2013, from the funds indicated in this part. The following is a summary of the appropriations in this part:

**PROVISIONS CONCERNING APPROPRIATIONS**

**FOR FISCAL YEAR 2012-2013**

**GENERAL SECTIONS**

Sec. 201. Pursuant to section 30 of article IX of the state constitution of 1963, total state spending from state resources under part 1 for fiscal year 2012-2013 is \$100.00 and state spending from state resources to be paid to local units of government for fiscal year 2012-2013 is \$0.00.

Sec. 202. The appropriations authorized under this act are subject to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.

**PART 2A**

**PROVISIONS CONCERNING ANTICIPATED APPROPRIATIONS**

**FOR FISCAL YEAR 2013-2014**

1 **GENERAL SECTIONS**

2       Sec. 1201. (1) It is the intent of the legislature to provide  
3 appropriations for the fiscal year ending on September 30, 2014 for  
4 the line items listed in part 1. The fiscal year 2013-2014  
5 appropriations are anticipated to be the same as those for fiscal  
6 year 2012-2013, except that the line items will be adjusted for  
7 changes in caseload and related costs, federal fund match rates,  
8 economic factors, and available revenue.

9       (2) It is the intent of the legislature that the 180 troopers  
10 hired during fiscal year 2012-2013 shall be used to reduce crime  
11 rates in this state's most distressed cities once fully deployed.

12       (3) It is the intent of the legislature that the 20 additional  
13 forensic employees hired during fiscal year 2012-2013 shall be used  
14 to reach an average 30-day turnaround for forensic evidence once  
15 fully trained.
