THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11506. (1) "Solid waste" means garbage, rubbish, ashes,
- 2 incinerator ash, incinerator residue, street cleanings, municipal
- 3 and industrial sludges, solid commercial and solid industrial
- 4 waste, and animal waste other than organic waste generated in the
- 5 production of livestock and poultry. However, solid waste does not
- 6 include the following:
- 7 (a) Human body waste.
- 8 (b) Medical waste.
- 9 (c) Organic waste generated in the production of livestock and
- **10** poultry.
- 11 (d) Liquid waste.

- (e) Ferrous or nonferrous scrap directed to a scrap metal
 processor or to a reuser of ferrous or nonferrous products.
- 3 (f) Slag or slag products directed to a slag processor or to a4 reuser of slag or slag products.
- 5 (g) Sludges and ashes managed as recycled or nondetrimental materials appropriate for agricultural or silvicultural use 6 pursuant to a plan approved by the department. Food processing 7 residuals, precipitated calcium carbonate from sugar beet 8 9 processing, wood ashes resulting solely from a source that burns only wood that is untreated and inert, lime from kraft pulping 10 11 processes generated prior to bleaching, or aquatic plants may be 12 applied on, or composted and applied on, farmland or forestland for 13 an agricultural or silvicultural purpose, or used as animal feed, 14 as appropriate, and such an application or use does not require a plan described in this subdivision or a permit or license under 15 this part. In addition, source separated materials approved by the 16 17 department for land application for agricultural and silvicultural 18 purposes and compost produced from those materials may be applied 19 to the land for agricultural and silvicultural purposes and such an 20 application does not require a plan described in this subdivision or permit or license under this part. Land application authorized 21 under this subdivision for an agricultural or silvicultural 22 23 purpose, or use as animal feed as provided for in this subdivision 24 shall be performed in a manner that prevents losses from runoff and leaching. Land application under this subdivision shall be at an 25 26 agronomic rate consistent with generally accepted agricultural and

management practices under the Michigan right to farm act, 1981 PA

- 2 (h) Materials approved for emergency disposal by the
- 3 department.
- 4 (i) Source separated materials.
- 5 (j) Site separated material.
- 6 (k) Fly ash or any other ash produced from the combustion of
- 7 coal, when used in UNDER ANY OF the following
- 8 instances: CIRCUMSTANCES:
- 9 (i) With a maximum of 6% of unburned carbon, if used as AS a
- 10 component of concrete, grout, mortar, or casting molds, IF THE FLY
- 11 ASH HAS NOT MORE THAN 6% UNBURNED CARBON.
- 12 (ii) With a maximum of 12% unburned carbon passing M.D.O.T.
- 13 test method MTM 101, if used as AS a raw material in asphalt for
- 14 road construction, IF THE FLY ASH HAS NOT MORE THAN 12% UNBURNED
- 15 CARBON AND PASSES MICHIGAN TEST METHOD FOR WATER ASPHALT

- 19 (iii) As aggregate, road, or building material that in ultimate
- 20 use will be stabilized or bonded by cement, limes, or asphalt.
- 21 (iv) As a road base or construction fill that is covered with
- 22 asphalt, concrete, or other material approved by the department and
- 23 that is placed at least 4 feet above the seasonal groundwater
- 24 table.
- (v) As the sole material in a depository designed to reclaim,
- 26 develop, or otherwise enhance land, subject to the approval of the
- 27 department. In evaluating the site, the department shall consider

- 1 the physical and chemical properties of the ash, including, but not
- 2 limited to, leachability, and the engineering of the depository,
- 3 including, but not limited to, the compaction, control of surface
- 4 water and groundwater that may threaten to infiltrate the site, and
- 5 evidence that the depository is designed to prevent water
- 6 percolation through the material.
- 7 (l) SOIL THAT IS WASHED OR OTHERWISE REMOVED FROM SUGAR BEETS,
- 8 HAS NOT MORE THAN 35% MOISTURE CONTENT, AND IS REGISTERED AS A SOIL
- 9 AMENDMENT UNDER PART 85. ANY TESTING REQUIRED TO BECOME REGISTERED
- 10 UNDER PART 85 IS THE RESPONSIBILITY OF THE GENERATOR.
- 11 (M) SOIL THAT IS RELOCATED UNDER SECTION 20120C.
- 12 (N) $\frac{(l)}{(l)}$ Other wastes regulated by statute.
- 13 (2) "Solid waste hauler" means a person who owns or operates a
- 14 solid waste transporting unit.
- 15 (3) "Solid waste processing plant" means a tract of land,
- 16 building, unit, or appurtenance of a building or unit or a
- 17 combination of land, buildings, and units that is used or intended
- 18 for use for the processing of solid waste or the separation of
- 19 material for salvage or disposal, or both, but does not include a
- 20 plant engaged primarily in the acquisition, processing, and
- 21 shipment of ferrous or nonferrous metal scrap, or a plant engaged
- 22 primarily in the acquisition, processing, and shipment of slag or
- 23 slag products.
- 24 (4) "Solid waste transporting unit" means a container, which
- 25 may be an integral part of a truck or other piece of equipment,
- 26 used for the transportation of solid waste.
- 27 (5) "Solid waste transfer facility" means a tract of land, a

- 1 building and any appurtenances, or a container, or any combination
- 2 of land, buildings, or containers that is used or intended for use
- 3 in the rehandling or storage of solid waste incidental to the
- 4 transportation of the solid waste, but is not located at the site
- 5 of generation or the site of disposal of the solid waste.
- 6 (6) "Source separated material" means glass, metal, wood,
- 7 paper products, plastics, rubber, textiles, garbage, or any other
- 8 material approved by the department that is separated at the source
- 9 of generation for the purpose of conversion into raw materials or
- 10 new products including, but not limited to, compost.
- 11 (7) "Type I public water supply", "type IIa public water
- 12 supply", "type IIb public water supply", and "type III public water
- 13 supply" mean those terms, respectively, as described in R 325.10502
- 14 of the Michigan administrative code.
- 15 (8) "Yard clippings" means leaves, grass clippings, vegetable
- 16 or other garden debris, shrubbery, or brush or tree trimmings, less
- 17 than 4 feet in length and 2 inches in diameter, that can be
- 18 converted to compost humus. Yard clippings do not include stumps,
- 19 agricultural wastes, animal waste, roots, sewage sludge, or
- 20 garbage.
- 21 Sec. 19608. (1) Money in the fund that is allocated under
- 22 section 19607 shall be used for the following purposes:
- (a) Money allocated under section 19607(1)(a) shall be used by
- 24 the department to fund all of the following:
- 25 (i) Corrective actions undertaken by the department to address
- 26 releases from leaking underground storage tanks pursuant to part
- **27** 213.

- 1 (ii) Response activities undertaken by the department at
- 2 facilities pursuant to part 201 to address public health and
- 3 environmental problems or to promote redevelopment.
- 4 (iii) Assessment activities undertaken by the department to
- 5 determine whether a property is a facility.
- (iv) \$75,000,000.00 shall be used to provide grants and loans
- 7 to local units of government and brownfield redevelopment
- 8 authorities created under the brownfield redevelopment financing
- 9 act, 1996 PA 381, MCL 125.2651 to 125.2672, for response activities
- 10 at known or suspected facilities with redevelopment potential. Of
- 11 the money provided for in this subparagraph, not more than
- 12 \$37,500,000.00 \$50,000,000.00 shall be used to provide grants and
- 13 not more than \$37,500,000.00 \$25,000,000.00 shall be used to
- 14 provide loans pursuant to the clean Michigan initiative revolving
- 15 loan program created in section 19608a. However, grants or loans
- 16 provided for in this subparagraph shall not be made to a local unit
- 17 of government or a brownfield redevelopment authority that is
- 18 responsible for causing a release or threat of release under part
- 19 201 at the site proposed for grant or loan funding.
- 20 (v) Not more than \$12,000,000.00 shall be used for grants
- 21 pursuant to the municipal landfill grant program under section
- 22 20109a.
- (b) Money allocated under section 19607(1)(b) shall be used
- 24 for waterfront redevelopment grants pursuant to part 795.
- (c) Money allocated under section 19607(1)(c) shall be used
- 26 for response activities for the remediation of contaminated lake
- 27 and river sediments pursuant to part 201.

- 1 (d) Money allocated under section 19607(1)(d) shall be used
- 2 for nonpoint source pollution prevention and control grants or
- 3 wellhead protection grants pursuant to part 88.
- 4 (e) Money allocated under section 19607(1)(e) shall be
- 5 deposited into the clean water fund created in section 8807.
- 6 (f) Money allocated under section 19607(1)(f) shall be
- 7 expended as follows:
- 8 (i) \$10,000,000.00 shall be deposited into the retired
- 9 engineers technical assistance program fund created in section
- **10** 14512.
- 11 (ii) \$5,000,000.00 shall be deposited into the small business
- 12 pollution prevention assistance revolving loan fund created in
- **13** section 14513.
- 14 (iii) \$5,000,000.00 shall be used by the department to implement
- 15 pollution prevention activities other than those funded under
- 16 subparagraphs (i) and (ii).
- 17 (g) Money that is allocated under section 19607(1)(g) shall be
- 18 used by the department of community health for remediation and
- 19 physical improvements to structures to abate or minimize exposure
- 20 of persons to lead hazards.
- 21 (h) Money allocated under section 19607(1)(h) shall be used
- 22 for infrastructure improvements at Michigan state parks as
- 23 determined by the department of natural resources. The installation
- 24 or upgrade of drinking water systems or rest room facilities shall
- 25 be the first priority.
- 26 (i) Money allocated under section 19607(1)(i) shall be used to
- 27 provide grants to local units of government for local recreation

- 1 projects pursuant to part 716.
- 2 (2) Of the money allocated under section 19607(1)(a),
- 3 \$93,000,000.00 shall be used for facilities that pose an imminent
- 4 or substantial endangerment to the public health, safety, or
- 5 welfare, or to the environment. For purposes of this subsection,
- 6 facilities that pose an imminent or substantial endangerment shall
- 7 include, but are not limited to, those where public access poses
- 8 hazards because of potential exposure to chemicals or safety risks
- 9 and where drinking water supplies are threatened by contamination.
- 10 (3) Before expending any funds allocated under subsection
- 11 (1)(c) at a site that is an area of concern as designated by the
- 12 parties to the Great Lakes water quality agreement, the department
- 13 shall notify the public advisory council established to oversee
- 14 that area of concern regarding the development, implementation, and
- 15 evaluation of response activities to be conducted with money in the
- 16 fund at that area of concern.
- 17 (4) Money in the fund shall not be used to develop a municipal
- 18 or commercial marina.
- 19 (5) Money provided in the fund may be used by the department
- 20 of treasury to pay for the cost of issuing bonds and by the
- 21 department and the department of natural resources to pay
- 22 department costs as provided in this subsection. Not more than 3%
- 23 of the total amount specified in section 19607(1)(a) to (f) shall
- 24 be available for appropriation to the department to pay its costs
- 25 directly associated with the completion of a project authorized by
- 26 section 19607(1)(a) to (f). Not more than 3% of the total amount
- 27 specified in section 19607(1)(h) and (i) shall be available for

- 1 appropriation to the department of natural resources to pay its
- 2 costs directly associated with the completion of a project
- 3 authorized by section 19607(1)(h) and (i). It is the intent of the
- 4 legislature that general fund appropriations to the department and
- 5 to the department of natural resources shall not be reduced as a
- 6 result of costs funded pursuant to this subsection.
- 7 (6) A grant shall not be provided under this part for a
- 8 project that is located at any of the following:
- 9 (a) Land sited for use as a gaming facility or as a stadium or
- 10 arena for use by a professional sports team.
- 11 (b) Land or other facilities owned or operated by a gaming
- 12 facility or by a stadium or arena for use by a professional sports
- 13 team.
- 14 (c) Land within a project area described in a project plan
- 15 pursuant to the economic development corporations act, 1974 PA 338,
- 16 MCL 125.1601 to 125.1636, for a gaming facility.
- 17 (7) The department, the department of natural resources, and
- 18 the department of community health shall each submit annually a
- 19 list of all projects that will be undertaken by that department
- 20 that are recommended to be funded under this part. The list shall
- 21 be submitted to the governor, the standing committees of the house
- 22 of representatives and the senate that primarily address issues
- 23 pertaining to the protection of natural resources and the
- 24 environment, and the appropriations committees in the house of
- 25 representatives and the senate. The list shall be submitted to the
- 26 legislative committees not later than February 15 of each year.
- 27 This list shall also be submitted before any request for

- 1 supplemental appropriation of bond funds. For each eligible
- 2 project, the list shall include the nature of the eligible project;
- 3 the county in which the eligible project is located; an estimate of
- 4 the total cost of the eligible project; and other information
- 5 considered pertinent by the administering state department. A
- 6 project that is funded by a grant or loan with money from the fund
- 7 does not need to be included on the list submitted under this
- 8 subsection. However, money in the fund that is appropriated for
- 9 grants and loans shall not be encumbered or expended until the
- 10 administering state department has reported those projects that
- 11 have been approved for a grant or a loan to the standing committees
- 12 of the house of representatives and the senate that primarily
- 13 address issues pertaining to the protection of natural resources
- 14 and the environment and to the appropriations subcommittees in the
- 15 house of representatives and the senate on natural resources and
- 16 environmental quality. Before submitting the first cycle of
- 17 recommended projects under subsection (1)(a), the department shall
- 18 publish and disseminate the criteria it will use in evaluating and
- 19 recommending these projects for funding.
- 20 (8) The legislature shall appropriate prospective or actual
- 21 bond proceeds for projects proposed to be funded. Appropriations
- 22 shall be carried over to succeeding fiscal years until the project
- 23 for which the funds are appropriated is completed.
- 24 (9) Not later than December 31 of each year, the department,
- 25 the department of natural resources, and the department of
- 26 community health shall each submit a list of the projects financed
- 27 under this part by that department to the governor, the standing

- 1 committees of the house of representatives and the senate that
- 2 primarily address issues pertaining to the protection of natural
- 3 resources and the environment, and the subcommittees of the house
- 4 of representatives and the senate on appropriations on natural
- 5 resources and environmental quality. Each list shall include the
- 6 name, address, and telephone number of the recipient or
- 7 participant, if appropriate; the name and location of the project;
- 8 the nature of the project; the amount of money allocated to the
- 9 project; the county in which the project is located; a brief
- 10 summary of what has been accomplished by the project; and other
- 11 information considered pertinent by the administering state
- 12 department.
- Sec. 19612. (1) A recipient of a grant or a loan made with
- 14 money from the fund shall do both of the following:
- 15 (a) Keep an accounting of the money spent on the project or
- 16 facility in a generally accepted manner. The accounting shall be
- 17 subject to a postaudit.
- 18 (b) Obtain authorization from the administering state
- 19 department before implementing a change that significantly alters
- 20 the proposed project.
- 21 (2) The administering state department may revoke a grant or a
- 22 loan made with money from the fund or withhold payment if the
- 23 recipient fails to comply with the terms and conditions of the
- 24 grant or loan agreement or with the requirements of this part or
- 25 the rules promulgated under this part, or with other applicable law
- 26 or rules. If a grant or loan is revoked, the administering state
- 27 department may recover all funds awarded.

- 1 (3) The administering state department may withhold a grant or
- 2 a loan until the administering state department determines that the
- 3 recipient is able to proceed with the proposed project.
- 4 (4) To assure timely completion of a project, the
- 5 administering state department may withhold 10% of the grant or
- 6 loan amount until the project is complete.
- 7 (5) If an approved applicant fails to sign a grant or loan
- 8 agreement within 90 days after receipt of a written grant or loan
- 9 offer by the administering state department, the administering
- 10 state department may cancel the grant or loan offer. The applicant
- 11 may not appeal or contest a cancellation pursuant to this
- 12 subsection.
- 13 (6) The administering state department may terminate a grant
- 14 or loan agreement and require immediate repayment of the grant or
- 15 loan if the recipient uses grant or loan funds for any purpose
- 16 other than for the approved activities specified in the grant or
- 17 loan agreement. The administering state department shall provide
- 18 the recipient written notice of the termination 30 days prior to
- 19 the termination.
- 20 (7) A loan made with money in the fund shall have the
- 21 following terms:
- 22 (a) A loan interest rate of not more than 50% of the prime
- 23 rate as determined by the administering state department as of the
- 24 date of approval of the loan.
- 25 (b) Loan recipients shall repay loans in equal annual
- 26 installments of principal and interest beginning not later than 5
- 27 years after execution of a loan agreement and concluding not later

- 1 than 15 years after execution of a loan agreement.
- 2 (c) A loan recipient shall enter into a loan agreement with
- 3 the administering state department. At a minimum, the loan
- 4 agreement shall contain a commitment that the loan is secured by a
- 5 full faith and credit pledge of the applicant, or if the applicant
- 6 is an authority established pursuant to the brownfield
- 7 redevelopment financing act, 1996 PA 381, MCL 125.2651 to 125.2672,
- 8 the commitment shall be from the municipality that created the
- 9 authority pursuant to that act.
- 10 (d) Upon default of a loan, as determined by the administering
- 11 state department, or upon the request of the loan recipient as a
- 12 method to repay the loan, the department of treasury shall withhold
- 13 state payments from the loan recipient in amounts consistent with
- 14 the repayment schedule in the loan agreement until the loan is
- 15 repaid. The department of treasury shall deposit these withheld
- 16 funds into the fund until the loan is repaid.
- 17 (8) Loan payments and interest shall be deposited in the fund.
- 18 (9) Upon default of a loan, as determined by the administering
- 19 state department, or upon the request of the loan recipient as a
- 20 method to repay the loan, the department of treasury shall withhold
- 21 from the loan recipient state payments in amounts consistent with
- 22 the repayment schedule in the loan agreement until the loan is
- 23 repaid. The department of treasury shall deposit these withheld
- 24 funds into the fund until the loan is repaid.
- 25 Sec. 20101. (1) As used in this part:
- 26 (a) "Act of God" means an unanticipated grave natural disaster
- 27 or other natural phenomenon of an exceptional, inevitable, and

- 1 irresistible character, the effects of which could not have been
- 2 prevented or avoided by the exercise of due care or foresight.
- 3 (b) "Agricultural property" means real property used for
- 4 farming in any of its branches, including cultivating of soil;
- 5 growing and harvesting of any agricultural, horticultural, or
- 6 floricultural commodity; dairying; raising of livestock, bees,
- 7 fish, fur-bearing animals, or poultry; turf and tree farming; and
- 8 performing any practices on a farm as an incident to, or in
- 9 conjunction with, these farming operations. Agricultural property
- 10 does not include property used for commercial storage, processing,
- 11 distribution, marketing, or shipping operations.
- 12 (c) "All appropriate inquiry" means an evaluation of
- 13 environmental conditions at a property at the time of purchase,
- 14 occupancy, or foreclosure that reasonably defines the existing
- 15 conditions and circumstances at the property in conformance with 40
- **16** CFR 312.
- 17 (d) "Attorney general" means the department of the attorney
- 18 general.
- 19 (e) "Background concentration" means the concentration or
- 20 level of a hazardous substance that exists in the environment at or
- 21 regionally proximate to a facility that is not attributable to any
- 22 release at or regionally proximate to the facility. A PERSON MAY
- 23 DEMONSTRATE A BACKGROUND CONCENTRATION FOR A HAZARDOUS SUBSTANCE BY
- 24 ANY OF THE FOLLOWING METHODS:
- 25 (i) THE HAZARDOUS SUBSTANCE COMPLIES WITH THE STATEWIDE DEFAULT
- 26 BACKGROUND LEVELS UNDER R 299.5746 OF THE MICHIGAN ADMINISTRATIVE
- 27 CODE.

- 1 (ii) THE HAZARDOUS SUBSTANCE IS LISTED IN THE DEPARTMENT'S 2005
- 2 MICHIGAN BACKGROUND SOIL SURVEY AND FALLS WITHIN THE TYPICAL RANGES
- 3 PUBLISHED IN THAT DOCUMENT.
- 4 (iii) THE HAZARDOUS SUBSTANCE IS LISTED IN ANY OTHER STUDY OR
- 5 SURVEY CONDUCTED OR APPROVED BY THE DEPARTMENT AND IS WITHIN THE
- 6 CONCENTRATIONS OR FALLS WITHIN THE TYPICAL RANGES PUBLISHED IN THAT
- 7 STUDY OR SURVEY.
- 8 (iv) A SITE-SPECIFIC DEMONSTRATION.
- 9 (f) "Baseline environmental assessment" means a written
- 10 document that describes the results of an all appropriate inquiry
- 11 and the sampling and analysis that confirm that the property is a
- 12 facility. However, for purposes of a baseline environmental
- 13 assessment, the all appropriate inquiry under 40 CFR 312.20(a) may
- 14 be conducted within 45 days after the date of acquisition of a
- 15 property and the components of an all appropriate inquiry under 40
- 16 CFR 312.20(b) and 40 CFR 312.20(c)(3) may be conducted or updated
- 17 within 45 days after the date of acquisition of a property.
- 18 (q) "Board" means the brownfield redevelopment board created
- 19 in section 20104a.
- 20 (H) "CERTIFICATE OF COMPLETION" MEANS A WRITTEN RESPONSE
- 21 PROVIDED BY THE DEPARTMENT CONFIRMING THAT A RESPONSE ACTIVITY HAS
- 22 BEEN COMPLETED IN ACCORDANCE WITH THE APPLICABLE REQUIREMENTS OF
- 23 THIS PART AND IS APPROVED BY THE DEPARTMENT.
- 24 (I) (h) "Cleanup criteria for unrestricted residential use"
- 25 means either of the following:
- 26 (i) Cleanup criteria that satisfy the requirements for the
- 27 residential category in section 20120a(1)(a) or (16).

- 1 (ii) Cleanup criteria for unrestricted residential use under
- 2 part 213.
- 3 (J) (i) "Department" means the director of the department of
- 4 natural resources and environment ENVIRONMENTAL QUALITY or his or
- 5 her designee to whom the director delegates a power or duty by
- 6 written instrument.
- 7 (K) (j) "Director" means the director of the department of
- 8 natural resources and environment. ENVIRONMENTAL QUALITY.
- 9 (l) (k) "Directors" means the directors or their designees of
- 10 the departments of natural resources and environment, ENVIRONMENTAL

- 7 Sec. 20120a. (1) The department may establish cleanup criteria
- 8 and approve of remedial actions in the categories listed in this
- 9 subsection. The cleanup category proposed shall be the option of
- 10 the person proposing the remedial action, subject to department
- 11 approval if required, considering the appropriateness of the

- 22 (g) "Regulated substance" means any of the following:
- 23 (i) A substance defined in section 101(14) of title I of the
- 24 comprehensive environmental response, compensation, and liability
- 25 act of 1980, Public Law 96-510, 42 USC 9601, but not including a
- 26 substance regulated as a hazardous waste under subtitle C of the
- 27 solid waste disposal act, title II of Public Law 89-272, 42 USC

- 2 (ii) Petroleum, including crude oil or any fraction of crude
- 3 oil that is liquid at standard conditions of temperature and
- 4 pressure (60 degrees Fahrenheit and 14.7 pounds per square inch
- 5 absolute). Petroleum includes but is not limited to mixtures of
- 6 petroleum with de minimis quantities of other regulated substances
- 7 and petroleum-based substances composed of a complex blend of

- 12 (n) "Site-specific target level" or "SSTL" means an RBCA risk-
- 13 based remedial action target level for contamination developed for
- 14 a site under RBCA tier II and tier III evaluations.
- 15 (o) "Threat of release" or "threatened release" means any
- 16 circumstance that may reasonably be anticipated to cause a release.
- 17 Threat of release or threatened release does not include the
- 18 ownership or operation of an underground storage tank system if the
- 19 underground storage tank system is operated in accordance with part
- 20 211 and rules promulgated under that part.
- 21 (p) "Tier I", "tier II", and "tier III" mean those terms as
- 22 they are used in RBCA.
- 23 (q) "Underground storage tank system" means a tank or
- 24 combination of tanks, including underground pipes connected to the

- 19 (viii) A liquid trap or associated gathering lines directly
- 20 related to oil or gas production and gathering operations.
- (ix) A storage tank situated in an underground area such as a
- 22 basement, cellar, mineworking, drift, shaft, or tunnel if the
- 23 storage tank is situated upon or above the surface of the floor.
- 24 (x) Any pipes connected to a tank that is described in
- 25 subdivisions (i) to (ix).
- 26 (xi) An underground storage tank system holding hazardous
- 27 wastes listed or identified under subtitle C of the solid waste

- 1 disposal act, title II of Public Law 89-272, 42 USC 6921 to 6939e,
- 2 or a mixture of such hazardous waste and other regulated
- 3 substances.
- $\mathbf{4}$ (xii) A wastewater treatment tank system that is part of a
- 5 wastewater treatment facility regulated under section 307(b) of
- 6 title III or section 402 of title IV of the federal water pollution
- 7 control act, 33 USC 1317 and 1342.
- 8 (xiii) Equipment or machinery that contains regulated substances
- 9 for operational purposes such as hydraulic lift tanks and
- 10 electrical equipment tanks.
- 11 (xiv) An underground storage tank system that has a capacity of
- 12 110 gallons or less.
- 13 (xv) An underground storage tank system that contains a de
- 14 minimis concentration of regulated substances.
- 15 (xvi) An emergency spill or overflow containment underground
- 16 storage tank system that is expeditiously emptied after use.
- 17 (r) "Vadose zone" means the soil between the land surface and
- 18 the top of the capillary fringe. Vadose zone is also known as an
- 19 unsaturated zone or a zone of aeration.
- 20 Sec. 21304. (1) Actions taken by a consultant pursuant to this
- 21 part do not limit or remove the liability of an owner or operator
- 22 THAT IS LIABLE UNDER SECTION 21323A except as specifically provided
- 23 for in this part.
- 24 (2) Notwithstanding any other provision in this part, if an
- 25 owner or operator THAT IS LIABLE UNDER SECTION 21323A is a
- 26 consultant or employs a consultant, this part does not require the
- 27 owner or operator THAT IS LIABLE UNDER SECTION 21323A to retain an

- 1 outside consultant to perform the responsibilities required under
- 2 this part. Those responsibilities may be performed by an owner or
- 3 operator THAT IS LIABLE UNDER SECTION 21323A who is a consultant or

- 5 Sec. 21304c. (1) A person that owns or operates property that
- 6 the person has knowledge is or was a site CONTAMINATED shall do all
- 7 of the following with respect to regulated substances at the
- 8 property:
- 9 (a) Undertake measures as are necessary to prevent
- 10 exacerbation.
- 11 (b) Exercise due care by undertaking corrective action
- 12 necessary to mitigate unacceptable exposure to regulated
- 13 substances, mitigate fire and explosion hazards due to regulated
- 14 substances, and allow for the intended use of the property in a
- 15 manner that protects the public health and safety.
- 16 (c) Take reasonable precautions against the reasonably
- 17 foreseeable acts or omissions of a third party and the consequences
- 18 that foreseeably could result from those acts or omissions.
- 19 (d) Provide reasonable cooperation, assistance, and access to
- 20 the persons that are authorized to conduct corrective action
- 21 activities at the property, including the cooperation and access
- 22 necessary for the installation, integrity, operation, and
- 23 maintenance of any complete or partial corrective action activity
- 24 at the property. Nothing in this subdivision shall be interpreted
- 25 to provide any right of access not expressly authorized by law,
- 26 including access authorized pursuant to a warrant or a court order,
- 27 or to preclude access allowed pursuant to a voluntary agreement.

- 1 (e) Comply with any land use or resources use restrictions
- 2 established or relied on in connection with the corrective action
- 3 activities at the property.
- 4 (f) Not impede the effectiveness or integrity of any land use
- 5 or resource use restriction employed at the property in connection
- 6 with corrective action activities.
- 7 (2) A person's obligations under this section shall be based
- 8 upon the applicable RBSL or SSTL.
- 9 (3) A person that violates subsection (1) that is not
- 10 otherwise liable under this part for the release at the property is
- 11 liable for corrective action activity costs and natural resource
- 12 damages attributable to any exacerbation and any fines or penalties
- 13 imposed under this part resulting from the violation of subsection
- 14 (1) but is not liable for performance of additional corrective
- 15 action activities unless the person is otherwise liable under this
- 16 part for performance of additional corrective action activities.
- 17 The burden of proof in a dispute as to what constitutes

- 13 underground storage tank system, the owner or operator THAT IS

- 17 department does not relieve the owner or operator THAT IS LIABLE

- 15 exposed areas of belowground releases and prevent further migration
- 16 of the released substance into surrounding soils, groundwater, and
- 17 surface water.
- 18 (b) Continue to monitor and mitigate any additional immediate
- 19 fire and safety hazards posed by vapors or NAPL that have migrated
- 20 from the underground storage tank system excavation zone and
- 21 entered into subsurface structures.
- Sec. 21307a. (1) Following initiation of initial actions under
- 23 section 21307, the owner or operator THAT IS LIABLE UNDER SECTION
- 24 21323A shall complete the requirements of this part and submit
- 25 related reports or executive summaries detailed in this part to

- 17 (a) Results of initial actions taken under section 21307(2).
- 18 (b) Site information and site characterization results. The

- 11 (E) The locations of nearby buildings, roadways, paved areas,

- (vii) A description of how the release was discovered.
- 14 (viii) A list of regulated substances the underground storage
- 15 tank system contained when the release occurred.
- 16 (ix) A list of the regulated substances the underground storage
- 17 tank system contained in the past other than those listed in
- 18 subparagraph (viii).
- 19 (x) The location of nearby surface waters and wetlands.
- 20 (xi) The location of nearby underground sewers and utility
- 21 lines.
- 22 (xii) The component of the underground storage tank system from
- 23 which the release occurred (e.g., piping, underground storage tank,
- 24 overfill).
- 25 (xiii) Whether the underground storage tank system was emptied
- 26 to prevent further release.
- 27 (xiv) A description of what other steps were taken to prevent

- 1 further migration of the regulated substance into the soil or
- 2 groundwater.
- 3 (xv) Whether toxic or explosive vapors or migrating or mobile
- 4 NAPL was found and what steps were taken to evaluate those
- 5 conditions and the current levels of toxic or explosive vapors or

- 24 during the recovery operation and where this discharge will be
- 25 located.
- **26** (F) The type of treatment applied to, and the effluent quality
- 27 expected from, any discharge.

- 1 (G) The steps that have been or are being taken to obtain
- 2 necessary permits for any discharge.
- 3 (H) The quantity and disposition of the recovered NAPL.
- 4 (xix) Identification of any other contamination on the site not
- 5 resulting from the release and the source, if known.
- 6 (xx) An estimate of the horizontal and vertical extent of on-
- 7 site and off-site soil contamination exceeding the applicable RBSL
- 8 for tier I sites or the applicable SSTL for tier II or tier III
- 9 sites.
- 10 (xxi) The depth to groundwater.
- 11 (xxii) An identification of potential migration and exposure
- 12 pathways and receptors.
- 13 (xxiii) An estimate of the amount of soil in the vadose zone
- 14 that is contaminated.
- 15 (xxiv) If the on-site assessment indicates that off-site soil
- 16 or groundwater may be affected, report the steps that have been
- 17 taken or will be taken including an implementation schedule to
- 18 expeditiously secure access to off-site properties to complete the
- 19 delineation of the extent of the release if the contamination
- 20 exceeds the applicable RBSL or the applicable SSTL.
- 21 (xxv) Groundwater flow rate and direction.
- 22 (xxvi) Laboratory analytical data collected. The owner or
- 23 operator may elect to obtain groundwater samples utilizing a grab
- 24 sample technique for initial assessment and monitoring purposes
- 25 that do not represent initial delineation of the limit of
- 26 contamination or closure verification sampling.
- 27 (xxvii) The vertical distribution of contaminants that exceed

- 1 the applicable RBSL or applicable SSTL.
- 2 (c) Site classification under section 21314a.
- 3 (d) Tier I or tier II evaluation according to the RBCA
- 4 process.
- 5 (e) A work plan, including an implementation schedule for
- 6 conducting a final assessment report under section 21311a, to
- 7 determine the vertical and horizontal extent of the contamination
- 8 that exceeds the applicable RBSL or applicable SSTL as necessary
- 9 for preparation of the corrective action plan.
- 10 (2) If migrating or mobile NAPL is discovered at a site after
- 11 the submittal of an initial assessment report pursuant to
- 12 subsection (1), the owner or operator THAT IS LIABLE UNDER SECTION
- 13 21323A shall do both of the following:
- 14 (a) Perform initial actions identified in section 21307(2)(c).
- 15 (b) Submit to the department an amendment to the initial
- 16 assessment report within 30 days of discovery of the migrating or
- 17 mobile NAPL that describes response actions taken as a result of
- 18 the migrating or mobile NAPL discovery.
- 19 (3) The department shall not require any additional
- 20 information beyond that required under this section to be included
- 21 in an initial assessment report. The owner or operator THAT IS
- 22 LIABLE UNDER SECTION 21323A shall provide supporting documentation
- 23 to the data and conclusions of the initial assessment report upon
- 24 request by the department.
- Sec. 21309a. (1) If initial actions under section 21307 have
- 26 not resulted in completion of corrective action, an owner or
- 27 operator THAT IS LIABLE UNDER SECTION 21323A shall prepare a

- 1 corrective action plan to address contamination at the site.
- 2 Corrective action plans submitted as part of a final assessment
- 3 report shall use the process described in RBCA and shall be based
- 4 upon the site information and characterization results of the
- 5 initial assessment report.
- 6 (2) A corrective action plan shall include all of the
- 7 following:
- 8 (a) A description of the corrective action to be implemented,
- 9 including an explanation of how that action will meet the
- 10 requirements of the tier I, II, or III evaluation in the RBCA

- 18 (x) Other elements required by the department to determine the
- 19 adequacy of the monitoring plan. Department requests for
- 20 information pursuant to this subparagraph shall be limited to
- 21 factors not adequately addressed by information required under
- 22 subparagraphs (i) through (ix) and shall be accompanied by an
- 23 explanation of the need for the additional information.
- 24 (d) An explanation of any land use or resource use
- 25 restrictions, if the restrictions are required pursuant to section
- 26 21310a, including how those restrictions will be effective in
- 27 preventing or controlling unacceptable exposures.

- 1 (e) A schedule for implementation of the corrective action.
- 2 (f) If the corrective action plan includes the operation of a
- 3 mechanical soil or groundwater remediation system, or both, a
- 4 financial assurance mechanism to pay for monitoring, operation, and
- 5 maintenance necessary to assure the effectiveness and integrity of
- 6 the corrective action remediation system.
- 7 (g) If provisions for operation and maintenance, monitoring,
- 8 or financial assurance are included in the corrective action plan,
- 9 and those provisions are not complied with, the corrective action
- 10 plan is void from the time of lapse or violation until the lapse or
- 11 violation is corrected.
- 12 (3) If a corrective action plan prepared under this section

- 20 (d) Grant to the department and its designated representatives
- 21 the right to enter the property at reasonable times for the purpose
- 22 of determining and monitoring compliance with the corrective action
- 23 plan, including but not limited to the right to take samples,
- 24 inspect the operation of the corrective action measures, and
- 25 inspect records.
- 26 (e) Allow the state to enforce restrictions set forth in the
- 27 covenant by legal action in a court of appropriate jurisdiction.

- (f) Describe generally the uses of the property that are
 consistent with the corrective action plan.
- 3 (3) If the owner or operator THAT IS LIABLE UNDER SECTION
- 4 21323A determines that exposure to regulated substances may be
- 5 reliably restricted by a means other than a restrictive covenant
- 6 and that imposition of land use or resource use restrictions
- 7 through restrictive covenants is impractical, the owner or operator
- 8 THAT IS LIABLE UNDER SECTION 21323A may select a corrective action

- 6 Sec. 21311a. (1) Within 365 days after a release has been
- 7 discovered, an owner or operator THAT IS LIABLE UNDER SECTION

- 17 (2) The owner or operator THAT IS LIABLE UNDER SECTION 21323A
- 18 shall provide supporting documentation to the data and conclusions
- 19 of the final assessment report upon request by the department. The
- 20 department shall not require any additional information beyond that
- 21 required under this section to be included in its final assessment
- 22 report.
- 23 Sec. 21312a. (1) Upon completion of the corrective action, the
- 24 owner or operator THAT IS LIABLE UNDER SECTION 21323A shall
- 25 complete a closure report and submit the report to the department

- 12 (3) If the department conducts an audit, the results of the
- 13 audit shall approve, approve with conditions, or deny the final
- 14 assessment report or closure report or shall notify the owner or
- 15 operator THAT IS LIABLE UNDER SECTION 21323A that the report does
- 16 not contain sufficient information for the department to make a
- 17 decision. If the department's response is that the report does not
- 18 include sufficient information, the department shall identify the

- 23 report for approval, submit a petition for review of scientific or
- 24 technical disputes to the response activity review panel pursuant
- 25 to section 20114e and pay a fee in the amount of \$300.00 in lieu of
- 26 the \$3,500.00 fee set forth in section 20114e(7), or submit a
- 27 petition to the department's office of administrative hearings for

- 2 (8) Notwithstanding section 21312a, after conducting an audit
- 3 under this section, the department may issue a closure letter for

- 6 (9) The department shall only audit a report required under
- 7 this part 1 time. If the REPORT DOES NOT CONTAIN SUFFICIENT
- 8 INFORMATION FOR THE DEPARTMENT TO MAKE A DECISION OR THE
- 9 department's audit identifies deficiencies as described in
- 10 subsection (6), the department may audit a revised report IF
- 11 SUFFICIENT INFORMATION IS PROVIDED FOR THE DEPARTMENT TO MAKE A
- 12 DECISION OR, to evaluate whether the identified deficiencies have
- 13 been corrected, which shall be completed within 90 days of the
