## **HOUSE BILL No. 5690**

May 29, 2012, Introduced by Reps. Nesbitt and Tyler and referred to the Committee on Natural Resources, Tourism, and Outdoor Recreation.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 30103 (MCL 324.30103), as amended by 2009 PA 139.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 30103. (1) A permit is not required under this part for
  any of the following:
  - (a) Any fill or structure existing before April 1, 1966, in waters covered by former 1965 PA 291, and any fill or structures existing before January 9, 1973, in waters covered for the first time by former 1972 PA 346.
  - (b) A seasonal structure placed on bottomland to facilitate private noncommercial recreational use of the water if it does not

- 1 unreasonably interfere with the use of the water by others entitled
- 2 to use the water or interfere with water flow.
- 3 (c) Reasonable sanding of beaches to the existing water's edge
- 4 by a riparian owner.
- 5 (d) Construction or maintenance of a private agricultural
- 6 drain regardless of outlet.
- 7 (e) A waste collection or treatment facility that is ordered
- 8 to be constructed or is approved for construction by the
- 9 department.
- 10 (f) Construction and maintenance of minor drainage structures
- 11 and facilities which are identified by rule promulgated by the
- 12 department pursuant to section 30110. Before such a rule is
- 13 promulgated, the rule shall be approved by the majority of a
- 14 committee consisting of the director of the department, the
- 15 director of the department of agriculture AND RURAL DEVELOPMENT,

- 17 designated representatives. The rules shall be reviewed at least

- 19 (g) Maintenance and improvement of all drains legally

- 22 those legally established drains constituting mainstream portions
- 23 of certain natural watercourses identified in rules promulgated by

- 15 DIVER EXTRACTS WEEDS FROM A WATER BODY AND A VACUUM HOSE DRAWS THE
- 16 WEEDS INTO A BOAT.
- 17 (B) "WATER withdrawal" means the removal of water from its
- 18 source for any purpose.
