

# SENATE BILL No. 1191

June 14, 2012, Introduced by Senator GLEASON and referred to the Committee on Outdoor Recreation and Tourism.

A bill to amend 1994 PA 451, entitled  
"Natural resources and environmental protection act,"  
by amending section 43526 (MCL 324.43526), as amended by 1996 PA  
585.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 43526. (1) ~~A person~~**AN INDIVIDUAL** shall not hunt deer  
2 during the firearm deer season without purchasing a firearm deer  
3 license. The fee for a resident firearm deer license is ~~\$13.00.~~  
4 ~~Beginning in 1999, the fee for a resident firearm deer license is~~  
5 ~~\$14.00. Beginning in 2001, the fee for a resident firearm deer~~  
6 ~~license is \$15.00.~~ The fee for a nonresident firearm deer license  
7 is \$120.00. ~~Beginning in 1999, the fee for a nonresident firearm~~  
8 ~~deer license is \$129.00. Beginning in 2001, the fee for a~~  
9 ~~nonresident firearm deer license is \$138.00.~~ Where authorized by

1 the department, a resident or nonresident may purchase a second  
2 firearm deer license in 1 season for the fee assessed under this  
3 subsection for the firearm deer license for which that ~~person~~  
4 **INDIVIDUAL** is eligible. However, a senior license discount is not  
5 available for the purchase of a second firearm deer license. The  
6 department may issue orders under part 401 designating the kind of  
7 deer that may be taken and the geographic area in which any license  
8 issued under this section is valid, when advisable in managing  
9 deer.

10 (2) The department may issue a kill tag with or as part of  
11 each deer license. The kill tag shall bear the license number. The  
12 kill tag may also include space for other pertinent information  
13 required by the department. The kill tag, if issued, is part of the  
14 license.

15 (3) The department shall charge a nonrefundable application  
16 fee not to exceed \$4.00 for each ~~person~~**INDIVIDUAL** who applies for  
17 an antlerless deer license. Except as otherwise provided in section  
18 43521, the fee for a resident antlerless deer license is ~~\$13.00.~~  
19 ~~Beginning in 1999, the fee for a resident antlerless deer license~~  
20 ~~is \$14.00. Beginning in 2001, the fee for a resident antlerless~~  
21 ~~deer license is \$15.00.~~ The fee for a nonresident antlerless deer  
22 license is \$120.00. ~~Beginning in 1999, the fee for a nonresident~~  
23 ~~antlerless deer license is \$129.00. Beginning in 2001, the fee for~~  
24 ~~a nonresident antlerless deer license is \$138.00.~~

25 (4) **A MINOR CHILD HUNTING DEER DURING THE MUZZLE-LOADING DEER**  
26 **SEASON MAY USE EITHER OF THE FOLLOWING FIREARMS:**

27 (A) **A SINGLE-SHOT SHOTGUN WITH A SMOOTH OR RIFLED BARREL.**

1 (B) A MUZZLE-LOADING RIFLE LOADED WITH BLACK POWDER OR A  
2 COMMERCIALY MANUFACTURED BLACK POWDER SUBSTITUTE.
