by amending section 167d (MCL 750.167d), as added by 2006 PA 148.

Sec. 167d. (1) A person shall not do any of the following

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

2 within 500 feet of a building or other location where a funeral, 3 memorial service, or viewing of a deceased person is being 4 conducted or within 500 feet of a funeral procession or burial: 5 (a) Make loud and raucous noise and continue to do so after 6 being asked to stop. 7 (A) (b) Make any statement or gesture OR ENGAGE IN ANY CONDUCT 8 that would make a reasonable person ATTENDING THAT FUNERAL, MEMORIAL SERVICE, VIEWING, PROCESSION, OR BURIAL under the 10 circumstances TO feel intimidated, threatened, or harassed. 11 Engage in any other conduct that the person knows or

- 2 the funeral, memorial service, viewing of the deceased person,
- 3 funeral procession, or burial.
- 4 (B) MAKE ANY STATEMENT OR GESTURE OR ENGAGE IN ANY CONDUCT
- 5 INTENDED TO INCITE OR PRODUCE AN IMMINENT BREACH OF THE PEACE AMONG
- 6 THOSE ATTENDING THAT FUNERAL, MEMORIAL SERVICE, VIEWING, OR BURIAL
- 7 OR TRAVELING IN THAT PROCESSION.
- 8 (C) MAKE ANY STATEMENT OR GESTURE OR ENGAGE IN ANY CONDUCT
- 9 INTENDED TO DISRUPT THE FUNERAL, MEMORIAL SERVICE, VIEWING,
- 10 PROCESSION, OR BURIAL.
- 11 (2) A PERSON SHALL NOT INTENTIONALLY OBSTRUCT, HINDER, IMPEDE,
- 12 OR BLOCK ANOTHER PERSON'S ENTRY TO OR EXIT FROM A FUNERAL, MEMORIAL
- 13 SERVICE, VIEWING OF A DECEASED PERSON, FUNERAL PROCESSION, OR
- 14 BURIAL. THIS SUBSECTION DOES NOT APPLY TO A PERSON CONDUCTING OR
- 15 ASSISTING IN THE CONDUCTING OF THE FUNERAL, MEMORIAL SERVICE,
- 16 VIEWING, FUNERAL PROCESSION, OR BURIAL.
- 17 (3) (2)—A person who violates subsection (1)—THIS SECTION is a
- 18 disorderly person and is guilty of a felony punishable as provided
- 19 under section 168.
