## **HOUSE BILL No. 4442**

A bill to amend 1969 PA 306, entitled "Administrative procedures act of 1969,"

by amending section 7 (MCL 24.207), as amended by 2000 PA 216.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 7. "Rule" means an agency regulation, statement,
  standard, policy, ruling, or instruction of general applicability
  that implements or applies law enforced or administered by the
  agency, or that prescribes the organization, procedure, or practice
  of the agency, including the amendment, suspension, or rescission
  of the law enforced or administered by the agency. Rule does not
  include any of the following:
  - (a) A resolution or order of the state administrative board.

- 13 memorandum, directive, or communication that does not affect the
- 14 rights of, or procedures and practices available to, the public.
- 15 (h) A form with instructions, an interpretive statement, a
- 16 guideline, an informational pamphlet, or other material that in
- 17 itself does not have the force and effect of law but is merely
- 18 explanatory.
- 19 (i) A declaratory ruling or other disposition of a particular
- 20 matter as applied to a specific set of facts involved.
- 21 (j) A decision by an agency to exercise or not to exercise a
- 22 permissive statutory power, although private rights or interests
- 23 are affected.
- 24 (k) Unless another statute requires a rule to be promulgated
- 25 under this act, a rule or policy that only concerns the inmates of
- 26 a state correctional facility and does not directly affect other
- 27 members of the public, except that a rule that only concerns

- 16 COORDINATING COUNCIL UNDER FORMER SECTION 22217 OF THE PUBLIC
- 17 HEALTH CODE, 1978 PA 368:
- 18 (i) The designation, deletion, or revision of covered medical
- 19 equipment and covered clinical services.
- 20 (ii) Certificate of need review standards.
- 21 (iii) Data reporting requirements and criteria for determining
- 22 health facility viability.
- (iv) Standards used by the department of community health in
- 24 designating a regional certificate of need review agency.
- 25 (v) The modification of the 100 licensed bed limitation for
- 26 short-term nursing care programs set forth in section 22210 of the
- 27 public health code, 1978 PA 368, MCL 333.22210.

- 1 (n) A policy developed by the family independence agency under
- 2 section 6(3) of the social welfare act, 1939 PA 250-280, MCL 400.6,
- 3 setting income and asset limits, types of income and assets to be
- 4 considered for eligibility, and payment standards for
- 5 administration of assistance programs under that act.
- 6 (o) A policy developed by the family independence agency under
- 7 section 6(4) of the social welfare act, 1939 PA 280, MCL 400.6, to
- 8 implement requirements that are mandated by federal statute or
- 9 regulations as a condition of receipt of federal funds.
- 10 (p) The provisions of an agency's contract with a public or
- 11 private entity including, but not limited to, the provisions of an
- 12 agency's standard form contract.

- 15 act, 1939 PA 280, MCL 400.111a, to implement policies and
- 16 procedures necessary to operate its health care programs in
- 17 accordance with an approved state plan or in compliance with state
- 18 statute.
