## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1535B. IF THE SUPERINTENDENT OF PUBLIC INSTRUCTION HAS
- 2 INFORMATION THAT A PERSON WHO HOLDS A TEACHING CERTIFICATE THAT IS
- 3 VALID IN THIS STATE HAS ENGAGED OR PARTICIPATED IN A STRIKE
- 4 PROHIBITED BY SECTION 2 OF 1947 PA 336, MCL 423.202, THE
- 5 SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL DO ALL OF THE FOLLOWING:
- 6 (A) WITHIN 10 DAYS AFTER THE INCEPTION OF THE STRIKE OR AFTER
- 7 RECEIVING INFORMATION THAT THE PERSON HAS ENGAGED OR PARTICIPATED
- 8 IN A STRIKE, NOTIFY THE PERSON THAT HIS OR HER TEACHING CERTIFICATE
  - MAY BE SUSPENDED FOR A PERIOD OF AT LEAST 2 YEARS, OR REVOKED, FOR

- 11 RECEIVING THE REQUEST FOR A HEARING. IF THE SUPERINTENDENT OF
- 12 PUBLIC INSTRUCTION DETERMINES AS A RESULT OF THE HEARING THAT THE
- 13 PERSON HAS ENGAGED OR PARTICIPATED IN A STRIKE IN VIOLATION OF
- 14 SECTION 2 OF 1947 PA 336, MCL 423.202, THE SUPERINTENDENT OF PUBLIC
- 15 INSTRUCTION SHALL SUSPEND THE PERSON'S TEACHING CERTIFICATE FOR AT
- 16 LEAST 2 YEARS AND MAY PERMANENTLY REVOKE THE PERSON'S TEACHING
- 17 CERTIFICATE, DEPENDING ON HIS OR HER DETERMINATION AS TO THE
- 18 SEVERITY OF THE OFFENSE.
