A bill to amend 1994 PA 451, entitled

"Natural resources and environmental protection act,"

by amending sections 40103 and 41102 (MCL 324.40103 and 324.41102), as amended by 2000 PA 191.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 22 (7) "Protected" or "protected animal" means an animal or kind
- 23 of animal that is designated by the department as an animal that
- 24 shall not be taken.
- 25 (8) "Residence" means a permanent building serving as a
- 26 temporary or permanent home. Residence may include a cottage,
- 27 cabin, or mobile home, but does not include a structure designed

- 1 primarily for taking game, a tree blind, a tent, a recreational or
- 2 other vehicle, or a camper.
- 3 Sec. 41102. (1) The department, in accordance with this part,
- 4 may regulate the taking or killing of all fish, game and fur-
- 5 bearing animals, and game birds protected by the laws of this
- 6 state, and may suspend or abridge the open season provided by law
- 7 for the taking or killing of such fish, animals, or game birds in
- 8 any designated waters or area of this state, if in the opinion of
- 9 the department it is necessary to assist in the increased or better
- 10 protection of the fish, game or fur-bearing animals, or game birds,
- 11 or any particular kinds or species of fish, game or fur-bearing
- 12 animals, or game birds, which may in the opinion of the department
- 13 be threatened from any cause or causes with depletion or
- 14 extermination in the waters or area. The department may promulgate
- 15 rules and orders necessary to implement this part after a thorough
- 16 investigation has been made by the department.

- 22 (B) SPORTING SWINE LOCATED ON A SPORTING SWINE LIVESTOCK
- 23 OPERATION PERMITTED UNDER THE SPORTING SWINE MARKETING ACT.
