HOUSE BILL No. 4505

March 24, 2011, Introduced by Reps. Tyler, McBroom, Huuki, Horn, Crawford, Bumstead, McMillin, Opsommer and Shirkey and referred to the Committee on Agriculture.

A bill to amend 2000 PA 190, entitled "Privately owned cervidae producers marketing act," by amending section 5 (MCL 287.955), as amended by 2006 PA 561.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 5. (1) A person shall not possess cervidae or engage in a

cervidae livestock operation unless he or she obtains from the
department a cervidae livestock facility registration or unless
otherwise exempt by rule or law. If the activity in which the
cervidae livestock facility is engaged is required to be regulated
under any other act, registration REGISTRATION under this act does
not exempt the person or cervidae livestock facility from
requirements imposed under any local, state, or federal regulation
LAW. Zoos accredited under the American zoological association or

- 1 other accreditations or standards determined appropriate by and
- 2 acceptable to the department are exempt from this act. THE DIRECTOR
- 3 MAY ALLOW A PERSON REGISTERED UNDER THIS ACT TO OBTAIN A
- 4 REGISTRATION UNDER THE SPORTING SWINE MARKETING ACT.
- 5 (2) A person registered under this act shall keep and maintain
- 6 records of production, purchases, or imports in order NECESSARY to
- 7 establish proof of ownership and shall keep any other records
- 8 required under standards incorporated by reference under section 6.
- 9 A person transporting cervidae species shall produce documentation
- 10 that contains the origin of shipment, registration or permit copies
- 11 or documentation, documentation demonstrating shipping destination,
- 12 and any other proof that may be required under the animal industry
- 13 act, 1988 PA 466, MCL 287.701 to 287.745, upon demand REQUEST of
- 14 the director or a law enforcement officer.
- 15 (3) Until July 1, 2008, a cervidae livestock facility
- 16 registered prior to the effective date of the amendatory act that
- 17 added this subsection must comply with the facility standards
- 18 contained in "Operational Standards for Registered Privately Owned
- 19 Cervid Facilities", published by the Michigan department of
- 20 agriculture, (May 2000). A cervidae livestock facility in existence
- 21 on or before the effective date of the amendatory act that added
- 22 this subsection shall be in compliance COMPLY with the facility
- 23 standards by July 1, 2008, which are contained in "Operational
- 24 Standards for Registered Privately Owned Cervidae Facilities"
- 25 published by the Michigan department of natural resources, (revised
- 26 December 2005), adopted by the Michigan commission of agriculture
- 27 on January 9, 2006, and adopted by the natural resources commission
