- 1 SEC. 14K. (1) A RECIPIENT OF FOOD ASSISTANCE OR CASH
- 2 ASSISTANCE BENEFITS SHALL HAVE HIS OR HER IMAGE AND SIGNATURE
- 3 CAPTURED OR REPRODUCED UPON ISSUANCE OF A MICHIGAN BRIDGE CARD. THE
- 4 DEPARTMENT SHALL ACQUIRE EQUIPMENT PURCHASED OR LEASED UNDER THIS
- 5 SECTION UNDER STANDARD PURCHASING PROCEDURES OF THE DEPARTMENT OF
- 6 TECHNOLOGY, MANAGEMENT, AND BUDGET BASED ON STANDARDS AND
- 7 SPECIFICATIONS ESTABLISHED BY THE DEPARTMENT. A DIGITAL
- 8 PHOTOGRAPHIC IMAGE AND SIGNATURE CAPTURED UNDER THIS SECTION SHALL
- 9 APPEAR ON THE RECIPIENT'S MICHIGAN BRIDGE CARD. IF MORE THAN 1
- 10 INDIVIDUAL IS AUTHORIZED BY THE DEPARTMENT TO USE THE MICHIGAN
