## **HOUSE BILL No. 4826**

June 28, 2011, Introduced by Reps. Foster, Forlini, Pettalia, Hughes, Nesbitt, Haveman, Irwin, Lund, Walsh, Liss, Potvin, Pscholka, Rutledge, O'Brien, Lyons, Franz and Tyler and referred to the Committee on Natural Resources, Tourism, and Outdoor Recreation.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by adding sections 41409, 41413, and
41415; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 41409. (1) WITHIN 240 DAYS AFTER THE EFFECTIVE DATE OF
  - THE AMENDATORY ACT THAT ADDED THIS SECTION, THE COUNCIL SHALL
- 3 SUBMIT A REPORT WITH RECOMMENDATIONS FOR LEGISLATION OR RULES TO
- 4 PREVENT THE INTRODUCTION AND SPREAD OF AIS THROUGH TRADE, INCLUDING
- 5 THE AQUARIUM, BAIT, PET, WATER GARDEN, HORTICULTURE, AQUACULTURE,
- 6 AND SHIPPING TRADES. THE COUNCIL SHALL SUBMIT THE REPORT TO THE
- GOVERNOR, THE SENATE MAJORITY LEADER, THE SPEAKER OF THE HOUSE OF

- 1 REPRESENTATIVES, AND THE STANDING COMMITTEES OF THE SENATE AND
- 2 HOUSE WITH PRIMARY RESPONSIBILITY FOR NATURAL RESOURCES,
- 3 CONSERVATION, AGRICULTURE, AND COMMERCE. IN PREPARING THE REPORT,
- 4 THE COUNCIL SHALL REVIEW THE AIS LAWS OF THIS STATE AND OTHER
- 5 JURISDICTIONS, INCLUDING THE OTHER GREAT LAKES STATES.
- 6 (2) IN THE REPORT UNDER SUBSECTION (1), THE COUNCIL SHALL MAKE
- 7 RECOMMENDATIONS ON ALL OF THE FOLLOWING:
- 8 (A) RISK ASSESSMENT PROCESSES TO SCREEN AQUATIC SPECIES
- 9 PROPOSED FOR TRADE AND TO SCREEN PATHWAYS OF INTRODUCTION AND
- 10 SPREAD. THE RISK ASSESSMENT PROCESSES SHALL CONSIDER POTENTIAL NET
- 11 HARM TO PUBLIC HEALTH AND SAFETY, THE ENVIRONMENT AND NATURAL
- 12 RESOURCES, AND THE ECONOMY. THE PROCESSES SHALL PLACE THE BURDEN TO
- 13 DEMONSTRATE THE HARMLESSNESS OF AN AQUATIC SPECIES OR PATHWAY ON
- 14 THE IMPORTER OR OTHER PERSON RESPONSIBLE FOR INTRODUCTION OR
- 15 DISTRIBUTION. THE RISK ASSESSMENT PROCESS FOR SPECIES SHALL
- 16 CLASSIFY SPECIES INTO 3 LISTS: "PROHIBITED", "PERMITTED", AND
- 17 "RESTRICTED".
- 18 (B) HARMONIZING FEDERAL AND STATE LAW SO THAT AQUATIC SPECIES
- 19 ON FEDERAL LISTS OF EITHER PROHIBITED OR PERMITTED SPECIES OF
- 20 PLANTS AND ANIMALS ARE PLACED ON THIS STATE'S LISTS.
- 21 (C) ESTABLISHING A PROGRAM FOR AQUATIC SPECIES IN TRADE TO
- 22 CERTIFY THAT THE ORGANISMS ARE FREE OF DISEASE, INSECT PESTS, AND
- 23 INCIDENTAL CONTAMINATION BY OTHER SPECIES.
- 24 (D) AN EDUCATION PROGRAM ON SAFE-USAGE PRACTICES DIRECTED TO
- 25 BOTH BUYERS AND SELLERS OF AQUATIC SPECIES IN TRADE.
- 26 (E) CONNECTING REGULATIONS AND EDUCATION ON AQUATIC SPECIES IN
- 27 TRADE TO THE PROTECTION OF THIS STATE'S NATURAL RESOURCES AS A

- 13 SEC. 41413. TO FACILITATE COORDINATION AND MINIMIZE
- 14 DUPLICATION IN FULFILLING ITS DUTIES, THE COUNCIL SHALL DO ALL OF
- 15 THE FOLLOWING:
- 16 (A) CONSIDER RELEVANT RECOMMENDATIONS AND REPORTS BY OTHER
- 17 STATE, REGIONAL, FEDERAL, PROVINCIAL, CANADIAN, AND INTERNATIONAL
- 18 BODIES AND COLLABORATIONS.
- 19 (B) REGULARLY CONSULT WITH THE GREAT LAKES COMMISSION AND THE
- 20 DEPARTMENT OF ENVIRONMENTAL QUALITY, INCLUDING THE OFFICE OF THE
- 21 GREAT LAKES.
- 22 SEC. 41415. THIS PART IS REPEALED EFFECTIVE 4 YEARS AFTER THE
- 23 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
