- 1 SEC. 42. (1) A PERSON SHALL NOT DIRECTLY OR INDIRECTLY CAUSE
- 2 TO BE MADE, PUBLISHED, DISSEMINATED, CIRCULATED, OR PLACED BEFORE
- 3 OR COMMUNICATED TO THE PUBLIC, IN A NEWSPAPER OR BY RADIO
- 4 BROADCAST, TELEVISION, INTERNET, OR OTHER MODE OF COMMUNICATION OR
- 5 PUBLICATION OR IN THE FORM OF A BOOK, NOTICE, HANDBILL, POSTER,
- 6 BILL, CIRCULAR, OR PAMPHLET, EITHER OF THE FOLLOWING:
- 7 (A) AN ADVERTISEMENT FOR SERVICES AS A PRIMARY CAREGIVER UNDER
- 8 THE MICHIGAN MEDICAL MARIHUANA ACT, 2008 IL 1, MCL 333.26421 TO

 - (B) AN OFFER TO SELL, TRANSFER, OR MAKE AVAILABLE MARIHUANA.
