HOUSE BILL No. 4870

July 27, 2011, Introduced by Rep. LeBlanc and referred to the Committee on Redistricting and Elections.

A bill to amend 1893 PA 206, entitled "The general property tax act,"

by amending section 24f (MCL 211.24f), as amended by 2000 PA 244.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 24f. (1) If a taxing unit submits a proposal on the question of authorizing the issuance of bonds, imposing a new millage, or increasing or renewing an existing millage, except an ad valorem special assessment millage for police or fire protection under 1951 PA 33, MCL 41.801 to 41.813, the ballot shall fully disclose each local unit of government to which the revenue from that millage will be disbursed. As used in this subsection:
 - (a) "Local unit of government" means a county, city, village, township, school district, intermediate school district, community college district, public library, or local authority created under

- 27 expired and the taxing unit submits to the electors the
