- 1 SEC. 2170. (1) EXCEPT AS PROVIDED UNDER SUBSECTION (2), AN
- 2 AGENT OF A LABOR ORGANIZATION, DURING OR AFTER TERMINATION OF AN
- 3 AGENCY OR REPRESENTATIVE RELATIONSHIP WITH A BARGAINING UNIT
- MEMBER, SHALL NOT BE COMPELLED TO DISCLOSE, IN A COURT OR
- 5 ADMINISTRATIVE ACTION, ARBITRATION, OR PROCEEDING, WHETHER CIVIL OR
- 6 CRIMINAL, ANY INFORMATION THE AGENT ACQUIRED IN THE COURSE OF HIS
- 7 OR HER PROFESSIONAL DUTIES OR WHILE ACTING IN HIS OR HER
- 8 REPRESENTATIVE CAPACITY.
