## **HOUSE BILL No. 5000**

September 21, 2011, Introduced by Reps. Genetski, Haveman, Lyons, Gilbert, Glardon, Price, Callton, Tyler, Yonker, Rogers, Pettalia, Franz, Heise, Shirkey, Somerville, Pscholka, MacGregor and Kurtz and referred to the Committee on Government Operations.

A bill to establish a state university system restructuring commission; to prescribe the powers and duties of the commission; and to prescribe the powers and duties of certain state governmental officers and entities.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the "state
  university system restructuring commission act".
- 3 Sec. 2. As used in this act:
  - (a) "Commission" means the state university system restructuring commission established in section 3.
  - (b) "Department" means the department of technology, management, and budget.
- 8 (c) "State university" means a university described in section 9 4, 5, or 6 of article VIII of the state constitution of 1963.

- 15 officio and nonvoting members of the commission.

- 18 removed in the manner provided for by law for removal of public
- 19 officers. A vacancy shall be filled for the unexpired term in the

- 21 governor shall designate 1 of the appointed members as chairperson
- 22 of the commission.
- 23 (3) The commission shall conduct its activities in compliance
- 24 with the open meetings act, 1976 PA 267, MCL 15.261 to 15.275. The
- 25 commission shall give public notice of the time, date, and place of

- 6 Sec. 4. (1) The commission shall analyze the operation and
- 7 governance structure of the state universities; analyze the
- 8 advantages and disadvantages of the constitutional requirement for
- 9 separate governing boards for each state university; review the
- 10 higher education governance structures utilized by other states;
- 11 and make any recommendations to the governor and the legislature it
- 12 considers appropriate concerning the restructuring of the manner in
- 13 which the state universities are governed in this state.
- 14 (2) The commission shall annually report to the governor and
- 15 to the legislature concerning its recommendations and other actions
- 16 under subsection (1).
