A bill to amend 1954 PA 116, entitled

"Michigan election law,"

by amending section 509q (MCL 168.509q), as amended by 2005 PA 71, and by adding section 496a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 496A. (1) VOTER REGISTRATION APPLICATIONS SHALL CONTAIN A
- 2 STATEMENT REQUIRING AN APPLICANT TO SUBMIT SATISFACTORY EVIDENCE OF
- 3 UNITED STATES CITIZENSHIP WITH HIS OR HER APPLICATION AND STATING
- 4 THAT THE APPLICATION SHALL BE REJECTED IF SATISFACTORY EVIDENCE OF
- 5 UNITED STATES CITIZENSHIP IS NOT PROVIDED.
 - (2) A PERSON PROCESSING VOTER REGISTRATION APPLICATIONS AT A
- 7 DEPARTMENT OF STATE OFFICE, A DESIGNATED VOTER REGISTRATION AGENCY,
- 8 OR A COUNTY, CITY, TOWNSHIP, OR VILLAGE CLERK'S OFFICE SHALL REJECT
 - A VOTER REGISTRATION APPLICATION THAT IS NOT ACCOMPANIED BY

- 12 PERSON PROCESSING THE VOTER REGISTRATION APPLICATION.
- 13 (C) THE APPLICANT'S UNITED STATES PASSPORT.
- 14 (D) A LEGIBLE PHOTOCOPY OF THE PERTINENT PAGES OF THE
- 15 APPLICANT'S UNITED STATES PASSPORT IDENTIFYING THE APPLICANT AND
- 16 THE APPLICANT'S PASSPORT NUMBER.
- 17 (E) THE APPLICANT'S UNITED STATES NATURALIZATION DOCUMENTS OR
- 18 THE NUMBER OF THE CERTIFICATE OF NATURALIZATION. IF ONLY THE NUMBER
- 19 OF THE CERTIFICATE OF NATURALIZATION IS PROVIDED, THE APPLICANT
- 20 SHALL NOT BE INCLUDED IN THE REGISTRATION ROLLS AND OUALIFIED VOTER
- 21 FILE UNTIL THE PERSON PROCESSING THE APPLICATION VERIFIES THE
- 22 NUMBER OF THE CERTIFICATE OF NATURALIZATION WITH THE UNITED STATES
- 23 IMMIGRATION AND NATURALIZATION SERVICE.
- 24 (F) OTHER DOCUMENTS OR METHODS OF PROOF THAT ARE USED TO
- 25 ESTABLISH UNITED STATES CITIZENSHIP PURSUANT TO THE IMMIGRATION
- 26 REFORM AND CONTROL ACT OF 1986, PUBLIC LAW 99-603, 100 STAT. 3359.
- 27 (G) THE APPLICANT'S BUREAU OF INDIAN AFFAIRS CARD NUMBER,

- 1 TRIBAL TREATY CARD NUMBER, OR TRIBAL ENROLLMENT NUMBER.
- 2 (3) FOR PURPOSES OF THIS SECTION, PROOF OF VOTER REGISTRATION
- 3 FROM ANOTHER STATE IS NOT SATISFACTORY EVIDENCE OF UNITED STATES
- 4 CITIZENSHIP.
- 5 (4) NOTWITHSTANDING SUBSECTION (2), A PERSON WHO IS REGISTERED
- 6 TO VOTE IN THIS STATE ON THE EFFECTIVE DATE OF THE AMENDATORY ACT
- 7 THAT ADDED THIS SECTION SHALL NOT BE REQUIRED TO SUBMIT EVIDENCE OF
- 8 UNITED STATES CITIZENSHIP UNLESS THE PERSON MOVES HIS OR HER
- 9 RESIDENCE TO ANOTHER CITY, TOWNSHIP, OR VILLAGE.
- 10 (5) AFTER A PERSON SUBMITS SATISFACTORY EVIDENCE OF
- 11 CITIZENSHIP, THE CITY, TOWNSHIP, OR VILLAGE CLERK SHALL ADD THIS
- 12 INFORMATION TO THE QUALIFIED VOTER FILE. THE CITY, TOWNSHIP, OR
- 13 VILLAGE CLERK MAY DESTROY ALL DOCUMENTS SUBMITTED AS EVIDENCE OF
- 14 UNITED STATES CITIZENSHIP NOT LESS THAN 2 YEARS AFTER THE DATE OF
- 15 SUBMISSION.
- 16 Sec. 509q. The qualified voter file shall contain all of the
- 17 following information for each qualified voter:
- 18 (a) The name; residence address including house number and
- 19 street name or rural route and box number, and the apartment
- 20 number, if any; city; state; zip code; and date of birth.
- 21 (b) The driver's license number or state personal
- 22 identification card number or similar number issued by a designated
- 23 voter registration agency.
- (c) Jurisdictional information including county and city or
- 25 township; village, if any; and school district.
- (d) Precinct numbers and ward numbers, if any.
- 27 (e) Any other information that the secretary of state

- 5 (g) The most recent digitized signature of an elector if

- 9 pursuant to section 307 of the Michigan vehicle code, 1949 PA 300,
