

HOUSE BILL No. 5305

January 26, 2012, Introduced by Rep. Lori and referred to the Committee on Transportation.

A bill to amend 1951 PA 51, entitled

"An act to provide for the classification of all public roads, streets, and highways in this state, and for the revision of that classification and for additions to and deletions from each classification; to set up and establish the Michigan transportation fund; to provide for the deposits in the Michigan transportation fund of specific taxes on motor vehicles and motor vehicle fuels; to provide for the allocation of funds from the Michigan transportation fund and the use and administration of the fund for transportation purposes; to promote safe and efficient travel for motor vehicle drivers, bicyclists, pedestrians, and other legal users of roads, streets, and highways; to set up and establish the truck safety fund; to provide for the allocation of funds from the truck safety fund and administration of the fund for truck safety purposes; to set up and establish the Michigan truck safety commission; to establish certain standards for road contracts for certain businesses; to provide for the continuing review of transportation needs within the state; to authorize the state transportation commission, counties, cities, and villages to borrow money, issue bonds, and make pledges of funds for transportation purposes; to authorize counties to advance funds for the payment of deficiencies necessary for the payment of bonds issued under this act; to provide for the limitations, payment, retirement, and security of the bonds and pledges; to provide for appropriations and tax levies by counties and townships for county roads; to authorize contributions by townships for county roads; to provide for the establishment and administration of the state trunk line

fund, local bridge fund, comprehensive transportation fund, and certain other funds; to provide for the deposits in the state trunk line fund, critical bridge fund, comprehensive transportation fund, and certain other funds of money raised by specific taxes and fees; to provide for definitions of public transportation functions and criteria; to define the purposes for which Michigan transportation funds may be allocated; to provide for Michigan transportation fund grants; to provide for review and approval of transportation programs; to provide for submission of annual legislative requests and reports; to provide for the establishment and functions of certain advisory entities; to provide for conditions for grants; to provide for the issuance of bonds and notes for transportation purposes; to provide for the powers and duties of certain state and local agencies and officials; to provide for the making of loans for transportation purposes by the state transportation department and for the receipt and repayment by local units and agencies of those loans from certain specified sources; and to repeal acts and parts of acts,"

by amending sections 11 and 11c (MCL 247.661 and 247.661c), section 11 as amended by 2002 PA 639 and section 11c as amended by 2002 PA 498.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 11. (1) A fund to be known as the state trunk line fund
2 is established and shall be set up and maintained in the state
3 treasury as a separate fund. The money deposited in the state trunk
4 line fund is appropriated to the ~~state transportation~~ department
5 for the following purposes in the following order of priority:

6 (a) For the payment, but only from money restricted as to use
7 by section 9 of article IX of the state constitution of 1963, of
8 bonds, notes, or other obligations in the following order of
9 priority:

10 (i) For the payment of contributions **PLEDGED BEFORE JULY 18,**
11 **1979 AND** required to be made by the state highway commission or the
12 state transportation commission under contracts entered into before
13 July 18, 1979, under 1941 PA 205, MCL 252.51 to 252.64, ~~which~~
14 ~~contributions have been pledged before July 18, 1979, for the~~

1 payment of the principal and interest on bonds issued under 1941 PA
 2 205, MCL 252.51 to 252.64, for the payment of which a sufficient
 3 sum is irrevocably appropriated.

4 (ii) For the payment of the principal and interest upon bonds
 5 designated "State of Michigan, State Highway Commissioner, Highway
 6 Construction Bonds, Series I", dated September 1, 1956, in the
 7 aggregate principal amount of \$25,000,000.00, issued pursuant to
 8 former 1955 PA 87 and the resolution of the state administrative
 9 board adopted August 6, 1956, for the payment of which a sufficient
 10 sum is irrevocably appropriated.

11 (iii) For the payment of the principal and interest on bonds
 12 issued under section 18b for transportation purposes other than
 13 comprehensive transportation purposes as defined by law and the
 14 payment of contributions ~~of~~ **PLEGDED TO THE PAYMENT OF PRINCIPAL AND**
 15 **INTEREST ON BONDS ISSUED UNDER SECTION 18D AND CONTRACTS ENTERED**
 16 **INTO UNDER SECTION 18D BY** the state highway commission or state
 17 transportation commission to be made pursuant to contracts entered
 18 into under section 18d. ~~, which contributions are pledged to the~~
 19 ~~payment of principal and interest on bonds issued under the~~
 20 ~~authorization of section 18d and contracts executed pursuant to~~
 21 ~~that section.~~ A sufficient portion of the fund is irrevocably
 22 appropriated to pay, when due, the principal and interest on bonds
 23 or notes issued under section 18b for purposes other than
 24 comprehensive transportation purposes as defined by law, and to pay
 25 the annual contributions of the state highway commission and the
 26 state transportation commission ~~as~~ **THAT** are pledged for the payment
 27 of bonds issued pursuant to contracts authorized by section 18d.

1 (b) For the transfer of funds appropriated pursuant to section
2 ~~10(1)(g)~~ **10(1)(H)** to the transportation economic development fund,
3 but the transfer shall be reduced each fiscal year by the amount of
4 debt service to be paid in that year from the state trunk line fund
5 for bonds, notes, or other obligations issued to fund projects of
6 the transportation economic development fund, which ~~amount~~ shall be
7 certified by the department.

8 (c) For the transfer of funds appropriated pursuant to section
9 10(1)(a) to the railroad grade crossing account in the state trunk
10 line fund for expenditure for rail grade crossing improvement
11 purposes at rail grade crossings on public roads and streets under
12 the jurisdiction of ~~the~~ **THIS** state, counties, cities, or villages.
13 Projects shall be selected for funding in accordance with the
14 following:

15 (i) Not more than 50% or less than 30% of these funds and
16 matched federal funds shall be expended for state trunk line
17 projects.

18 (ii) In prioritizing projects for these funds, in whole or in
19 part, the department shall consider train and vehicular traffic
20 volumes, accident history, traffic control device improvement
21 needs, and the availability of funding.

22 (iii) Consistent with the other requirements for these funds,
23 the first priority for funds deposited pursuant to this subdivision
24 for rail grade crossing improvements and retirement shall be to
25 match federal funds from the railroad-highway grade crossing
26 improvement program or other comparable federal programs if a match
27 is required under federal law.

1 (iv) If the department and the road authority with jurisdiction
2 over the crossing formally agree that the grade crossing should be
3 eliminated by permanent closing of the public road or street, the
4 physical removal of the crossing, roadway within railroad rights of
5 way, and street termination treatment will be negotiated between
6 the road authority and railroad company. The funds provided to the
7 road authority as a result of the crossing closure will be credited
8 to its account representing the same road or street system on which
9 the crossing is located and shall be used for any transportation
10 purpose within that road authority's jurisdiction.

11 (d) For the total operating expenses of the state trunk line
12 fund for each fiscal year as appropriated by the legislature.

13 (e) For the preservation of state trunk line highways and
14 bridges.

15 (f) For the opening, widening, improving, construction, and
16 reconstruction of state trunk line highways and bridges, including
17 the acquisition of necessary rights of way and the work incidental
18 to that opening, widening, improving, construction, or
19 reconstruction. Those sums in the state trunk line fund not
20 otherwise appropriated, distributed, determined, or set aside by
21 law shall be used for the construction or reconstruction of the
22 national system of interstate and defense highways, referred to in
23 this act as "the interstate highway system", to the extent
24 necessary to match federal aid funds as the federal aid funds
25 become available for that purpose; and, for the construction and
26 reconstruction of the state trunk line system.

27 (g) The ~~state transportation~~ department may enter into

1 agreements with ~~county road commissions and with cities and~~
2 ~~villages~~ **A LOCAL ROAD AGENCY OR A PRIVATE SECTOR COMPANY** to perform
3 work on a highway, road, or street. The agreements may provide for
4 the performance by any of the contracting parties of any of the
5 work contemplated by the contract including **MAINTENANCE**,
6 engineering services, and the acquisition of rights of way in
7 connection with the work, by purchase or condemnation by any of the
8 contracting parties in its own name, and for joint participation in
9 the costs, but only to the extent that the contracting parties are
10 otherwise authorized by law to expend money on the highways, roads,
11 or streets. The ~~state transportation department~~ also may contract
12 with a ~~county~~ **LOCAL** road ~~commission, city, and village~~ **AGENCY** to
13 advance money to a ~~county~~ **LOCAL** road ~~commission, city, and village~~
14 agency to pay ~~their~~ **THE** costs of improving railroad grade crossings
15 on the terms and conditions agreed to in the contract. A contract
16 may be executed before or after the state transportation commission
17 borrows money for the purpose of advancing money to a ~~county~~ **LOCAL**
18 road ~~commission, city, or village~~ **AGENCY**, but the contract shall be
19 executed before the advancement of any money to a ~~county~~ **LOCAL** road
20 ~~commission, city, or village~~ **AGENCY** by the state transportation
21 commission, and shall provide for the full reimbursement of any
22 advancement by a ~~county~~ **LOCAL** road ~~commission, city, or village~~
23 **AGENCY** to the ~~state transportation department~~, with interest,
24 within 15 years after advancement, from any available revenue
25 sources of the ~~county~~ **LOCAL** road ~~commission, city, or village~~
26 **AGENCY** or, if provided in the contract, by deduction from the
27 periodic disbursements of any money returned by the state to the

1 ~~county-LOCAL road commission, city, or village.~~**AGENCY.**

2 (h) For providing inventories of supplies and materials
3 required for the activities of the ~~state transportation~~ department.
4 The ~~state transportation~~ department may purchase supplies and
5 materials for these purposes, with payment to be made out of the
6 state trunk line fund to be charged on the basis of issues from
7 inventory in accordance with the accounting and purchasing laws of
8 this state.

9 (2) Notwithstanding any other provision of this act, at least
10 90% of state revenue appropriated annually to the state trunk line
11 fund less the amounts described in subdivisions (a) to (i) shall be
12 expended annually by the ~~state transportation~~ department for the
13 preservation of highways, roads, streets, and bridges and for the
14 payment of debt service on bonds, notes, or other obligations
15 described in subsection (1)(a) issued after July 1, 1983 ~~—~~for the
16 purpose of providing funds for the preservation of highways, roads,
17 streets, and bridges. Of the amounts appropriated for state trunk
18 line projects, the department shall, where possible, secure
19 warranties of not less than 5-year full replacement guarantee for
20 contracted construction work. If an appropriate certificate is
21 filed under section 18e, but only to the extent necessary, this
22 subsection ~~shall~~**DOES** not prohibit the use of any amount of money
23 restricted as to use by section 9 of article IX of the state
24 constitution of 1963 and deposited in the state trunk line fund for
25 the payment of debt service on bonds, notes, or other obligations
26 pledging for the payment ~~thereof~~**OF THAT DEBT SERVICE** money
27 restricted as to use by section 9 of article IX of the state

1 constitution of 1963 and deposited in the state trunk line fund,
2 whenever issued, as specified under subsection (1)(a). The amounts
3 ~~which~~**THAT** are deducted from the state trunk line fund for the
4 purpose of the calculation required by this subsection are as
5 follows:

6 (a) Amounts expended for the purposes described in subsection
7 (1)(a) for the payment of debt service on bonds, notes, or other
8 obligations issued before July 2, 1983.

9 (b) Amounts expended to provide the state matching requirement
10 for projects on the national highway system and for the payment of
11 debt service on bonds, notes, or other obligations issued after
12 July 1, 1983, for the purpose of providing funds for the state
13 matching requirements for projects on the national highway system.

14 (c) Amounts expended for the construction of a highway,
15 street, road, or bridge to 1 or more of the following or for the
16 payment of debt service on bonds, notes, or other obligations
17 issued after July 1, 1983, for the purpose of providing funds for
18 the construction of a highway, street, road, or bridge to 1 or more
19 of the following:

20 (i) A location for which a building permit has been obtained
21 for the construction of a manufacturing or industrial facility.

22 (ii) A location for which a building permit has been obtained
23 for the renovation of, or addition to, a manufacturing or
24 industrial facility.

25 (d) Amounts expended for capital outlay other than for
26 highways, roads, streets, and bridges or to pay debt service on
27 bonds, notes, or other obligations issued after July 1, 1983, for

1 the purpose of providing funds for capital outlay other than for
2 highways, roads, streets, and bridges.

3 (e) Amounts expended for the operating expenses of the ~~state~~
4 ~~transportation~~ department other than the units of the department
5 performing the functions assigned on January 1, 1983 to the bureau
6 of highways.

7 (f) Amounts expended pursuant to contracts entered into before
8 January 1, 1983.

9 (g) Amounts expended for the purposes described in subsection
10 (5).

11 (h) Amounts appropriated for deposit in the transportation
12 economic development fund and the rail grade crossing account
13 ~~pursuant to~~ **UNDER** section ~~10(1)(g)~~ **10(1)(H)** and 10(1)(a).

14 (i) Upon the affirmative recommendation of the director of the
15 ~~state transportation~~ department and the approval by resolution of
16 the state transportation commission, ~~these~~ amounts expended for
17 projects vital to the economy of this state, a region, or local
18 area or the safety of the public. The resolution shall state the
19 cost of the project exempted from this subsection.

20 (3) Notwithstanding any other provision of this act, the ~~state~~
21 ~~transportation~~ department shall expend annually at least 90% of the
22 federal revenue distributed to the credit of the state trunk line
23 fund in that year, except for federal revenue expended for the
24 purposes described in subsection (2)(b), (c), (f), and (i) and for
25 the payment of notes issued under section 18b(9) on the
26 preservation of highways, roads, streets, and bridges. The
27 requirement of this subsection ~~shall be~~ **IS** waived if compliance

1 would cause this state to be ineligible ~~according to~~ **UNDER** federal
2 law for federal revenue, but only to the extent necessary to make
3 this state eligible ~~according to~~ **UNDER** federal law for that
4 revenue.

5 (4) Notwithstanding any other provision of this section, the
6 ~~state transportation department~~ may loan money to ~~county~~ **A LOCAL**
7 ~~road commissions, cities, and villages~~ **AGENCY** for paying capital
8 costs of transportation purposes described in the second paragraph
9 of section 9 of article IX of the state constitution of 1963 from
10 the proceeds of bonds or notes issued pursuant to section 18b or
11 from the state trunk line fund. Loans made directly from the state
12 trunk line fund shall be made only after provision of funds for the
13 purposes specified in subsection (1)(a) to (f). Loans described in
14 this subsection are not subject to the revised municipal finance
15 act, 2001 PA 34, MCL 141.2101 to 141.2821.

16 (5) ~~County~~ **A LOCAL** ~~road commissions, cities, and villages~~
17 **AGENCY** may borrow money from the proceeds of bonds or notes issued
18 under section 18b or the state trunk line fund for the purposes set
19 forth in subsection (4) that shall be repayable, with interest,
20 from 1 or more of the following:

21 (a) The money to be received by the ~~county~~ **LOCAL** ~~road~~
22 ~~commission, city, or village~~ **AGENCY** from the Michigan
23 transportation fund, except to the extent the money has been or may
24 in the future be pledged by contract ~~in accordance with~~ **UNDER** 1941
25 PA 205, MCL 252.51 to 252.64, or has been or may in the future be
26 pledged for the payment of the principal and interest upon notes
27 issued ~~pursuant to~~ **UNDER** 1943 PA 143, MCL 141.251 to 141.254, or

1 has been or may in the future be pledged for the payment of
2 principal and interest upon bonds issued under section 18c or 18d,
3 or has been or may in the future be pledged for the payment of the
4 principal and interest upon bonds issued pursuant to 1952 PA 175,
5 MCL 247.701 to 247.707.

6 (b) Any other legally available funds of the ~~city, village, or~~
7 ~~county-LOCAL road commission-AGENCY~~, other than the general funds
8 of the county.

9 (6) ~~Loans-IF REQUIRED BY THE DEPARTMENT, LOANS~~ made pursuant
10 ~~to-UNDER~~ subsection (4) ~~if required by the state transportation~~
11 ~~department may be-ARE~~ payable by deduction by the state treasurer,
12 upon direction of the ~~state transportation~~ department, from the
13 periodic disbursements of any money returned by ~~the-THIS~~ state
14 under this act to the ~~county-LOCAL road commission, city, or~~
15 ~~village-AGENCY~~, but only after sufficient money has been returned
16 to the ~~county-LOCAL road commission, city, or village-AGENCY~~ to
17 provide for the payment of contractual obligations incurred or to
18 be incurred and principal and interest on notes and bonds issued or
19 to be issued under 1941 PA 205, MCL 252.51 to 252.64, 1943 PA 143,
20 MCL 141.251 to 141.254, 1952 PA 175, MCL 247.701 to 247.707, or
21 section 18c or 18d. The interest rates and payment schedules of any
22 loans made from the proceeds of bonds or notes issued pursuant to
23 section 18b shall be established by the ~~state transportation~~
24 department to conform as closely as practicable to the interest
25 rate and repayment schedules on the bonds or notes issued to make
26 the loans. However, the ~~state transportation~~ department may allow
27 for the deferral of the first payment of interest or principal on

1 the loans for a period ~~of~~ not to exceed 1 year after the respective
2 first payment of interest or principal on the bonds or notes issued
3 to make the loans.

4 (7) The amount borrowed by a ~~county-LOCAL road commission,~~
5 ~~city, or village pursuant to-AGENCY UNDER~~ subsection (5) shall not
6 be included in, or charged against, any constitutional, statutory,
7 or charter debt limitation of the county, city, or village and
8 shall not be included in the determination of the maximum annual
9 principal and interest requirements of, or the limitations upon,
10 the maximum annual principal and interest incurred under 1941 PA
11 205, MCL 252.51 to 252.64, 1943 PA 143, MCL 141.251 to 141.254,
12 1952 PA 175, MCL 247.701 to 247.707, or section 18c or 18d.

13 (8) The ~~county-LOCAL road commission, city, or village-AGENCY~~
14 is not required to seek or obtain the approval of the electors, the
15 municipal finance commission or its successor agency, or, except as
16 provided in this subsection, the department of treasury to borrow
17 money ~~pursuant to-UNDER~~ subsection (5). The borrowing is not
18 subject to the revised municipal finance act, 2001 PA 34, MCL
19 141.2101 to 141.2821, or to section 5(g) of the home rule city act,
20 1909 PA 279, MCL 117.5. The ~~state-transportation~~ department shall
21 give at least 10 days' notice to the state treasurer of its
22 intention to make a loan under subsection (4). If the state
23 treasurer gives notice to the director of the ~~state-transportation~~
24 department within 10 days ~~of-AFTER~~ receiving the notice from the
25 ~~state-transportation~~ department, that, based upon the then existing
26 financial or credit situation of the ~~county-LOCAL road commission,~~
27 ~~city, or village-AGENCY~~, it would not be in the best interests of

1 the state to make a loan under subsection (4) to the ~~county~~ **LOCAL**
 2 road ~~commission, city, or village~~ **AGENCY**, the loan shall not be
 3 made unless the state treasurer, after a hearing, if requested by
 4 the affected ~~county~~ **LOCAL** road ~~commission, city, or village~~ **AGENCY**,
 5 subsequently gives notice to the director of the ~~state~~
 6 ~~transportation~~ department that the loan may be made on the
 7 conditions that the state treasurer specifies.

8 (9) The state transportation commission may borrow money and
 9 issue bonds and notes under ~~, and pursuant to the requirements of,~~
 10 section 18b to make loans to ~~county~~ **A LOCAL** road ~~commissions,~~
 11 ~~cities, and villages~~ **AGENCY** for the purposes described in the
 12 second paragraph of section 9 of article IX of the state
 13 constitution of 1963, as provided in subsection (4). A single issue
 14 of bonds or notes may be issued for the purposes specified in
 15 subsection (4) and for the other purposes specified in section 18b.
 16 The house and senate transportation appropriations subcommittees
 17 shall be notified by the department if there are extras and
 18 overruns sufficient to require approval of either the state
 19 administrative board or the commission, or both, on any contract
 20 between the department and a local road agency or a private
 21 business.

22 **(10) THE DEPARTMENT MAY BORROW MONEY FROM A LOCAL ROAD AGENCY,**
 23 **IF THE LOCAL ROAD AGENCY HAS ACCUMULATED UNEXPENDED MONEY FROM THE**
 24 **MONEY DISTRIBUTED TO THE LOCAL ROAD AGENCY UNDER THIS ACT, FOR THE**
 25 **PURPOSES DESCRIBED IN SECTION 9 OF ARTICLE IX OF THE STATE**
 26 **CONSTITUTION OF 1963 OR FOR THE PURPOSE OF MATCHING FEDERAL FUNDS**
 27 **PROVIDED FOR TRANSPORTATION PURPOSES. MONEY LOANED TO THE**

1 DEPARTMENT FROM A LOCAL ROAD AGENCY UNDER THIS SUBSECTION SHALL BE
2 REPAID ACCORDING TO THE AGREEMENT BETWEEN THE LOCAL ROAD AGENCY AND
3 THE DEPARTMENT.

4 (11) ~~(10)~~ The director of the ~~state transportation~~ department,
5 after consultation with representatives of the interests of ~~county~~
6 **LOCAL** road ~~commissions, cities, and villages~~ **AGENCIES**, shall
7 establish, by intergovernmental communication, procedures for the
8 implementation and administration of the loan program established
9 under subsections (4) to ~~(9)~~ **(10)**.

10 (12) ~~(11)~~ Not more than 10% per year of all of the funds
11 received by and returned to the ~~state transportation~~ department
12 from any source for the purposes of this section may be expended
13 for administrative expenses. The department shall be subject to
14 section 14(5) if more than 10% per year is expended for
15 administrative expenses. As used in this subsection,
16 "administrative expenses" means those expenses that are not
17 assigned including, but not limited to, specific road construction
18 or preservation projects, and are often referred to as general or
19 supportive services. Administrative expenses ~~shall~~ **DO** not include
20 net equipment expense, net capital outlay, debt service principal
21 and interest, and payments to other state or local offices ~~which~~
22 **THAT** are assigned, but not limited to, specific road construction
23 projects or preservation activities.

24 (13) ~~(12)~~ Any performance audits of the department shall be
25 conducted according to government auditing standards issued by the
26 United States general accounting office.

27 (14) ~~(13)~~ Contracts entered into to advance money to a ~~county~~

1 ~~LOCAL road commission, city, or village~~ **AGENCY** under subsection
 2 (1)(g) are not subject to the revised municipal finance act, 2001
 3 PA 34, MCL 141.2101 to 141.2821.

4 **(15)** ~~(14)~~ As used in this section, "rail grade crossing
 5 improvement purposes" means 1 or more of the following:

6 (a) The installation and modernization of active and passive
 7 warning devices at railroad grade crossings.

8 (b) The installation or improvement of grade crossing
 9 surfaces.

10 (c) Modification, relocation, or modernization of railroad
 11 grade crossing active and passive warning devices necessitated by
 12 roadway improvement projects.

13 (d) Test installations of innovative warning devices or other
 14 innovative applications.

15 (e) Construction of new grade separations.

16 (f) A cash incentive payment made pursuant to subsection
 17 (1)(c)(iv) for any public road or street crossing, in an amount no
 18 greater than the cost of installing flashing light signals and half
 19 roadway gates at the crossing.

20 (g) Any other work that would be eligible for funding under
 21 the federal railroad-highway grade crossing improvement program or
 22 other comparable programs.
