A bill to amend 1968 PA 251, entitled "Cemetery regulation act,"

(MCL 456.521 to 456.543) by adding section 17.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17. (1) THE OWNER OR OPERATOR OF A CEMETERY MAY TERMINATE
- 2 THE BURIAL, COLUMBARIUM, OR ENTOMBMENT RIGHT TO A SPACE ONLY IF
- 3 BOTH OF THE FOLLOWING CONDITIONS ARE MET RELATING TO THAT BURIAL,
 - COLUMBARIUM, OR ENTOMBMENT SPACE:
- 5 (A) A PERIOD OF TIME OF NOT LESS THAN 50 YEARS HAS ELAPSED
- 6 FROM THE DATE OF THE LAST RECORDED CONTACT WITH THE CUSTOMER,
- 7 INCLUDING THE PURCHASE, TRANSFER, DESIGNATION, BURIAL, INSTALLATION
- 8 OF MEMORIAL, PAYMENT ON ACCOUNT, OR LETTER FROM THE CUSTOMER
- 9 AFFIRMING OWNERSHIP.

- 16 KNOWN ADDRESS SEEKING INFORMATION REGARDING THE OWNER'S CURRENT

- 18 (4) AFTER THE OWNER OR OPERATOR OF THE CEMETERY HAS COMPLIED
- 19 WITH THE NOTICE REQUIREMENTS OF SUBSECTIONS (2) AND (3), AND IF NO
- 20 WRITTEN RESPONSE IS RECEIVED BY THE OWNER OR OPERATOR OF THE
- 21 CEMETERY, THE RIGHTS TO THE BURIAL, COLUMBARIUM, OR ENTOMBMENT
- 22 SPACE ARE TERMINATED UPON THE EXPIRATION OF 60 DAYS AFTER THE DATE
- 23 THE PUBLICATION NOTICE OCCURS.
- 24 (5) IF THE OWNER OR OPERATOR OF A CEMETERY RECEIVES A WRITTEN
- 25 RESPONSE FROM AN OWNER OR THE OWNER'S REPRESENTATIVE AFTER NOTICE
- 26 IS GIVEN UNDER SUBSECTION (2) OR (3), OR BOTH, WITHIN THE TIME
- 27 PERIODS PRESCRIBED IN THOSE SUBSECTIONS, AND THE OWNER OR THE

- 1 OWNER'S REPRESENTATIVE INDICATES AN INTENT TO RETAIN OWNERSHIP
- 2 RIGHTS, THE RIGHTS TO THE BURIAL, COLUMBARIUM, OR ENTOMBMENT SPACE
- 3 SHALL NOT BE TERMINATED. IF THE OWNER OR THE OWNER'S REPRESENTATIVE
- 4 OF THE SPACE DESIRES TO TERMINATE THE OWNERSHIP RIGHTS OF THE
- 5 BURIAL, COLUMBARIUM, OR ENTOMBMENT SPACE, THE OWNER OR OWNER'S
- 6 REPRESENTATIVE MAY SELL THE SPACE TO THE CEMETERY FOR AN AMOUNT AS

- 8 (6) IF THE OWNER OR THE OWNER'S REPRESENTATIVE CONTACTS THE
- 9 OWNER OR OPERATOR OF THE CEMETERY AFTER THE RIGHTS TO THE BURIAL,
- 10 COLUMBARIUM, OR ENTOMBMENT SPACE ARE TERMINATED, THE OWNER OR THE
- 11 OWNER'S REPRESENTATIVE MAY DO 1 OF THE FOLLOWING:
- 12 (A) IF THE SPACE HAS NOT BEEN RESOLD, REQUEST REINSTATEMENT,
- 13 AT NO ADDITIONAL COST, OF THE BURIAL, COLUMBARIUM, OR ENTOMBMENT
- 14 RIGHTS TO THE SPACE IF HE OR SHE INDICATES IN WRITING THE INTENTION
- 15 TO KEEP THE ORIGINAL SPACE. UNDER SUCH CIRCUMSTANCES, THE RIGHTS
- 16 SHALL BE REINSTATED.
- 17 (B) IF THE ORIGINAL SPACE HAS BEEN SOLD, THE OWNER OR OPERATOR
- 18 OF THE CEMETERY MAY, AT HIS OR HER OPTION, PAY THE CURRENT RETAIL
- 19 VALUE OF THE SPACE, NICHE, OR MAUSOLEUM TO THE OWNER OR THE OWNER'S
- 20 REPRESENTATIVE OR GIVE THE OWNER OR THE OWNER'S REPRESENTATIVE A
- 21 SPACE OF COMPARABLE VALUE.
- 22 (7) ANY CONTRACT OR AGREEMENT ENTERED INTO ON OR AFTER THE
- 23 EFFECTIVE DATE OF THIS SECTION SHALL CONTAIN A WRITTEN NOTICE OF
- 24 THE RIGHT OF THE CEMETERY TO TERMINATE THE OWNERSHIP RIGHTS OF THE
