A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 169 (MCL 750.169).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 169. (1) Disturbance of religious meetings Any person 2 who, on the first day of the week, or at any other time, shall 3 wilfully interrupt or disturb any assembly of people met for the 4 worship of God, within the place of such meeting or out of it, 5 shall be guilty of a misdemeanor. A PERSON SHALL NOT DO ANY OF THE FOLLOWING:

- (A) ENTER OR ATTEMPT TO ENTER ANY PRIVATE PROPERTY WHERE THE PERSON KNOWS PEOPLE ARE MEETING OR ARE INTENDING TO MEET IN THE PURSUIT OF THEIR FREE EXERCISE OF RELIGION WITH THE INTENT TO DISRUPT THAT MEETING.
  - (B) AFTER BEING INSTRUCTED TO LEAVE, REMAIN ON OR ATTEMPT TO
