A bill to amend 1966 PA 346, entitled "State housing development authority act of 1966," (MCL 125.1401 to 125.1499c) by adding section 13.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 13. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ACT,
- 2 THE AUTHORITY SHALL NOT AWARD GRANTS, MAKE DIRECT LOANS, MAKE
- 3 INDIRECT LOANS THROUGH A LENDER, OR OTHERWISE EXPEND MONEY FOR
- 4 COMMERCIAL DEVELOPMENT UNLESS ALL OF THE FOLLOWING REQUIREMENTS ARE
- 5 MET:
  - (A) THE COMMERCIAL DEVELOPMENT IS PART OF A HOUSING PROJECT OR
- HOUSING DEVELOPMENT AND NOT LESS THAN 75% OF THE EXPENDITURES BY
- 8 THE AUTHORITY FOR THE HOUSING PROJECT OR HOUSING DEVELOPMENT ARE OR
- 9 WILL BE FOR RESIDENTIAL DEVELOPMENT.
