## **HOUSE BILL No. 5649**

May 17, 2012, Introduced by Rep. McMillin and referred to the Committee on Commerce.

A bill to amend 1966 PA 346, entitled "State housing development authority act of 1966," (MCL 125.1401 to 125.1499c) by adding section 14.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 14. (1) THE AUTHORITY SHALL COMPLY WITH THE STATE
- 2 FINANCIAL MANAGEMENT GUIDE ISSUED BY THE DEPARTMENT OF TECHNOLOGY,
- 3 MANAGEMENT, AND BUDGET PURSUANT TO THE MANAGEMENT AND BUDGET ACT,
- 4 1984 PA 431, MCL 18.1101 TO 18.1594, INCLUDING, BUT NOT LIMITED TO,
- 5 PROVISIONS PROHIBITING ADVANCE CONTRACT PAYMENTS WITHOUT THE
- 6 APPROVAL OF THE DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET.
- 7 (2) THE AUTHORITY SHALL UTILIZE COMPETITIVE SOLICITATION FOR
- 8 ANY CONTRACT, INCLUDING A CONTRACT RENEWAL OR GROUP OF CONTRACTS TO
  - BE AWARDED TO A SINGLE COMPANY, OF \$25,000.00 OR MORE.
  - (3) EXCEPT AS PROVIDED IN SUBSECTION (5) OR (6), A MEMBER OR
  - EMPLOYEE OF THE AUTHORITY SHALL NOT ENGAGE IN OR ACCEPT EMPLOYMENT

- 1 WITH OR RENDER SERVICES FOR ANOTHER PERSON IF THAT EMPLOYMENT OR
- 2 SERVICE IS INCOMPATIBLE OR IN CONFLICT WITH THE DISCHARGE OF THE
- 3 MEMBER OR EMPLOYEE'S OFFICIAL DUTIES OR IF THAT EMPLOYMENT MAY TEND
- 4 TO IMPAIR HIS OR HER INDEPENDENCE OF JUDGMENT OR ACTION IN THE
- 5 PERFORMANCE OF OFFICIAL DUTIES.
- 6 (4) EXCEPT AS PROVIDED IN SUBSECTION (5) OR (6), A MEMBER OR
- 7 EMPLOYEE OF THE AUTHORITY SHALL NOT PARTICIPATE IN THE NEGOTIATION
- 8 OR EXECUTION OF CONTRACTS, MAKING OF LOANS, GRANTING OF SUBSIDIES,
- 9 FIXING OF RATES, ISSUANCE OF CERTIFICATES, OR OTHER REGULATION OR
- 10 SUPERVISION RELATING TO A BUSINESS ENTITY IN WHICH THE MEMBER OR
- 11 EMPLOYEE HAS A FINANCIAL OR PERSONAL INTEREST.
- 12 (5) SUBJECT TO SUBSECTION (6), A MEMBER OF THE AUTHORITY MAY
- 13 VOTE ON, MAKE, OR PARTICIPATE IN MAKING A GOVERNMENTAL DECISION IF
- 14 ALL OF THE FOLLOWING OCCUR:
- 15 (A) THE REQUISITE QUORUM NECESSARY FOR OFFICIAL ACTION ON THE
- 16 GOVERNMENTAL DECISION BY THE AUTHORITY WOULD NOT BE AVAILABLE IF
- 17 THE PARTICIPATION OF THE MEMBER IN THE OFFICIAL ACTION WERE
- 18 PROHIBITED UNDER SUBSECTION (3) OR (4).
- 19 (B) THE MEMBER IS NOT PAID FOR WORKING MORE THAN 25 HOURS PER
- 20 WEEK FOR THIS STATE OR A POLITICAL SUBDIVISION OF THIS STATE.
- 21 (C) THE MEMBER PROMPTLY DISCLOSES ANY PERSONAL, CONTRACTUAL,
- 22 FINANCIAL, BUSINESS, OR EMPLOYMENT INTEREST HE OR SHE HAS IN THE
- 23 GOVERNMENTAL DECISION AND THE DISCLOSURE IS MADE PART OF THE PUBLIC
- 24 RECORD OF THE OFFICIAL ACTION ON THE GOVERNMENTAL DECISION.
- 25 (6) IF A GOVERNMENTAL DECISION INVOLVES A CONTRACT AWARD, A
- 26 MEMBER OF THE AUTHORITY MAY VOTE ON, MAKE, OR PARTICIPATE IN MAKING
- 27 THE GOVERNMENTAL DECISION IF ALL OF THE FOLLOWING OCCUR:

- 1 (A) ALL OF THE CONDITIONS OF SUBSECTION (5) ARE MET.
- 2 (B) THE MEMBER WILL DIRECTLY BENEFIT FROM THE CONTRACT IN AN
- 3 AMOUNT LESS THAN \$250.00 OR LESS THAN 5% OF THE PUBLIC COST OF THE
- 4 CONTRACT, WHICHEVER IS LESS.
- 5 (C) THE MEMBER FILES WITH THE AUTHORITY A SWORN AFFIDAVIT
- 6 ATTESTING TO THE INFORMATION DESCRIBED IN SUBDIVISION (B).
- 7 (D) THE AFFIDAVIT REQUIRED BY SUBDIVISION (C) IS MADE A PART
- 8 OF THE PUBLIC RECORD OF THE OFFICIAL ACTION ON THE GOVERNMENTAL
- 9 DECISION.
- 10 (7) AS USED IN THIS SECTION, "GOVERNMENTAL DECISION" MEANS A
- 11 DETERMINATION, ACTION, VOTE, OR DISPOSITION UPON A MOTION,
- 12 PROPOSAL, RECOMMENDATION, RESOLUTION, OR MEASURE ON WHICH A VOTE BY
- 13 THE MEMBERS OF THE AUTHORITY IS REQUIRED AND BY WHICH THE AUTHORITY
- 14 FORMULATES OR EFFECTUATES PUBLIC POLICY.
