A bill to amend 2010 PA 347, entitled "Girl scouts of Michigan fund act," by amending sections 3 and 4 (MCL 206.923 and 206.924).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 3. (1) The girl scouts of Michigan fund is created in the department to provide funds for donation to any girl scout organization located in this state to prepare young people to make ethical and moral choices over their lifetimes by instilling in them the values of the scout oath and law.
 - (2) The state treasurer shall credit to the fund all amounts appropriated for this purpose under section 435 of the income tax act of 1967, 1967 PA 281, MCL 206.435, AND ALL AMOUNTS RECEIVED
 - FROM THE SALE OF A FUND-RAISING LICENSE PLATE RECOGNIZING THE GIRL
