## **HOUSE BILL No. 5969**

October 17, 2012, Introduced by Rep. Brown and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 218a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 218A. (1) A PERSON WHO DOES ANY OF THE FOLLOWING AND WHO
- 2 KNOWS OR HAS REASON TO KNOW THAT THE DOCUMENT IS FORGED OR
- 3 GROUNDLESS, CONTAINS A MATERIAL MISSTATEMENT OR FALSE CLAIM,
- 4 CONTAINS A SIGNATURE THAT IS NOT THE SIGNATURE OF THE PERSON WHOSE
- 5 NAME IS BEING SIGNED, OR IS OTHERWISE INVALID MAKES A FALSE
- 6 REPRESENTATION CONCERNING TITLE AND IS GUILTY OF A FELONY
- 7 PUNISHABLE BY IMPRISONMENT FOR NOT LESS THAN 1 YEAR AND NOT MORE
- 8 THAN 5 YEARS OR A FINE OF NOT MORE THAN \$10,000.00, OR BOTH FINE
- 9 AND IMPRISONMENT:

- 1 (A) CLAIMS AN INTEREST IN, OR A LIEN OR ENCUMBRANCE AGAINST,
- 2 REAL PROPERTY IN A DOCUMENT THAT IS RECORDED IN THE OFFICE OF THE
- 3 REGISTER OF DEEDS OF THE COUNTY WHERE THE PROPERTY IS LOCATED.
- 4 (B) EXECUTES OR NOTARIZES A DOCUMENT PURPORTING TO CREATE AN

- 6 IS RECORDED IN THE OFFICE OF THE REGISTER OF DEEDS OF THE COUNTY

- 8 (C) CAUSES A DOCUMENT DESCRIBED IN SUBDIVISION (A) OR (B) TO
- 9 BE RECORDED IN THE OFFICE OF THE REGISTER OF DEEDS OF THE COUNTY
- 10 WHERE THE PROPERTY IS LOCATED.
- 11 (D) ROBOSIGNS A DOCUMENT OR CAUSES A DOCUMENT TO BE
- 12 ROBOSIGNED.
- 13 (2) A PERSON WHO MAKES A FALSE REPRESENTATION CONCERNING TITLE
- 14 IN 2 OR MORE TRANSACTIONS ENGAGES IN A PATTERN OF MAKING FALSE
- 15 REPRESENTATIONS CONCERNING TITLE AND IS GUILTY OF A FELONY
- 16 PUNISHABLE BY IMPRISONMENT FOR NOT LESS THAN 3 YEARS AND NOT MORE
- 17 THAN 20 YEARS OR A FINE OF NOT MORE THAN \$50,000.00, OR BOTH FINE
- 18 AND IMPRISONMENT, IF ALL OF THE FOLLOWING APPLY TO THE
- 19 TRANSACTIONS:
- 20 (A) THE TRANSACTIONS HAVE THE SAME OR SIMILAR PATTERN,
- 21 PURPOSES, RESULTS, ACCOMPLICES, VICTIMS, OR METHODS OF COMMISSION,
- 22 OR ARE OTHERWISE INTERRELATED BY DISTINGUISHING CHARACTERISTICS.
- 23 (B) THE TRANSACTIONS ARE NOT ISOLATED INCIDENTS WITHIN THE
- 24 PRECEDING 4 YEARS.
- 25 (C) THE AGGREGATE LOSS OR INTENDED LOSS IN THE TRANSACTIONS IS
- 26 MORE THAN \$250.00.
- 27 (3) IN ADDITION TO THE CRIMINAL PENALTIES IMPOSED UNDER

- 1 SUBSECTIONS (1) AND (2), A PERSON WHO MAKES A FALSE REPRESENTATION
- 2 CONCERNING TITLE AS DESCRIBED IN SUBSECTION (1) IS SUBJECT TO A
- 3 CIVIL FINE OF NOT MORE THAN \$5,000.00 FOR EACH VIOLATION. A PENALTY
- 4 UNDER THIS SUBSECTION MAY BE RECOVERED IN A CIVIL ACTION BROUGHT IN
- 5 THE NAME OF THIS STATE BY THE ATTORNEY GENERAL. THE ATTORNEY
- 6 GENERAL MAY RECOVER REASONABLE ATTORNEY FEES AND COSTS IN AN ACTION
- 7 UNDER THIS SUBSECTION.
- 8 (4) EXCEPT AS PROVIDED IN SUBSECTION (5), THE OWNER OR HOLDER
- 9 OF THE BENEFICIAL INTEREST IN REAL PROPERTY THAT IS THE SUBJECT OF
- 10 A FALSE REPRESENTATION CONCERNING TITLE AS DESCRIBED IN SUBSECTION
- 11 (1) MAY BRING A CIVIL ACTION TO RECOVER ANY DAMAGES SUFFERED BY THE
- 12 OWNER OR HOLDER OF THE BENEFICIAL INTEREST, REASONABLE ATTORNEY
- 13 FEES, AND COSTS. ADDITIONALLY, A PERSON WHO MAKES A FALSE
- 14 REPRESENTATION CONCERNING TITLE BY ROBOSIGNING UNDER SUBSECTION
- 15 (1) (D) IS LIABLE TO THE OWNER OR HOLDER OF THE BENEFICIAL INTEREST
- 16 IN THE PROPERTY FOR 3 TIMES THE AMOUNT FOR WHICH THE PERSON WOULD
- 17 OTHERWISE BE LIABLE UNDER THIS SUBSECTION.
- 18 (5) BEFORE BRINGING A CIVIL ACTION UNDER SUBSECTION (4), THE
- 19 OWNER OR HOLDER OF THE BENEFICIAL INTEREST IN THE REAL PROPERTY
- 20 SHALL REQUEST IN WRITING THAT THE PERSON WHO MADE THE FALSE
- 21 REPRESENTATION RECORD A DOCUMENT THAT CORRECTS THE FALSE
- 22 REPRESENTATION. IF THE PERSON RECORDS A CORRECTIVE DOCUMENT WITHIN
- 23 20 DAYS AFTER THE DATE OF THE WRITTEN REQUEST, THE OWNER OR HOLDER
- 24 OF THE BENEFICIAL INTEREST IS NOT ENTITLED TO FILE A CIVIL ACTION
- 25 UNDER SUBSECTION (4).
- 26 (6) AS USED IN THIS SECTION, "ROBOSIGN" MEANS TO SIGN A
- 27 DOCUMENT FOR THE SIGNOR OR TRANSFEROR.
