- 5 (A) HE OR SHE IS MARRIED TO A MEMBER OF THE ARMED FORCES OF 6 THE UNITED STATES WHO IS ON ACTIVE DUTY.
- 7 (B) HE OR SHE HOLDS A CURRENT TEACHING CERTIFICATE OR LICENSE
- 8 ISSUED BY AN EQUIVALENT CREDENTIALING DEPARTMENT, BOARD, OR
