## **HOUSE BILL No. 4288**

February 17, 2011, Introduced by Rep. Womack and referred to the Committee on Local, Intergovernmental, and Regional Affairs.

A bill to amend 1990 PA 72, entitled "Local government fiscal responsibility act," by amending sections 21a and 41a (MCL 141.1221a and 141.1241a), as added by 2009 PA 181.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 21a. (1) An emergency financial manager appointed under this article shall file with the governor, the senate majority leader, and the speaker of the house of representatives and post on the internet on the website of the local unit of government a report that contains all of the following:
  - (a) A description of each expenditure made, approved, or disapproved during the reporting period that has a cumulative value

- 21 EDUCATION FINANCIAL EMERGENCY RESOLUTION BOARD SHALL SET THE SAME
- 22 DATE FOR ALL EMERGENCY MANAGERS APPOINTED UNDER THIS ARTICLE FOR
- 23 SUBMISSION OF THE REPORT.
- 24 Enacting section 1. This amendatory act does not take effect

- 26 00567'11) of the 96th Legislature is enacted into law.
