HOUSE BILL No. 5921

September 19, 2012, Introduced by Rep. Kandrevas and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled

"The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 70a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 70A. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION,
- 2 A PERSON SHALL NOT OWN OR POSSESS A NONHUMAN PRIMATE IN THIS STATE.
- 3 THIS SUBSECTION DOES NOT APPLY TO ANY OF THE FOLLOWING:
- 4 (A) A ZOO ACCREDITED BY THE ASSOCIATION OF ZOOS AND AQUARIUMS.
- 5 (B) AN INSTITUTION ACCREDITED BY THE ASSOCIATION FOR
- 6 ASSESSMENT AND ACCREDITATION OF LABORATORY ANIMAL CARE.
 - (C) A SANCTUARY ACCREDITED BY THE GLOBAL FEDERATION OF ANIMAL
- 8 SANCTUARIES OR THE AMERICAN SANCTUARY ASSOCIATION.
- 9 (D) A PERSON OR ORGANIZATION THAT HOLDS A VALID LICENSE ISSUED
- 10 BY THE UNITED STATES DEPARTMENT OF AGRICULTURE FOR ENGAGING IN AN

- 1 ACTIVITY WHILE THE PERSON OR ORGANIZATION IS ENGAGED IN THE
- 2 PERMITTED ACTIVITY.
- 3 (E) A LAW ENFORCEMENT OFFICER IN THE COURSE OF HIS OR HER
- 4 EMPLOYMENT AS A LAW ENFORCEMENT OFFICER.
- 5 (F) A VETERINARIAN IN THE COURSE OF HIS OR HER OCCUPATION AS A
- 6 VETERINARIAN.
- 7 (G) A PERMITTING AGENCY IN THE COURSE OF ITS BUSINESS OR
- 8 MISSION AS A PERMITTING AGENCY.
- 9 (H) ANIMAL CONTROL PERSONNEL OF A LOCAL UNIT OF GOVERNMENT IN
- 10 THE COURSE OF HIS OR HER OCCUPATION AS AN ANIMAL CONTROL OFFICER.
- 11 (I) A PERSON WHO OWNS OR POSSESSES A NONHUMAN PRIMATE ON THE
- 12 DATE THAT THE AMENDATORY ACT THAT ADDED THIS SECTION IS ENACTED
- 13 INTO LAW. THIS EXEMPTION ONLY APPLIES FOR THE SPECIFIC INDIVIDUAL
- 14 NONHUMAN PRIMATE OR PRIMATES OWNED OR POSSESSED ON THE DATE THIS
- 15 AMENDATORY ACT IS ENACTED INTO LAW, AND APPLIES ONLY UNTIL THE
- 16 DEATH OF THAT NONHUMAN PRIMATE OR NONHUMAN PRIMATES.
- 17 (2) A PERSON SHALL NOT TRANSFER THE OWNERSHIP OR POSSESSION OF
- 18 A NONHUMAN PRIMATE, EXCEPT TO A PERSON, ENTITY, ORGANIZATION, OR
- 19 AGENCY DESCRIBED IN SUBSECTION (1)(A), (B), (C), (D), (E), (F),
- 20 (G), OR (H).
- 21 (3) A PERSON SHALL NOT BREED, OR CAUSE TO BE BRED, A NONHUMAN
- 22 PRIMATE, EXCEPT BY A PERSON, ENTITY, OR ORGANIZATION DESCRIBED IN
- 23 SUBSECTION (1) (A) OR (B).
- 24 (4) A PERSON SHALL NOT IMPORT A NONHUMAN PRIMATE INTO THIS
- 25 STATE UNLESS BOTH OF THE FOLLOWING CONDITIONS ARE SATISFIED:
- 26 (A) THE PERSON OBTAINS PRIOR AUTHORIZATION OF THE DEPARTMENT
- 27 OF AGRICULTURE AND RURAL DEVELOPMENT OF THIS STATE.

- 1 (B) THE PERSON ADMINISTERS, OR CAUSES TO BE ADMINISTERED,
- 2 UNIQUE AND PERMANENT IDENTIFICATION FOR EACH NONHUMAN PRIMATE.
- 3 (5) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 4 MISDEMEANOR PUNISHABLE BY PERMANENT REMOVAL OF THE NONHUMAN PRIMATE
- 5 FROM THE DEFENDANT'S POSSESSION AND 1 OR MORE OF THE FOLLOWING:
- 6 (A) IMPRISONMENT FOR NOT MORE THAN 93 DAYS.
- 7 (B) COMMUNITY SERVICE FOR NOT MORE THAN 500 HOURS.
- 8 (C) A FINE OF NOT LESS THAN \$500.00 OR MORE THAN \$1,000.00.
- 9 Enacting section 1. This amendatory act takes effect 90 days
- 10 after the date it is enacted into law.
