SENATE BILL No. 100

February 1, 2011, Introduced by Senator JONES and referred to the Committee on Regulatory Reform.

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending sections 1111, 1113, and 1114 (MCL 436.2111, 436.2113, and 436.2114), as amended by 2010 PA 213.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1111. (1) Except as otherwise provided for in subsection
- 2 (6), the THE sale of beer and wine between the hours of 7 a.m. on
- 3 Sunday and 2 a.m. on Monday is allowed. , but may be prohibited, in
 - any EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (6), A county, city,
 - village, or township MAY PROHIBIT THE SALE OF BEER AND WINE BETWEEN
 - THE HOURS OF 7 A.M. AND 12 NOON ON SUNDAY OR BETWEEN THE HOURS OF 7
- 7 A.M. ON SUNDAY AND 2 A.M. ON MONDAY under the following
- 8 circumstances:

- 1 (a) By majority vote of the legislative body voting on the
- 2 resolution to make such an authorization. Failure of the
- 3 legislative body to act on such an authorization is grounds for the
- 4 petitioning of the county, city, village, or township for
- 5 submission of the question to the voters of the county, city,
- 6 village, or township under subsection (2).
- 7 (b) By submission of a petition under subsection (2) by a
- 8 majority vote of the electors voting at a regular state election.
- 9 (2) Not more often than once in every 4 years, upon UPON the
- 10 filing of a petition with the county, city, village, or township
- 11 clerk, by a majority of the electors voting at a regular state
- 12 election within that county, village, city, or township, as
- 13 applicable, requesting the submission of the question of the Sunday
- 14 MORNING sale of beer and wine OR THE SUNDAY SALE OF BEER AND WINE,
- 15 the clerk shall submit that question to the electors of the county,
- 16 city, village, or township at the next regular state election held
- 17 in that county, city, village, or township. A petition filed under
- 18 this subsection shall be filed not less than 60 days before the
- 19 regular state election. A ballot question under this subsection
- 20 shall not be submitted more often than once in any 4-year period.
- 21 (3) In the case of a county, city, or township, the petition
- 22 shall be signed by a number of the registered and qualified
- 23 electors of the county, city, or township that is not less than 35%
- 24 of the total number of votes cast for all candidates for the office
- 25 of secretary of state in that county, city, or township at the last
- 26 general election held for that purpose and, in the case of a
- 27 village the petition shall be signed by a number of the registered

- 9 "Shall the sale of beer and wine within (the county, city,
- 10 village, or township as the case may be) between the hours of 7
- 11 a.m. AND 12 NOON on Sunday and 2 a.m. on Monday be prohibited?

- 14 (B) FOR THE SALE BETWEEN THE HOURS OF 7 A.M. ON SUNDAY AND 2
- 15 A.M. ON MONDAY:
- 16 "SHALL THE SALE OF BEER AND WINE WITHIN (THE COUNTY, CITY,
- 17 VILLAGE, OR TOWNSHIP AS THE CASE MAY BE) BETWEEN THE HOURS OF 7
- 18 A.M. ON SUNDAY AND 2 A.M. ON MONDAY BE PROHIBITED?

- 21 (5) All votes on the VOTES ON A question submitted to the
- 22 electors under this section shall be taken, counted, and canvassed
- 23 in the same manner as votes cast in county, city, village, or
- 24 township election ELECTIONS, as applicable, are taken, counted, and
- 25 canvassed. Ballots shall be furnished by the election commission or
- 26 similar body of the respective county, city, village, or township.
- 27 If a majority of the electors voting at an election conducted under

- 1 this section vote in favor of the question submitted, the sale of
- 2 beer and wine within that county, city, village, or township
- 3 between the hours of 7 a.m. AND 12 NOON on Sunday OR BETWEEN THE

- 5 (6) The sale of beer and wine in any county between the hours

- 5 (7) ANY PROHIBITIONS ON THE SALE OF BEER AND WINE BETWEEN THE
- 6 HOURS OF 7 A.M. AND 12 NOON ON SUNDAY OR BETWEEN THE HOURS OF 7
- 7 A.M. ON SUNDAY AND 2 A.M. ON MONDAY ADOPTED BY A COUNTY, CITY,
- 8 VILLAGE, OR TOWNSHIP BEFORE THE EFFECTIVE DATE OF THE AMENDATORY
- 9 ACT THAT ADDED THIS SUBSECTION SHALL REMAIN IN EFFECT.
- 10 Sec. 1113. (1) Except as provided in subsection (2), (3), or
- 11 (5) and subject to subsection (6), a licensee enumerated under
- 12 section 525 may sell at retail, and a person may buy, spirits or
- 13 mixed spirit drink between the hours of 7 a.m. on Sunday and 2 a.m.
- 14 on Monday.
- 15 (2) Unless the legislative body of a county has prohibited the
- 16 sale of spirits and mixed spirit drink for consumption on the
- 17 premises BETWEEN THE HOURS OF 7 A.M. AND 12 NOON on Sunday OR
- 18 BETWEEN THE HOURS OF 7 A.M. ON SUNDAY AND 2 A.M. ON MONDAY, by
- 19 resolution approved by a majority of the legislative body voting on
- 20 that resolution, the spirits and mixed spirit drink may be sold
- 21 after 7 a.m. on Sunday, in an establishment licensed under this act
- 22 in which the gross receipts derived from the sale of food and other
- 23 goods and services exceed 50% of the total gross receipts. With
- 24 respect to an action taken by the legislative body or if the
- 25 legislative body fails to act, a petition may be filed with the
- 26 county clerk requesting the submission of the question regarding
- 27 the prohibition of the sale of spirits and mixed spirit drink for

- 1 consumption on the premises in addition to beer and wine **BETWEEN**
- 2 THE HOURS OF 7 A.M. AND 12 NOON on Sunday OR BETWEEN THE HOURS OF 7
- 3 A.M. ON SUNDAY AND 2 A.M. ON MONDAY. The petition shall be signed
- 4 by a number of the registered and qualified electors of the county
- 5 that is not less than 8% of the total number of votes cast for all
- 6 candidates for the office of secretary of state in the county at
- 7 the last general election held for that purpose. The question shall
- 8 not be submitted to the electors of a county more than once every 4
- 9 years. The county clerk shall submit the question at the next
- 10 regular state election held in the county if the petitions are

- 14 wine, on Sunday shall be submitted by ballot in substantially the

- 25 mixed spirit drink for consumption?

- 14 sale of spirits and mixed spirit drink for consumption off the

- 16 BETWEEN THE HOURS OF 7 A.M. ON SUNDAY AND 2 A.M. ON MONDAY by
- 17 resolution approved by a majority of the legislative body voting on
- 18 the resolution, spirits and mixed spirit drink may be sold after 7
- 19 a.m., in a retail establishment licensed under this act. With
- 20 respect to an action taken by the legislative body or if the
- 21 legislative body fails to act, a petition may be filed with the
- 22 county clerk requesting the submission of the question regarding
- 23 the prohibition of the sale of spirits and mixed spirit drink for
- 24 consumption off the premises, in addition to beer and wine, in a
- 25 retail establishment licensed under this act BETWEEN THE HOURS OF 7

- 12 at an election vote in favor of the proposal, the sale of spirits
- 13 and mixed spirit drink may be prohibited in the county under this
- 14 act for consumption on the premises or by a retail establishment
- 15 for consumption off the premises, in addition to beer and wine,
- 16 BETWEEN THE HOURS OF 7 A.M. AND 12 NOON on Sunday OR BETWEEN THE
