9	Sec. 301. The department of natural resources shall enter into
10	agreements with local units of government for the purpose of
11	administering the grants identified in part 1. Among other
12	provisions, the agreements shall require that grant recipients
13	agree to dedicate to public outdoor recreation uses in perpetuity
14	the land acquired or developed; to replace lands converted or lost
15	to other than public outdoor recreation use; and, for parcels
16	acquired that are over 5 acres in size, to provide the state with a
17	nonparticipating 1/6 minimum royalty interest in any acquired
18	minerals that are retained by the grant recipient. The agreements
19	shall also provide that the full payments of grants can be made
20	only after proof of acquisition, or proof of completion of the
21	development project, is submitted by the grant recipient and all
22	costs are verified by the department of natural resources. This
23	requirement may be waived by the department of natural resources.
24	Sec. 302. Any unobligated balance in a Michigan natural
25	resources trust fund appropriation made under part 1 shall not
26	revert to the Michigan natural resources trust fund at the close of

- 1 the fiscal year, but shall continue until the purpose for which it
- 2 was appropriated is completed for a period not to exceed 3 fiscal
- 3 years. The unexpended balance of any Michigan natural resources
- 4 trust fund appropriation made in part 1 remaining after the purpose
- 5 for which it was appropriated is completed shall revert to the
- 6 Michigan natural resources trust fund and be made available for
- 7 appropriation.
