THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 811e. (1) Beginning January 1, 2007, the **THE** secretary of state may develop a fund-raising plate as provided in this section.

(2) A start-up fee of \$15,000.00 shall be paid for any new fund-raising plate authorized under this section. The fee shall be deposited in the transportation administration collection fund through October 1, 2011 to be used for the cost of creating, producing, and issuing fund-raising plates. If the fee described in this subsection is not paid within 18 months of—AFTER the effective date of the public act that authorizes the development and issuance

- 2 not be created, produced, or issued. A start-up fee paid under this

- 4 (3) Not less than 3 years after the secretary of state first

- 2 SEC. 811R. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 3 SECTION 811E AND ISSUE UNDER SECTION 811F A FUND-RAISING PLATE
- 4 RECOGNIZING THE MICHIGAN BREAST AND CERVICAL CANCER CONTROL
- 5 PROGRAM. THE SECRETARY OF STATE IN CONJUNCTION WITH THE MICHIGAN
