## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 513A. (1) BEGINNING OCTOBER 1, 2012, THE COMMISSION MAY
- 2 ISSUE TO THE GOVERNING BOARD OF A COMMUNITY COLLEGE OR UNIVERSITY
- 3 THAT OPERATES AN ACCREDITED CULINARY OR HOSPITALITY PROGRAM,
- 4 WITHOUT REGARD TO THE QUOTA PROVISIONS OF SECTION 531, A LICENSE TO
- 5 SELL ALCOHOLIC LIQUOR FOR CONSUMPTION AT THE COMMUNITY COLLEGE'S OR
- 6 UNIVERSITY'S CULINARY OR HOSPITALITY PROGRAM'S LOCATION FOR
- 7 ACTIVITIES THAT FURTHER THE COMMUNITY COLLEGE'S OR UNIVERSITY'S
- 8 COMMUNITY OR ACADEMIC MISSION.
  - (2) THE SALE OF ALCOHOLIC LIQUOR TO PATRONS AT A LOCATION

- 24 (B) "UNIVERSITY" MEANS A PUBLIC UNIVERSITY DESCRIBED IN
- 25 SECTION 4, 5, OR 6 OF ARTICLE VIII OF THE STATE CONSTITUTION OF
