A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.532) by adding section 279.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 279. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2010, A TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY THIS
- 3 ACT EQUAL TO 50% OF THE COST PAID BY THE TAXPAYER, NOT TO EXCEED
- 4 \$5,000.00, FOR QUALIFIED RENOVATIONS MADE TO THE HOME OF THE
- 5 TAXPAYER IF THE TAXPAYER IS EITHER OF THE FOLLOWING:
- 6 (A) A PERSON WITH A DISABILITY WHO MAKES RENOVATIONS TO HIS OR
- 7 HER OWN HOME.
- 8 (B) A TAXPAYER, OTHER THAN A TAXPAYER DESCRIBED IN SUBDIVISION
- 9 (A), IF A PERSON WITH A DISABILITY LIVES IN THE HOME OF THE
- TAXPAYER WHO MAKES THE QUALIFIED RENOVATIONS.

- 14 (i) CHANGES TO ACCOMMODATE THE PHYSICAL NEEDS OF A PERSON WITH
- 15 A DISABILITY, INCLUDING, BUT NOT LIMITED TO, BATH BARS, RAMPS, DOOR
- 16 WIDENING, ACCESS CHANGES, AND REFITTING OF FIXTURES.
- 17 (ii) ADDITION OF A ROOM.
- 18 (iii) ANY CHANGE TO THE HOME THAT IS MADE TO MEET LOCAL OR STATE
- 19 BUILDING CODES, ORDINANCES, STATUTES, OR RULES THAT REGULATE
- 20 HOUSING FOR PERSONS WITH DISABILITIES.
- 21 (iv) SAFETY FEATURES.
- 22 (C) "PERSON WITH A DISABILITY" MEANS THAT TERM AS DEFINED IN
- 23 SECTION 103 OF THE PERSONS WITH DISABILITIES CIVIL RIGHTS ACT, 1976
