- 5 SUPERVISION OF A PERSON LICENSED UNDER ARTICLE 20 OF THE
- 6 OCCUPATIONAL CODE, 1980 PA 299, MCL 339.2001 TO 339.2014. THE
- 7 CONSTRUCTION DOCUMENTS SHALL INCLUDE THE NAME AND ADDRESS OF THE
- 8 ARCHITECT OR PROFESSIONAL ENGINEER AND SHALL BEAR THAT INDIVIDUAL'S
- 9 ORIGINAL SIGNATURE, SEAL, OR STAMP AND THE DATE.
