

SUBSTITUTE FOR
HOUSE BILL NO. 4916

A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 682d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 **SEC. 682D. (1) A VILLAGE, CITY, OR TOWNSHIP MAY, BY WRITTEN**
2 **AUTHORIZATION, ALLOW EMPLOYEES AND VOLUNTEERS OF ENTITIES DESCRIBED**
3 **IN SUBSECTION (2), WHO ARE 18 YEARS OF AGE OR OLDER, TO CONDUCT**
4 **FUND-RAISING ACTIVITIES WITHIN THE IMPROVED PORTION OF A STREET OR**
5 **HIGHWAY THAT IS WITHIN THE GEOGRAPHICAL JURISDICTION OF THAT**
6 **VILLAGE, CITY, OR TOWNSHIP.**

7 **(2) SUBSECTION (1) APPLIES TO AN ENTITY THAT IS SUBJECT TO THE**
8 **REQUIREMENTS OF SECTION 501(C) (3), (4), (8), OR (19) OF THE**
9 **INTERNAL REVENUE CODE, 26 USC 501.**

1 (3) A WRITTEN AUTHORIZATION ISSUED UNDER SUBSECTION (1) SHALL
2 SPECIFY THE NAME OF THE ENTITY, THE DATES AND TIMES DURING WHICH
3 FUNDRAISING MAY TAKE PLACE, AND THE LOCATIONS FOR THOSE FUND-
4 RAISING ACTIVITIES. THE AUTHORIZATION MAY SPECIFY REQUIREMENTS FOR,
5 AND LIMITATIONS ON, THE USE OF THE STREET OR HIGHWAY.

6 (4) AN AUTHORIZATION ISSUED UNDER SUBSECTION (1) SHALL BE
7 CONTINGENT UPON THE ENTITY'S INDEMNIFYING THE LOCAL UNIT OF
8 GOVERNMENT AND THIS STATE OR THE LOCAL AUTHORITY THAT REGULATES THE
9 USE OF THAT STREET OR HIGHWAY FOR ALL CLAIMS FOR DAMAGES ARISING
10 OUT OF THE ENTITY'S USE OF THAT STREET OR HIGHWAY. THE
11 AUTHORIZATION SHALL ALSO BE CONTINGENT UPON THE ENTITY'S ENSURING
12 THAT ALL INDIVIDUALS WORKING ON BEHALF OF THAT ENTITY WHO ARE
13 EXPOSED TO MOVING VEHICLE TRAFFIC WEAR HIGH-VISIBILITY SAFETY
14 APPAREL MEETING CURRENT AMERICAN NATIONAL STANDARDS PROMULGATED BY
15 THE INTERNATIONAL SAFETY EQUIPMENT ASSOCIATION.

16 (5) THE PROHIBITIONS UNDER THIS ACT AGAINST AN INDIVIDUAL'S
17 STANDING, WALKING, OR OTHERWISE REMAINING WITHIN THE IMPROVED
18 PORTION OF A STREET OR HIGHWAY DO NOT APPLY TO AN INDIVIDUAL WHO IS
19 CONDUCTING FUND-RAISING ACTIVITIES IN COMPLIANCE WITH THE WRITTEN
20 AUTHORIZATION GRANTED BY A VILLAGE, CITY, OR TOWNSHIP UNDER THIS
21 SECTION.
