

**HOUSE SUBSTITUTE FOR
SENATE BILL NO. 199**

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 201 and 206 (MCL 388.1801 and 388.1806),
section 201 as amended by 2012 PA 465 and section 206 as amended by
2012 PA 201.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 201. (1) Subject to the conditions set forth in this
2 article, the amounts ~~listed~~ in subsections (2) and (4) are
3 appropriated for community colleges for the fiscal year ending
4 September 30, ~~2013,~~ **2014**, from the funds indicated in this section.
5 The following is a summary of the appropriations in subsections (2)
6 and (4):
7 (a) The gross appropriation is ~~\$294,130,500.00.~~ **\$100.00**. After

1 deducting total interdepartmental grants and intradepartmental
 2 transfers in the amount of \$0.00, the adjusted gross appropriation

 24 is appropriated for fiscal year ~~2012-2013~~ **2013-2014** an amount not
 25 to exceed ~~\$1,733,600.00.~~ **\$0.00** for payments to community colleges
 26 from the state school aid fund. A community college that receives
 27 money under this subsection shall use that money solely for the

1 purpose of offsetting a portion of the retirement contributions
2 owed by the college for the fiscal year ending September 30, 2013.

 7 in effect for the fiscal year ending September 30, ~~2012, 2013~~, the
 8 amounts appropriated for community colleges under subsection (2) of
 9 this section for the fiscal year ending September 30, ~~2012-2013~~ are
 10 appropriated from the following funds:

14 Sec. 206. The funds appropriated in section 201 are
 15 appropriated for community colleges with fiscal years ending June
 16 30, ~~2013-2014~~ and shall be paid out of the state treasury and
 17 distributed by the state treasurer to the respective community
 18 colleges in 11 monthly installments on the sixteenth of each month,
 19 or the next succeeding business day, beginning with October 16,
 20 ~~2012-2013~~. Each community college shall accrue its July and August
 21 ~~2013-2014~~ payments to its institutional fiscal year ending June 30,
 22 ~~2013-2014~~. However, if the state budget director determines that a
 23 community college failed to submit all verified Michigan community
 24 colleges activities classification structure data for school year
 25 ~~2011-2012-2012-2013~~ to the workforce development agency by November
 26 1, ~~2012, 2013~~, or failed to submit its longitudinal data system
 27 data set for school year ~~2011-2012-2012-2013~~ to the center for

1 educational performance and information under section 219, the
2 state treasurer shall withhold the monthly installments from that
3 community college until those data are submitted. The state budget
4 director shall notify the chairs of the house and senate
5 appropriations subcommittees on community colleges at least 10 days
6 before withholding funds from any community college.
