A bill to amend 1976 PA 451, entitled

"The revised school code,"

(MCL 380.1 to 380.1852) by adding sections 502b, 522b, and 552b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 502B. IF THE BOUNDARIES OF A SCHOOL DISTRICT HAVE CHANGED 2 WITHIN THE 3 IMMEDIATELY PRECEDING CALENDAR YEARS BY A 3 CONSOLIDATION UNDER PART 9, AN ANNEXATION UNDER PART 10, OR AN ANNEXATION AND TRANSFER UNDER PART 10A, AN AUTHORIZING BODY SHALL 4 5 NOT ISSUE AN INITIAL CONTRACT FOR A PUBLIC SCHOOL ACADEMY TO BE 6 LOCATED WITHIN THE BOUNDARIES OF THE SCHOOL DISTRICT WITHOUT 7 APPROVAL OF THE CONTRACT BY A MAJORITY OF THE INTERMEDIATE SCHOOL 8 BOARD OF THE INTERMEDIATE SCHOOL DISTRICT IN WHICH THE SCHOOL 9 DISTRICT IS LOCATED.

SEC. 522B. IF THE BOUNDARIES OF A SCHOOL DISTRICT HAVE CHANGED WITHIN THE 3 IMMEDIATELY PRECEDING CALENDAR YEARS BY A

IF THE BOUNDARIES OF A SCHOOL DISTRICT HAVE CHANGED 8 9 WITHIN THE 3 IMMEDIATELY PRECEDING CALENDAR YEARS BY A 10 CONSOLIDATION UNDER PART 9, AN ANNEXATION UNDER PART 10, OR AN 11 ANNEXATION AND TRANSFER UNDER PART 10A, AN AUTHORIZING BODY SHALL 12 NOT ISSUE AN INITIAL CONTRACT FOR A SCHOOL OF EXCELLENCE TO BE LOCATED WITHIN THE BOUNDARIES OF THE SCHOOL DISTRICT WITHOUT 13 14 APPROVAL OF THE CONTRACT BY A MAJORITY OF THE INTERMEDIATE SCHOOL 15 BOARD OF THE INTERMEDIATE SCHOOL BOARD OF THE INTERMEDIATE SCHOOL 16 DISTRICT IN WHICH THE SCHOOL DISTRICT IS LOCATED.
