A bill to amend 1976 PA 451, entitled

"The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1232.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1232. NOT LATER THAN OCTOBER 1 EACH YEAR, THE BOARD OF A 2 SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY 3 SHALL POST ON THE SCHOOL DISTRICT'S OR PUBLIC SCHOOL ACADEMY'S WEBSITE, WITH A LINK ON THE HOMEPAGE, AND SUBMIT TO THE CENTER FOR 4 EDUCATIONAL PERFORMANCE AND INFORMATION A TEACHER RETENTION AND 5 6 TURNOVER REPORT FOR EACH SCHOOL OPERATED BY THE SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY. THE REPORT SHALL BE SUBMITTED IN THE FORM 7 8 AND MANNER PRESCRIBED BY THE CENTER FOR EDUCATIONAL PERFORMANCE AND 9 INFORMATION AND SHALL CONTAIN AT LEAST ALL OF THE FOLLOWING:
