HOUSE BILL No. 5331

February 18, 2014, Introduced by Rep. Leonard and referred to the Committee on Elections and Ethics.

A bill to amend 1976 PA 388, entitled "Michigan campaign finance act,"

by amending section 64 (MCL 169.264), as amended by 1993 PA 262.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 64. (1) A candidate in a primary election may obtain
- 2 funds from the state campaign fund in an amount equal to \$2.00 for
- 3 each \$1.00 of qualifying contribution if the candidate certifies to
 - the secretary of state both of the following:
 - (a) That the candidate committee of the candidate received \$75,000.00 or more of qualifying contributions.
 - (b) That the full name and address of each person making a qualifying contribution is recorded by the candidate committee of the candidate certifying. This requirement is in addition to and

- 3 (2) A candidate is not entitled to funds from the state
- 4 campaign fund for a primary election if it is determined the name
