September 30, 2014, Introduced by Reps. Schor, Zemke, Knezek, Kivela and Cavanagh and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for various state departments and agencies for the fiscal year ending September 30, 2015; and to provide for the expenditure of the appropriations.

3 PROVISIONS CONCERNING APPROPRIATIONS

4 GENERAL SECTIONS

5 Sec. 201. In accordance with the provisions of section 30 of
6 article IX of the state constitution of 1963, total state spending
7 from state resources in this appropriation act for the fiscal year
8 ending September 30, 2015 is \$2,000,000.00 and state appropriations
9 paid to local units of government are \$2,000,000.00.

10 Sec. 202. The appropriations made and expenditures authorized
11 under this act and the departments, commissions, boards, offices,
12 and programs for which appropriations are made under this act are
13 subject to the management and budget act, 1984 PA 431, MCL 18.1101
14 to 18.1594.

15 DEPARTMENT OF TREASURY

16 Sec. 301. The funds appropriated in part 1 for MSF, special
17 grants shall be expended for grants to at-risk school districts
18 under the same provisions provided for grants made under section
19 31b of the state school aid act of 1979, 1979 PA 94, MCL 388.1631b.
