

# SENATE BILL No. 842

March 4, 2014, Introduced by Senators JONES, BOOHER, ROBERTSON, PROOS and SCHUITMAKER and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16o of chapter XVII (MCL 777.16o), as amended  
by 2012 PA 169.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

### 1 CHAPTER XVII

2 Sec. 16o. This chapter applies to the following felonies  
3 enumerated in chapter 750 of the Michigan Compiled Laws:
